Regular Meeting
January 11, 2010

Call to Order / Pledge of Allegiance

Mayor Kendall called the January 11, 2010 meeting of the Marysville City Council to order at 7:00 p.m. at Marysville City Hall. The invocation was given by Pastor Kurt Onken from Messiah Lutheran Church. Mayor Kendall led those present in the Pledge of Allegiance.

Roll Call

Chief Administrator Mary Swenson gave the roll call. The following staff and councilmembers were in attendance.

Mary Swenson informed council that it was her understanding that Councilmember Phillips called Councilmember Soriano. Councilmember Soriano informed council he did receive a call stating that Councilmember Phillips was ill.

Motion made by Councilmember Soriano to excuse the absence of Councilmember Phillips. The motion died for lack of a second.

Committee Reports

Councilmember Seibert reported on the January 8 Public Works meeting where the main topic of discussion was the utility rate study which should be coming to Council in the next cycle.

Councilmember Vaughan reported that the Graffiti Task Force met last Thursday and discussed various things that are being done with graffiti eradication in our community. It was noted that there has been an increase in instances of graffiti in the community. Some of this is coming from the newly annexed areas. Commander Lamoureux also remarked that the police have stepped up their efforts again to try to get the individuals who are doing the graffiti. The importance of getting together with the Tribes soon regarding the 116th Street railroad bridge was also mentioned. A representative from the school district was in attendance and discussed some of the things the school district is going. The next meeting Graffiti Task Force meeting will be in February.

Presentations

A. Dr. Nyland – Marysville School District Superintendent.

Dr. Nyland gave a PowerPoint presentation regarding the upcoming levy and bond issue in the school election on February 9 and plans for replacing their three most obsolete schools.

Councilmember Nehring congratulated Dr. Nyland and noted that the new high school is looking sharp. Councilmember Nehring asked if they will be ready to take advantage of the low construction costs. Dr. Nyland stated that they were shovel-ready earlier when they were hoping to get the stimulus package. Councilmember Nehring asked about Totem. Dr. Nyland explained that parts of it are old, but some of it was modernized at some point in the past so it has a better score than some of the other schools.

Councilmember Rasmussen commended Dr. Nyland and his staff for the outstanding work that they are doing with the improvements in the district.

Councilmember Vaughan also thanked Dr. Nyland for all the good work the district has done especially at Totem. Dr Nyland thanked him and gave credit to the staff at that school.

Councilmember Wright thanked him for the presentation and the good work that he has done. She asked what else the Council could do to support the district. Grant Weed noted that the Council could take a position on the ballot measure but it would need to appear on the Council's agenda in exactly the same format as it is going to the voters and they need to provide equal time for differing views.

Councilmember Seibert stated he would like to encourage people to vote.

7. Proposed Utility Rate Cost of Service Adjustment (*will be held on 1/25/10*).

This is notification that a public hearing will be held next Monday. Public Works Director Kevin Nielsen noted that there is an ordinance that goes along with this. The new restructuring will be distributed to Council prior to the meeting. CAO Mary Swenson added that they are in the process of setting up a meeting with Cauldie Rogers from the Chamber so that she has a preview of this.

New Business

8. Agreement for Services with Allied Employers commencing January 1, 2010 and ending on December 31, 2010.

Mary Swenson explained that this is an update of the current contract.

9. Retainage Escrow Agreement with SRV Construction, Inc. for the Ingraham Boulevard Extension Project #R0502.

Public Works Director Nielsen stated that this is the standard escrow agreement that is in the contract that they are allowed to use for retainage.

10. An **Ordinance** of the City of Marysville, Washington, Adopting and Revising Stormwater Management Regulations Pursuant to the Western Washington Phase II Municipal Stormwater Permit Issued to the City by the Washington State Department of Ecology and Amending Chapters 4.02, 14.03, 14.05, 14.09, 14.15, 14.16, 14.17, 14.18, and 19.22, of the Marysville Municipal Code.

Director Nielsen explained that this is in order to fulfill the requirements of the NPDES Stormwater Permit Phase II. Mary commended Kari Chenault and their crew for the excellent work that they do.

Councilmember Seibert referred to item 10-12, (14.03.200) asked about taking the easement to the main as had been discussed previously and not just the boundary of the public right-of-way. He recalled that there had been an issue with maintenance with utilities underneath the road service. Kevin Nielsen stated that they actually own to the main; he indicated that he would look into this.

Councilmember Seibert then referred to item 10-16. He noted that *Discharge restrictions into sanitary sewers* was deleted. He wondered if this covered in a different area. Director Nielsen indicated that it is included in Pretreatment.

Councilmember Seibert then referred to item 10-42 and other areas in this document which show large chunks of information that has been deleted. He asked for more information about why this was deleted or if it was just moved. Director Nielsen stated that a lot of it is covered by the Stormwater Manual which is referenced here. The manual is adopted in here so many things were removed to avoid conflicts. Councilmember Seibert requested some clarifications regarding the deletions for the meeting next week.

Councilmember Seibert asked about the fact that one of the *Whereas* statements references that we adopted the 2001 manual. He asked why it doesn't reference the 2005 manual. Director Nielsen replied that staff will be bringing the 2005 manual forward, but they are working on some amendments and exemptions to it. The latest adopted manual is the 2001 manual.

Councilmember Soriano referred to page 10-15. He noted that the liability coverage is significantly higher. City Attorney Beyer stated that these are standard insurance requirements on all the contracts now. Director Nielsen pointed out that it did go up a year and a half ago, but it was cleaned up here.

Councilmember Soriano referred to page 10-35 about not allowing washing of sidewalks, pathways and non-commercial washing of cars. He asked if this has always been in there.

Director Nielsen indicated that this has not changed. He explained that by the NPDES Permit Phase II these are not allowed. There was discussion about these restrictions.

- 11. An **Ordinance** of the City of Marysville, Washington Restructuring Water, Sewer, and Surface Water Utility Rates, Amending Sections 14.07.010, 14.07.060, 14.07.070, and 14.19.050 of the Marysville Municipal Code as Allowed Under Section 14.07.075.

The ordinance will be coming to Council prior to the meeting. CAO Mary Swenson briefly discussed the rate structure. She stated that she is more comfortable with this structure than she has been with any other. She believes it is very fair and justifiable. The consultant from Gray and Osborne did a very good job on this study. She discussed communication with the annexation area residents regarding rate changes.

- 12. A **Resolution** supporting the Marysville Kids Matter Initiative.

Councilmember Rasmussen brought this up to council. Mayor Kendall noted that there will be two versions – one could be signed by the Mayor and the other could be signed by all the councilmembers.

- 13. A **Resolution** of the City of Marysville Regarding Marysville School District Propositions No. 1 & 2 on the Election Ballot on February 9, 2010.

The Ballot Title Reads Substantially as Follows:

**MARYSVILLE SCHOOL DISTRICT No. 25
PROPOSITION NO. 1**

GENERAL OBLIGATION BONDS - \$78,000,000

The Board of Directors of Marysville School District No. 25 adopted Resolution No. 2010-3 concerning this proposition for bonds. The proposition would authorize the District to replace and equip two elementary schools and a middle school; acquire new and renovate existing technology facilities; and other capital improvements; to issue \$78,000,000 of general obligation bonds maturing within a maximum of 20 years; and collect excess property taxes annually to repay the bonds, as provided in this Resolution.

- Friday the 22nd is the school district groundbreaking at 10:00 for Ingraham Blvd.
- Thursday at 7:30 is the Governmental Affairs meeting with the tribes.

Staff Business

Chief Smith:

- Jim Ballew has done a great job working with Lisa Brenton regarding the naming of the park after her husband. She is very happy with the recognition of her husband.
- The police department has made a conditional offer with an individual from WWU.
- Several other individuals from police organizations within Snohomish County are also applying.
- Formal promotions happen next Monday and everyone is very excited. Jobie Johnson and Brian Lutschg will be promoted to sergeant and Wendy Wade is getting promoted to lieutenant.

Kevin Nielsen:

- He discussed the windstorm over the weekend.
- Crews are working on potholes, sweeping, maintenance, and valve exercises. Vactors are doing sewer and storm cleaning.
- Construction is still occurring on 47th Street.
- They are considering improvements to the 88th Street Corridor with some money from Snohomish County. They are looking at making the connection on 51st from 88th to 84th.

Councilmember Seibert pointed out that there are areas on 51st between Grove Street and 80th Street that are narrow and have gaps with no sidewalks. He expressed concerns about walkability if this is opened up for more traffic. Director Nielsen commented that there are plans for 51st to be a major corridor for biking and pedestrian transportation from 172nd to 528. They are also looking at roundabouts for certain spots, but this will require more study especially considering its proximity to schools.

Gloria Hirashima noted that the Healthy Communities ACES committee is looking at marking out another trail similar to Jennings loop for the Pinewood and the Kellogg Marsh neighborhoods. They have identified a couple loops which are possibilities.

Sandy Langdon remarked that notices were sent out to businesses that were potentially affected by the admissions tax and the 1%. They have had minimal response.

Cheryl Beyer had no comments.

Mary Swenson stated that it was a pleasure to do the interviews and promotions for the police department. She is extremely pleased with the promotions. This has created a lot of positive energy in the department

Call on Councilmembers

Jeff Vaughan asked Kevin Nielsen if 88th Street might be used as part of the truck route. Director Nielsen said they would revisit this. He recommended leaving as much traffic on 528 as possible. He briefly revisited construction routes. Council's consensus was to not have trucks on Ingraham Blvd. Vaughan stated that Pinewood Elementary has been concerned for years about truck traffic. There was discussion about future truck routes as growth happens.

Carmen Rasmussen said she received her first complaint about census takers which she forwarded it to staff.

Jon Nehring commented that Doug Carlton in the annexation area contacted him regarding a truck problem in his neighborhood. Chief Smith indicated they would look into it and contact him.

Lee Phillips apologized for not making it last week due to illness.

- The Snohomish County Cities and Towns dinner is in Mukilteo tomorrow. They will be doing their annual elections for the PSRC boards and committees. He discussed his and Councilmember Donna Wright's possible involvement in this.
- Congratulations to all the folks in the police department who are being promoted. Congratulations to Wendy Wade who is the first female lieutenant.







PUBLIC HEARING

After reviewing the official file, which included the Community Development Department Staff Recommendation; and after visiting the site, the Hearing Examiner conducted a public hearing on the application for a Conditional Shoreline Substantial Development Permit. The hearing on the application was opened at 7:00 p.m., January 14, 2010, in the City Council Chambers, Marysville, Washington, and closed at 7:20 p.m. Participants at the public hearing are listed in the minutes of the hearing. A verbatim recording of the hearing and complete minutes are available upon request in the Community Development Department. A list of exhibits offered and entered at the hearing and a list of parties of record are attached to this report.

HEARING COMMENTS

No members of the public attended the hearing. Those in attendance included only the representative of the applicant – the Washington State Department of Transportation (Sharif Shaklawun, P.E.) and the representative of the city of Marysville (Cheryl Dungan).

Discussion included the following related to revised plans for the bridge structure:

- Length of bridge span has been reduced from 720 feet to 680 feet;
- Concerns about pier placement within the waterway led to a modest redesign of the bridge and revised pier placement on the banks of Ebey Slough;
- Pier placement on the north bank of the slough will not allow for the planned pedestrian and bicycle path to be constructed on the north bank;
- The pedestrian and bicycle path will instead be constructed on a different route and will consist of six-foot wide concrete sidewalks that will run parallel to the newly constructed roadway segment from the north bank of the slough to 1st Street in Marysville;
- As a condition of the project approval, WSDOT will construct an enhanced crosswalk on the south leg of the intersection of 1st Street and SR 529 (State Street);
- Pedestrian and bicycle facilities on the new SR 529 bridge will consist of five-foot wide bicycle lanes and six-foot wide sidewalks on both sides of the bridge;
- Pedestrian and bicycle facilities on the bridge are consistent with the policy of building “complete streets” but these facilities do not connect to designated continuous non-motorized facilities south of the project area, although SR 529 is a well used bicycle corridor between Everett and Marysville;
- Pedestrian and bicycle facilities on the north side of the bridge project connect to the sidewalk system in Marysville and to bicycle facilities on routes parallel to SR 529 (State Street) through Marysville;
- Despite changes to the bridge design and pier placement, wetland impacts and mitigation remain as described in Attachment A of the Master Permit Application, and in various exhibits on record, including Exhibit 13, Draft Wetland and Stream Mitigation Report, June 11, 2009. A final mitigation plan will be submitted to the City of approval prior to commencement of construction activities;
- The most recent roadway design plans – dated December 16, 2009 – were introduced into the record as Exhibit 53.

WRITTEN COMMENTS

Written comments were introduced to the record at the public hearing.

- Exhibit 51 – State of Washington Department of Natural Resources Harbor Line Commission, Resolution No. 1326, establishing a Public Place in the existing harbor area in front of the City of Marysville.
- Exhibit 52 – Letter to the Hearing Examiner from Katherine Johnson, DVM, dated January 13, 2010, expressing several concerns regarding the Ebey Slough Bridge Replacement Project.

FINDINGS, CONCLUSIONS AND RECOMMENDATION

Having considered the entire record in this matter, the Hearing Examiner now makes and enters the following:

FINDINGS AND CONCLUSIONS

1. The information contained in Section I (Findings) and Section II (Findings and Conclusions) of the Community Development Department Staff Recommendation (Hearing Examiner Exhibit 50) is found to be supported by the evidence presented during the hearing and by this reference is adopted as portion of the Hearing Examiner's findings and conclusions. A copy of the Staff Recommendation is available in the Marysville Community Development Department.
2. The minutes of the meeting accurately summarize the testimony offered at the hearing and by this reference are entered into the official record.
3. The applicant has provided evidence and has demonstrated that the request meets the criteria for a Conditional Shoreline Substantial Development Permit as set forth in the Marysville 2006 Shoreline Master Plan, and listed here as follows:
 - (1) That the proposed use will be consistent with the policies of the SMA and the policies of the master program.*
 - (2) That the proposed use will not interfere with the normal public use of public shorelines.*
 - (3) That the proposed use of this site and design of the project will be compatible with other permitted uses within the area.*
 - (4) That the proposed use will cause no unreasonably adverse effects to the shoreline environment designation in which it is to be located.*
 - (5) That the public interest suffers no substantial detrimental effect.*
4. The applicant concurs with each of the Conditions for Approval recommended by City of Marysville Community Development Department staff.
5. With regard to the concern expressed in Exhibit 52 regarding the historic status of the existing Ebey Slough bridge, WSDOT has determined that the SR 529 Ebey Slough Bridge Replacement Project is consistent with the Marysville Shoreline Master Program, Chapter 4, General Provisions, Archeological and Historic Resources.
6. The installation of bicycle and pedestrian facilities on the new SR 529 bridge is consistent with the concept of developing "complete streets" to accommodate the full range of potential users of the roadway and will support the non-motorized use

of the bridge. The provisions for pedestrians and bicyclists on the segment of SR 529 between the south project limits and Everett could be enhanced to create an outstanding non-motorized connection between Everett and Marysville.

RECOMMENDATION

Based on the foregoing findings and conclusions, the Hearing Examiner recommends that the request for a Conditional Shoreline Substantial Development Permit be **Approved With Conditions**.

Recommended Conditions:

1. WSDOT shall construct an enhanced crosswalk of tinted and stamped asphalt or concrete at the SR 529 crossing of the south leg of the intersection at 1st Street. Additionally, the pathway which extends southeasterly from the public sidewalk shall be demarcated with a 4' high standard galvanized railing to the trail terminus. A 12' x 12' concrete pad with picnic table shall be installed at the terminus of the pathway and shall include a 4' high standard galvanized railing around the perimeter of the pad.
2. If during construction activities, buried prehistoric to historic material, cultural, and/or human remains are found, the project shall be temporarily halted consistent with the inadvertent discovery plan and until representatives of the US Army Corp of Engineers, the Tulalip Tribes, DAHP, and the City are consulted to assess and protect the resource.
3. WSDOT shall be required to enter into a *Memorandum of Understanding* with the City to purchase advance mitigation credits designated for the Qwuloot Estuary Restoration Project – City-owned properties, provided the use of the credits is consistent with the terms and conditions of the advance mitigation approval. Alternative mitigation may be approved by the City provided it is consistent with the City's mitigation requirements as set forth in the City's Critical Areas Ordinance (CAO).
4. WSDOT shall be required to remove the existing bridge superstructure, bridge rest and fender timber and piles, concrete piers and abutments, in accordance with the Marysville Shoreline Master Program.
5. Prior to commencement of construction activities, the applicant shall submit a *Spill Prevention Control and Countermeasures (SPCC) Plan* to the City for review and approval.
6. Prior to commencement of construction activities, the applicant will be required to submit a final, detailed mitigation plan to the City for review and approval that is consistent with MMC 19.24.130 through 19.24.150.
7. The issuance of this Conditional Shoreline Substantial Development permit approval shall not be considered a waiver of or statement of compliance with permit requirements from other agencies with potential jurisdiction over the described work. If changes to the

proposed impacts or mitigation boundary occur as a result of agency review, the construction and mitigation plans shall be revised accordingly.

8. Prior to issuance of a grading permit, the applicant shall obtain all applicable county, state and federal permits.

RECONSIDERATION:

A party to a public hearing may seek reconsideration only of a final decision by filing a written request for reconsideration with the director within fourteen (14) days of the final written decision. The request shall comply with MMC 15.11.020(3). The examiner shall consider the request within seven (7) days of filing the same. The request may be decided without public comment or argument by the party filing the request. If the request is denied, the previous action shall become final. If the request is granted, the hearing examiner may immediately revise and reissue its decision. Reconsideration should be granted only when a legal error has occurred or a material factual issue has been overlooked that would change the previous decision.

JUDICIAL APPEAL:

- (1) Appeals from the final decision of the hearing examiner, or other city board or body involving MMC Titles 15 to 20 and for which all other appeals specifically authorized have been timely exhausted, shall be made to Snohomish County superior court pursuant to the Land Use Petition Act, RCW 36.70C within 21 days of the date the decision or action became final, unless another applicable appeal process or time period is established by state law or local ordinance.
- (2) Notice of the appeal and any other pleadings required to be filed with the court shall be served as required by law within the applicable time period. This requirement is jurisdictional.
- (3) The cost of transcribing and preparing all records ordered certified by the court or desired by the appellant for such appeal shall be borne by the appellant. The record of the proceedings shall be prepared by the City or such qualified person as it selects. The appellant shall post with the city clerk prior to the preparation of any records an advance fee deposit in the amount specified by the city clerk. Any overage will be promptly returned to the appellant.

1. PA 09038 –Ebey Slough Bridge Replacement–request approval of a Conditional Shoreline Substantial Development permit to allow the replacement of the existing 2-lane, swing span SR 529 bridge with a new 4-lane fixed span bridge together with the associated improvements.

Staff Comment:

Ms. Dungan added an email received on January 14, 2010 regarding the construction of the sidewalks to the record. She added that she would like to revise Staff Recommendation to include the sidewalks be constructed of stamped asphalt rather than stamped concrete. Ms. Dungan also added that the size of the bridge had been reduced. Mr. McDonald questioned if the change was because of the change in bike facility. WSDOT representative Sharif Shaklawun, responded that it was because of the placement of the piers due to restrictions imposed by NOA and US Fish and Wildlife regulations and requirements. Mr. McDonald questioned access from the intersections to the bridge. Ms. Dungan responded that it would be primarily through the sidewalk. Mr. McDonald questioned connectivity of bike lanes and sidewalks on the south side of the bridge; he felt that the environment on the South side was somewhat unfriendly to bike and pedestrians. Mr. Shaklawun responded that currently many bikes use SR529 and there are shoulders to accommodate bikes.

Mr. McDonald questioned the conditions regarding removal of the old bridge and how the state would comply with City's Shoreline Master Plan requirements. Ms. Dungan responded that

DNR had just conditioned the removal with a Resolution. She added that the City felt confident that the removal would comply with city requirements. Mr. McDonald questioned if the plans reflected the relocation of the piers. He stated that he thought the most recent plan set should be added to the record; adding it to the record as Exhibit 53.

I. EVALUATION

A. Request

The applicant is requesting approval of a Conditional Shoreline Development Permit to allow the replacement of an existing two-lane, swing span bridge with a new four-lane ~~720~~⁷²⁵-foot long by 72-foot wide fixed-span bridge, that includes sidewalks, separate bicycle lanes, construction of retaining walls, signing and illumination. The bridge approach will be realigned to the east to match into the new bridge span. The existing swing span bridge, including the support structure will be removed upon completion of the fixed-span bridge. According to the SEPA checklist, approximately 30,000 cubic yards of fill and 10,000 cubic yards of cut will be required to construct the new roadways and bridge approaches. The applicant is also proposing to remove approximately 817 cubic yards of sediment that has built up around the existing bridge rest. Storm water leaving the newly constructed bridge and surrounding roads will be collected and treated in filtration vaults and bio-swales before being discharged to Ebey Slough or the Marysville storm sewer system. The project is located within SR 529 right-of-way between milepost 5.98 and 6.5.

A portion of the bridge project is located within unincorporated Snohomish County, WSDOT has submitted a substantial development permit application to Snohomish County which is currently under review.

B. Site Description

The SR 529 bridge is located in the delta of the Snohomish River. As with all major tributaries of the lower, tidally-influenced Snohomish River estuary, Ebey Slough is contained by levees throughout the project reach. The land use to the north of the current and future SR 529 bridges has been heavy industry. While much of this closed, the levees built to protect the area still remain in place. Land use to the south of the current/future bridge is undeveloped wetlands on the island lying between Ebey and Steamboat Sloughs.

C. Consistency with Shoreline Master Program:

Under the City's *Shoreline Master Plan* (SMP), the project area are designated High Intensity environment along the north portion of the bridge; Aquatic waterward of the ordinary high water mark; and Urban Conservancy to the south within the existing wetlands associated with Ebey Slough. Pursuant to the *SMP Use and Modification Matrices*, roads are a permitted use in the High Intensity designation and a conditional use in the Aquatic and Urban Conservancy designations provided there is no other feasible route or location.

The City's SMP sets forth specific goals and policies to guide developments located within shoreline jurisdiction. The applicant has submitted *Attachment A*, which is hereby adopted as part of this report, which addresses specific goals and policies of the SMP applicable to this project.

In order to meet the SMP requirements for public access along the shoreline, and because the proposed pedestrian/bike access path which was intended to be constructed under the new bridge

cannot achieve vertical separation between the path and the bridge girders, WSDOT has agreed to route the pathway as follows:

- From the Marysville Waterfront Park pathway, northward along the west SR 529 sidewalk to the 1st Street signal.
- Over SR 529 at the signal on the enhanced crosswalk.
- Southward on the eastern SR 529 sidewalk.
- Southeastward along the toe of the SR 529 bridge approach slope terminating at WSDOT right-of-way on the existing northern shoreline levee.

WSDOT will be required to construct an enhanced crosswalk of stamped asphalt at the SR 529 crossing. Additionally, the pathway which extends southeasterly from the public sidewalk shall be demarcated with a 4' high standard galvanized railing to the trail terminus. A 12' x 12' concrete pad with picnic table shall be installed at the terminus of the pathway and shall include a 4' high standard galvanized railing around the perimeter of the pad.

D. Consistency with Conditional Shoreline Development Permit Criteria

The purpose of a conditional use permits is to allow greater flexibility in administrating the use regulations of the master program in a manner consistent with the policies of the Shoreline Management Act (SMA). Conditional use permits may also be granted in circumstances where denial of the permit would result in a thwarting of the policy enumerated in the SMA. Below are the criteria for the criteria granting a conditional use permit followed by the applicant's response:

- a. The uses which are classified or set forth in the master program as conditional uses may be authorized, provided the applicant can demonstrate all of the following:*

- 1. That the proposed use will be consistent with the policies of the SMA and the policies of the master program.*

WSDOT's proposed project is designed to comply with the provisions of the Shoreline Management Act and the policies and regulations of the Marysville Shoreline Master Program.

Chapter 4. General Provisions

Archeological and Historic Resources

WSDOT addresses archaeological and historic resources through compliance with the provisions of the National Historic Preservation Act Section 106 and Washington State Executive Order 05-05. These processes involve consultation with the Washington State Department of Archaeology and Historic Preservation (DAHP), affected Tribes, the Advisory Council on Historic Preservation, and local governments.

WSDOT conducted a Cultural Resources review of the SR 529 Ebey Slough Bridge replacement project. This review included the Ebey Slough Bridge site, margins of SR 529, and three mitigation parcels located along Ebey, Steamboat, and Union Sloughs.

WSDOT conducted a Determination of National Register of Historic Properties (NRHP) Eligibility Assessment on the Existing SR 529 Ebey Slough Bridge and it was found to be eligible. Accordingly, the Ebey Slough Bridge will be documented prior to its removal. Once completed, all documentation including photographs, drawings, plans, and narrative will be submitted to the Washington State Department of Archaeology and Historic Preservation Office for archiving and for future reference.

WSDOT will develop an Unanticipated Discovery Plan that will outline procedures for notifying DAHP, Snohomish County, the City of Marysville, and affected Tribes in the event that archaeological materials are discovered during project construction. This plan will be distributed to all contractors and a copy will be maintained on the project site by the WSDOT construction office at all times during construction.

Flood Hazard Reduction and River Corridor Management

WSDOT's proposed design is intended to minimize flood hazards by replacing the existing Ebey Slough Bridge with a longer and higher bridge structure, and removing the existing bridge rest. WSDOT conducted a Reach Assessment, Channel Migration Zone Study, and Flood Impact Analysis for this project. Results from these studies were incorporated into the project design through avoidance and minimization strategies.

By replacing the existing Ebey Slough Bridge with a longer and higher bridge structure, and removing the existing bridge rest, the project will reduce flood impacts over the existing condition.

Public access to the Ebey Slough shoreline will not change as a result of this project. The new bridge does improve bicycle and pedestrian safety across the bridge by providing wider shoulders and two Americans with Disabilities Act (ADA) compliant sidewalks on the bridge deck. The new two-way turning lane on the north bridge approach provides better public access to local businesses.

WSDOT highway facilities are designed for the movement of vehicles, goods, and services. Roadway shoulders are designed for emergency parking only. There are significant safety concerns associated with promoting public access due to dangers associated with high traffic speeds.

Chapter 5. Shoreline Modification Provisions

Fill

The new SR 529 Ebey Slough Bridge span is longer than the existing bridge, allowing the bridge approach to be placed entirely upland of

the Ordinary High Water Mark. The bridge span between the roadway fill approaches will rest on concrete piers.

The new SR 529 Bridge is designed to reduce impacts by raising and lengthening the bridge span over Ebey Slough and reducing the number of structures in the channel. The new bridge clearance will be 16.5 feet above the mean high water mark of Ebey Slough, whereas the existing bridge clearance is 8 feet. At 720 feet, the new bridge is 20 feet longer than the existing bridge. The in channel structures are reduced from three to two. There are a total of five piers supporting the new bridge span where there were three piers and eight additional bents supporting the old bridge span.

WSDOT performed a Flood Impact Analysis in May 2009 and determined that the combined actions of removing the existing SR 529/25 swing bridge and constructing a fixed span replacement bridge would result in a net reduction of approximately 120 cubic yards of fill within the floodplain of Ebey Slough. This would result in an incremental decrease in flood elevations in Ebey Slough.

The proposed project is designed to improve water quality, and fish and wildlife habitat, by removing the old bridge and replacing it with a taller, longer structure that reduces infringement on the Ebey Slough channel. Additionally, the removal of creosote piles from the existing bridge will improve water quality conditions. WSDOT has developed a series of Best Management Practices (BMP) to minimize short-term impacts to water quality, fish and wildlife habitat associated with construction activities. Please see the JARPA form, Draft Wetland and Stream Mitigation Report, and the Biological Assessment for descriptions of the measures.

Chapter 6. Shoreline Use Provisions

Transportation and Parking

WSDOT views this project as one that maintains and preserves the existing highway facility. The basic infrastructure is in place. There is an existing two-lane roadway and sufficient existing right-of-way to construct the project. The only alternative would be to relocate the existing facility to another location within the Shoreline Zone. This would likely result in more significant impacts to the environment, local properties, and land uses.

WSDOT is committed to working in cooperation with all agencies and municipalities in the development of State highway infrastructure and believes that the proposed project is consistent with the City's comprehensive plan and applicable capital improvement plans. WSDOT is equally committed to ensuring that work is carried out in

compliance with Washington State Department of Ecology approved Shoreline Master Program.

Two sidewalks and bicycle lanes will be constructed on the shoulders of the new bridge deck. Three new ADA ramps will be installed in the project area.

The bridge abutments for the new bridge will be constructed in upland areas outside the existing diking system. Where the existing bridge will be removed, disturbed embankments will be regraded to the original slope and revegetated with native plants and grasses.

SR 529 runs perpendicular to the shoreline of Ebey Slough. The new bridge is routed as close as possible to the existing bridge to minimize shoreline and ecological impacts and maintain existing business connectivity. WSDOT has minimized impacts to shoreline vegetation to the extent possible. Whenever possible, existing vegetation will be preserved. Disturbed areas will be hydro-seeded and then re-planted with native vegetation including lyngby's sedge and hardstem bulrush. Impacted buffers within the shoreline area of this project will be re-established with black twinberry, hookers willow, pea fruit rose, red elderberry, scoulers willow, snowberry, and black hawthorn (please see planting plan in the Draft Wetland and Stream Mitigation Report).

New surface water drainage systems will be designed in conformance with the 2008 WSDOT Highway Runoff Manual approved by the Washington State Department of Ecology. WSDOT will prepare a Temporary Erosion and Sediment Control Plan (TESC) which will address all temporary and permanent Best Management Practices (BMPs) required for construction and maintenance of this project. These BMPs will include but are not limited to bio-swales, vegetated filter strips, and a filtration vault.

WSDOT's Maintenance Division maintains vegetated areas within the right-of-way. The Maintenance Division has in place procedures for addressing noxious weeds and invasive species. These practices are specified in WSDOT's Vegetation Management Manual.

All utility trunk lines and related facilities installed by WSDOT will be buried within the roadway prism and/or attached directly to the SR 529 bridge superstructure to minimize shoreline impacts.

2. *That the proposed use will not interfere with the normal public use of the shorelines.*

The new Ebey Slough Bridge will be constructed entirely within state right-of-way. This right-of-way is dedicated to highway construction and contains an existing state highway and bridge. WSDOT does not encourage public access within state highway right-of-way for safety

reasons. WSDOT highway facilities are designed for the rapid movement of vehicles, goods and services. Roadway shoulders are designed for emergency parking only. There are significant safety concerns associated with promoting public access due to dangers associated with high traffic speeds. Encouraging access under highway bridges is also discouraged.

3. *That the proposed use of this site and design of the project will be compatible with other permitted uses within the area.*

WSDOT strives to involve agencies and municipalities early on in the project development process to ensure compatibility with other permitted uses in the project area. WSDOT coordinated with the city of Marysville in bridge lighting and plant hanger design to improve the appearance of the bridge. WSDOT developed drainage system linkages and utility relocations with Marysville's Public Works department. WSDOT will extend the bicycle path from the Marysville marina over SR 529 terminating on the eastern property line with a 12-foot by 12-foot landing near the north shore of Ebey Slough. WSDOT plans to add sidewalks and bicycle lanes on the new bridge deck to connect the city's bicycle and pedestrian lanes with the south side of the Ebey Slough Bridge. WSDOT will install electrical, and fiber optics conduit to accommodate utility expansion across the new Ebey Slough Bridge. WSDOT will install a two way left turn lane on SR 529 north of the new bridge to maintain access to local businesses.

4. *That the proposed use will cause no unreasonably adverse effects to the shoreline environment designation in which it is to be located.*

No unreasonably adverse effects to the shoreline will result from rebuilding the SR 529 Ebey Slough Bridge. WSDOT will be replacing the existing Ebey Slough bridge which is 87 years old and past its service life. The new four-lane 720-foot long by 72-foot fixed-span bridge and associated road approaches will likely enhance the shoreline's appearance. (See WSDOT response to the City of Marysville Master Program Question 5 below).

Any impacts to sensitive areas in the shoreline resulting from construction of this project will be fully mitigated with the city of Marysville and Snohomish County in accordance with their respective Critical Area Ordinances.

5. *That the public interest suffers no substantial detrimental effect.*

There are no substantial detrimental effects from replacement of the SR 529 Ebey Slough Bridge. Upon completion of the SR 529 Ebey Slough Bridge project, the public will benefit from:

- **Improved connectivity between the cities of Everett and Marysville;**
- **Increased traffic capacity on SR 529;**
- **Improved navigation on Ebey Slough;**
- **Increased floodway capacity;**
- **Enhanced business and park access;**
- **Additional bicycle and pedestrian lanes;**
- **Improved access and utilities for future business development south of Ebey Slough;**
- **A reduction of potential contaminant sources in Ebey Slough; and**
- **Improved shoreline visibility.**

b. Other uses which are not classified or set forth in the master program may be authorized as conditional uses provided that the applicant can demonstrate, in addition to the criteria set forth in Subsection a of this section, that extraordinary circumstances preclude reasonable use of the property in a manner consistent with the use regulations of the master program.

Not Applicable.

c. In the granting of all conditional use permits, consideration shall be given to the cumulative impact of additional requests or like actions in the area.

WSDOT is not aware of other bridge construction projects near the project area.

E. Cultural Resource Survey

The applicant submitted a *Cultural Resource Assessment*, prepared by AMEC Earth and Environmental, Inc., dated February 20th, 2008. The report concludes the following:

Results are equivocal. One historic building was assessed for listing on the National Register of Historic Places. It was not found to be eligible for listing. Limited trenching in the footprint of the new bridge identified a brick wall/foundation feature overlain by historic fill. The feature is of unknown age, but appears to have been part of a lumber mill built on the site in the 1950s. The foundation stands in an area known to have been used during the early settlement of Marysville. Because limited trenching and high water conditions did not permit full exploration of the foundation feature, the feature was not recorded as an archaeological site. There remains a high potential for historic archaeological deposits and the possibility of deeply buried Native American archaeological deposits within the northern portion of the proposed bridge footprint. It is, therefore, recommended that WSDOT prepare an inadvertent discovery plan and provide archaeological monitors during ground disturbance associated with the construction of the new bridge abutment. No Historic Properties or potentially

eligible sites were identified through this investigation. If an inadvertent discovery plan is developed and monitoring conducted, this project will have 'no adverse effect' on historic properties.

In addition, the existing bridge is eligible for the National Register of Historic Places. WSDOT is currently involved in a Section 106 consultation regarding the existing bridge. The 106 consultation is occurring with the USACE 404 permit review process and is anticipated to be resolved through that process.

The Tulalip Tribes have stated their interest in being involved in the historic/cultural assessment. WSDOT has agreed to work with the Tribe through the USACE 404 permit process. Also, if construction activities yield buried prehistoric to historic material cultural and/or human remains, the project should be temporarily halted consistent with the inadvertent discovery plan and until representatives of the US Army Corp of Engineers, the Tulalip Tribes, DAHP, and the City are consulted to assess and protect the resource.

F. Floodplain Regulations and Channel Migration

The subject property area is mapped within the 100-year floodplain of Ebey Slough by Snohomish County. The Flood Insurance Rate Map (FIRM) also designates this site as within the 100-year floodplain (Zone AE). The FIRM floodplain elevation has been identified by FEMA as NGVD 27 elevation of 9' or NAVD 88 elevation of 12.7'. The applicant has submitted a *Flood Impact Analysis* that concludes the following:

The combined actions of removing the existing SR 529/25 swing span bridge with a fixed span replacement bridge would result in a net loss of a little more than 120 cubic yards of fill within the water column of the floodplain of Ebey Slough thus increasing floodplain storage capacity. This would theoretically result in a small, incremental decrease in base flood elevations in the backwater of the SR 529/25 replacement bridge in Ebey Slough. It should be noted that removal of the central pivot pier of the existing bridge accounts for 71 percent of the total fill loss. The project would also result in a net 97 percent loss in floodway fill, which affects Ebey Slough water levels at all stages and at all times. Even though the project would result in a net gain of over 910 cubic yards of fill in the flood fringe, these volumes would only affect river stages at the highest of high tides combined with strong base flows in Ebey Slough and this volume is more than compensated by floodway fill losses. The net impact of the SR 529/25 bridge replacement project on base flood levels would be a small, incremental decrease, although due to economies of scale this decrease would likely not be measurable in any practical sense.

Additionally, the applicant has submitted a *Channel Migration Zone Study* prepared by WSDOT Environmental Services, Hydrology Program, dated March 2009 which concludes that the replacement bridge project would have no effect on channel migration within the project reach and the reduction of fill within the floodway will reduce backwater effects in the near up-river vicinity of the SR 529/25 replacement bridge.

G. Noise

The applicant has submitted a *Noise Technical Report* prepared by WSDOT Air, Noise, and Energy Program, dated 10/29/2007 which concludes the following:

For the existing year (2006) and for the design year (2030), the modeling results indicate that there are no homes exposed to traffic noise levels exceeding the NAC (66 dBA). The noise modeling results for the existing year and for the design year indicate that the businesses along SR 529 would experience traffic noise levels exceeding the NAC of 71 dBA. But noise barrier walls along the right-of-way to protect the affected businesses require driveway access to the highway. Any noise wall along the right-of-way would have to include wide openings for individual driveways, which would reduce the noise reduction efficiency that would be provided by a continuous noise wall. Therefore, it is not feasible to construct noise barrier walls for this project.

Construction noise is exempt from local property line regulations during daytime hours. The most constant noise source at construction sites would be internal combustion engines. Engine-powered equipment includes earth (bridge) removing equipment, material-handling equipment, and stationary equipment. Mobile equipment operates in a cyclic fashion, while stationary equipment, such as generators and compressors, operates at sound levels fairly constant over time. Because trucks would be present during most phases and would not be confined to the project site, noise from trucks could affect more receptors. Other noise sources would include impact equipment, which could be pneumatically powered, hydraulic, or electric.

H. Critical Areas

The applicant submitted a *Wetland and Stream Assessment Report* prepared by Northwest Region Environmental Services, dated March 2002, updated November 2008. The report identifies one estuarine wetland delineated into five segments (A through E) in the project corridor. The estuarine wetland is classified as a Category I wetland within the City of Marysville. The wetland is supported by Ebey Slough tides and the majority of the delineated wetland is located within the Ebey Slough mean higher high water (MHHW). One Type S (Shoreline of Statewide Significance) stream, Ebey Slough is located within the project corridor.

Project Impacts

The project as proposed will have unavoidable impacts to the wetland associated with Ebey Slough. Total project impacts include 0.23 acre of permanent wetland impact and 0.67 acre of permanent buffer impact. There will be 0.24 acre of indirect impact and 0.11 acre of indirect buffer impact resulting from shading from the new bridge. The project will also have long-term and short-term temporary impacts from construction and demolition work trestles. Long-term temporary impacts total 0.04 acre for wetlands, and short-term temporary impacts total 0.60 acre for wetlands and 0.06 acre for buffers. A portion of the project occurs within unincorporated Snohomish County, the following is a breakdown of wetland impacts within the city limits –vs- Snohomish County:

Permanent impacts to the open-water channel of Ebey Slough include 160 sq. ft. of permanent channel from the placement of the new bridge pier foundations. Additional permanent stream impacts include approximately 817 cubic yards of sediment removal during removal of the existing bridge rest, and shading from the 21,960 sq. ft. of new bridge deck. The removal of the existing bridge will daylight 9,672 sq. ft. of channel, leaving a net total of 1,308 sq. ft. of channel that will be shaded by the new bridge structure. The project will include removal of the bridge superstructure; removal of concrete piers and abutments to at least 3 feet below the existing grade; extraction of the bridge rest and fender timbers and piles. Any piles that break during extraction will be cut off at either the existing mud line or sediment removal elevation, as applicable, and capped with steel or plastic covers; removal of approximately 817 cubic yards of sediment that have accumulated around the bridge rest. Removal depths will be up to 4.5 feet. Permanent sediment removal will be offset by replacement of the removed sediment with native soil material totaling the same area.

Temporary stream impacts include approximately 15,785 sq. ft. from installation of piers associated with temporary work trestles, removal of existing foundations, demolition from the existing bridge, and shading from the temporary work trestles. These areas will be returned to pre-construction conditions after project work completion.

Avoidance/Minimization of Impacts

Pursuant to the City's SMP, the project applicant must demonstrate that the project, as proposed, meets the avoidance/minimization criteria as outlined. In response to the criteria, WSDOT has submitted the following:

WSDOT has avoided and minimized impacts to wetlands and wetland buffers to the greatest extent practicable. Total avoidance was not possible due to constraints with safety and design guidelines.

Avoidance

There were two reasonable alternatives considered for replacing this bridge. One was to replace it upstream and the other downstream.

- WSDOT chose to construct the new bridge east of the existing bridge primarily on existing fill. Constructing the new bridge west of the existing bridge would have impacted 0.57 acres of wetland. Constructing the new bridge east of the existing bridge resulted in 0.10 acres of impact to wetland. The bridge placement avoided 0.47 acres of wetland impact.
- WSDOT lengthened the new bridge spans to reduce the number of bridge piers from seven to five. This action reduced the piers impacting wetlands from two piers to one.

Minimization

Clearing and grading

- Best management practices (BMPs) will be applied to limit erosion or runoff.
- Stockpiled earthen material will not be stored in sensitive areas.
- Specific permit requirements and weather conditions (dry or wet season) will limit the amount of clearing and open grading that can occur at any one time.
- Sediment and dust control measures will be implemented to prevent waterway contamination or the transport of debris outside of the construction site.

New Bridge approaches

- There are some known contaminants that may be released by construction. Cleanup and disposal measures will be implemented to properly dispose of any contaminants encountered during the construction of the approaches.
- Steepening side slopes will reduce wetland fills.
- Stormwater filtration with 3:1 fill slopes will be installed to minimize excavating wetland areas for stormwater treatment.
- A filtration vault will filter stormwater runoff prior to routing it into the city of Marysville stormwater system.

Temporary work trestles

- The piles will be driven by vibration to minimize turbidity.
- Handrails and kickboard will typically be placed along work trestles during construction for worker safety and to prevent materials from sliding over the edge.
- The decks will be sealed to prevent material passing through the deck.

New Bridge

- In-water work will only be conducted during the work window established by the HPA to minimize turbidity and sedimentation impact.
- Bio-swales and vegetative strips will be incorporated into the project to reduce wetland sedimentation and turbidity.
- During bridge painting, a containment system will be placed around the bridge to prevent contamination and dust from entering the wetland.
- Concrete forms will be sealed with foam to prevent leakage of any cement residue into the wetland.

Old bridge demolition

- Piles that break during extraction will be cut off at the existing mud line, sealed and capped with a metal or plastic cover to prevent pier contamination from escaping into the wetland.
- Unconfined excavation will occur during low tide.

- Piles will be pulled during low/slack tides. Silt curtains will be placed around the work area where practical, otherwise restrictions on the number of piles that can be extracted at a time will be applied to minimize re-suspension of sediment during pile removal.
- A containment system will be installed below the bridge spans over the wetlands to capture debris from demolition activities.
- Appropriate BMPS, such as containment tarps, will be utilized to ensure no material enters Ebey Slough during construction.
- The contractor will install cofferdams around the existing eight piers and swing-span pedestal prior to demolition.
- BMPs such as extraction of the cofferdams and piles in the dry or at low/slack tides and limiting the number that can be extracted at a time will be applied to minimize turbidity due to removal.
- All creosote treated timbers and piles and excavated contaminated sediment will be removed and sent to an approved disposal site.

Project Mitigation

The City of Marysville is currently in the process of establishing an advance mitigation area as compensatory mitigation credit for the proposed flooding of city-owned property within the proposed Qwuloolt Estuary Restoration Project. Replacement ratios for projects using advance mitigation credits will be established through the approval process and will be consistent with the final conditions of the advance mitigation credit approval.

Pursuant to MMC 19.24.125, compensatory mitigation for permanent wetland impacts within the City limits, WSDOT will be required to enter into a *Memorandum of Agreement* with the City to purchase advance mitigation credits designated for the Qwuloolt Estuary Restoration Project – City-owned properties, provided the proposed use of advanced mitigation credits is consistent with the terms and conditions of approval. If for some reason establishment of the advanced mitigation is not feasible, then the applicant will be required to provide mitigation within the project vicinity consistent with the City’s Critical Areas Ordinance.

WSDOT is also considering two options for potential compensatory wetland and stream mitigation for permanent impacts to the portion of wetland located within Snohomish County. Mitigation Option A includes participating in the Snohomish County fee-in-lieu program by providing funds for the Smith Island Estuary Restoration Project, which will provide wetland and fish habitat. Mitigation Option B includes providing approximately six acres of estuarine wetland and buffer mitigation at a conjoined, 20-acre mitigation site with the Burlington Northern-Santa Fe Railroad on a portion of Smith Island along Union Slough.

I. Biological Assessment

The applicant has submitted a *Biological Assessment* (BA) prepared by Northwest Region Environmental Services, dated February 2009 describing the project background, populations potentially impacted by the proposed action, and measures to avoid and mitigate impacts. Direct effects of the proposed project on listed species are related to temporary and permanent impacts within the project footprint. Temporary impacts are associated with access roads, pile driving in

the streambed, noise, temporary shading, and water quality from the potential release of contaminated sediment and turbidity. Permanent impacts include clearing and grubbing vegetation, potential for permanent noise impacts on listed fish species, and the placement of permanent fill below the MHHWM for three new piers.

Indirect effects include temporary impacts from installation of the temporary work bridges, because of impacts to estuarine wetland vegetation that provide fish habitat; and potential impacts to juvenile salmonids following exposure to underwater noise from impact pile driving. The installation of permanent stormwater treatment facilities will have a long term effect that is beneficial for all listed aquatic species. All interrelated actions associated with the project are deemed insignificant or beneficial for ESA-listed salmonids.

The U.S. Fish and Wildlife Service (USFWS) and NOAA's National Marine Fisheries Service (NOAA Fisheries Service) species listings identified the following listed fish species in the project area: Puget Sound Chinook salmon, Puget Sound steelhead trout, and Coastal Puget Sound bull trout.

Based on the project impacts presented and the minimization measures proposed in the BA for the project, the proposed project **may affect, but is not likely to adversely affect** Puget Sound Chinook salmon, Puget Sound steelhead trout, and Coastal-Puget Sound bull trout. The proposed project **may affect, is likely to adversely affect** on critical habitat for Puget Sound Chinook salmon and Coastal-Puget Sound bull trout. Also, the proposed project will likely result in **adverse affects to** essential fish habitat (EFH) for Chinook, pink, and coho salmon during in-water work for similar reasons as the proposed impacts to ESA-listed species and critical habitat.

The applicant has received a conditional HPA from WDFW and is in the process of obtaining a 404 permit from the USACE and a 401 permit and a CZM consistency determination from the DOE. The applicant will be required to receive all applicable local, state, and federal permits prior to commencement of construction activity.

J. Conformance with SEPA

A Determination of Non-significance (DNS) was issued by WSDOT on October 13, 2009. There were no appeals. This determination is hereby adopted by reference as part of this report.

K. Findings and Conclusions

1. The proposal as conditioned, is consistent with the City of Marysville Shoreline Management Master Program map designation, development policies and regulations.
2. The proposal as conditioned, is consistent with the conditional shoreline use criteria as established in the City's SMP.
3. The proposal as conditioned, is consistent with the City's Critical Areas Ordinance.
4. The proposal as conditioned, is consistent with the City's Floodplain regulations.

III. STAFF RECOMMENDATION

Based upon the above stated findings and conclusions, the Community Development Department recommends approval of the Conditional Shoreline Development Permit subject to the following conditions:

1. WSDOT shall construct an enhanced crosswalk of stamped asphalt at the SR 529 crossing. Additionally, the pathway which extends southeasterly from the public sidewalk shall be demarcated with a 4' high standard galvanized railing to the trail terminus. A 12' x 12' concrete pad with picnic table shall be installed at the terminus of the pathway and shall include a 4' high standard galvanized railing around the perimeter of the pad.
2. If during construction activities, buried prehistoric to historic material, cultural, and/or human remains are found, the project shall be temporarily halted consistent with the inadvertent discovery plan and until representatives of the US Army Corp of Engineers, the Tulalip Tribes, DAHP, and the City are consulted to assess and protect the resource.
3. WSDOT shall be required to enter into a *Memorandum of Agreement* with the City to purchase advance mitigation credits designated for the Qwuloolt Estuary Restoration Project – City-owned properties, provided the use of the credits is consistent with the terms and conditions of the advance mitigation approval. Alternative mitigation may be approved by the City provided it is consistent with the city's mitigation requirements as set forth in the City's CAO.
4. WSDOT shall be required to remove the existing bridge superstructure, bridge rest and fender timber and piles, and concrete piers and abutments.
5. Prior to commencement of construction activities, the applicant shall submit a *Spill Prevention Control and Countermeasures (SPCC)* Plan to the City for review and approval.
6. Prior to commencement of construction activities, the applicant will be required to submit a final, detailed mitigation plan to the city for review and approval that is consistent with MMC 19.24.130 through 19.24.150.
7. The issuance of this conditional shoreline permit approval shall not be considered a waiver of or statement of compliance with permit requirements from other agencies with potential jurisdiction over the described work. If changes to the proposed impacts or mitigation boundary occur as a result of agency review, the construction and mitigation plans shall be revised accordingly.
8. Prior to issuance of a grading permit, the applicant shall obtain all applicable county, state and federal permits.

A RESOLUTION OF THE CITY OF MARYVILLE AFFIRMING THE RECOMMENDATION OF THE HEARING EXAMINER AND GRANTING A CONDITIONAL SHORELINE SUBSTANTIAL DEVELOPMENT PERMIT TO ALLOW THE REPLACEMENT OF THE SR 529 BRIDGE WITH A 4-LANE FIXED SPAN BRIDGE THAT INCLUDES SIDEWALKS, SEPARATE BICYCLE LANES, SIGNING, ILLUMINATION, STORMWATER TREATMENT, RETAINING WALLS, WETLAND AND BUFFER MITIGATION

WHEREAS, the Washington State Department of Transportation (WSDOT) owns certain right-of-way within SR 529 between milepost 5.98 and 6.5, in the City of Marysville, and

WHEREAS, the WSDOT applied to the City for a conditional Shoreline Substantial Development Permit to replace the existing two-lane swing span bridge with a new 4-lane 680-foot long by 72-foot wide fixed span bridge together with associated improvements; and

WHEREAS, a SEPA Threshold Determination of Non-Significance was issued by WSDOT on October 13, 2009; and

WHEREAS, the City Hearing Examiner held a public hearing on January 14, 2010 and adopted Findings of Fact, Conclusions and a Recommendation approving the conditional Shoreline Substantial Development Permit subject to eight (8) conditions; and

WHEREAS, the City Council held a public meeting on said conditional Shoreline Substantial Development Permit on February 8, 2010 and following a review of the record before the Hearing Examiner concurred with the Findings of Fact, Conclusions and Recommendation of the Hearing Examiner; NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARYSVILLE, WASHINGTON AS FOLLOWS:

1. The Findings of Fact, Conclusions and Recommendation of the Hearing Examiner with respect to the above-referenced conditional Shoreline Substantial Development Permit under File No. PA 09038 is hereby adopted by this reference as the decision of the City Council.
2. The conditional Shoreline Substantial Development Permit for the above described property shall be perpetually conditioned upon strict compliance with each of the conditions set forth in the Recommendation of the Hearing Examiner.
3. Violation of any of the conditions of said decision may result in revocation of the conditional Shoreline Substantial Development Permit or enforcement action being brought by the City.
4. This decision shall be final and conclusive with the right of appeal by any aggrieved party to the Shorelines Hearings Board pursuant to RCW 90.58.140(6).
5. The Director of Community Development is directed to file this Resolution and the decision of the Hearing Examiner with the Department of Ecology.






SECTION E

EASTERN WORK TRETTLES ELEVATION VIEW




