18 I, Leesa Manion, Prosecuting Attorney for King County in the name and by the authority
19 of the State of Washington, do accuse JING EMTAGE, AND GERALD ALLAN EMTAGE of
20 the following crime[s], which are of the same or similar character, and which are based on the
21 same conduct or a series of acts connected together or constituting parts of a common scheme or
22 plan: **Leading Organized Crime, Money Laundering, Promoting Prostitution In The
23 Second Degree, Promoting Prostitution In The Second Degree, Promoting Prostitution In
24 The Second Degree, Promoting Prostitution In The Second Degree, Promoting Prostitution
In The Second Degree, Promoting Prostitution In The Second Degree, Promoting
Prostitution In The Second Degree, Promoting Prostitution In The Second Degree,
Promoting Prostitution In The Second Degree, Promoting Prostitution In The Second
Degree,** committed as follows:

Count 1 Leading Organized Crime

That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
them in King County, Washington, on or about the period between January 1, 2021 and May 2,
2023 , did intentionally organize, manage, direct, supervise and finance three or more of the
following persons a female identified as "Alicia" at Element Massage, a female identified as
"Mia" at Garden Spa, and a female identified as "Jenny" at Luxe Massage, with intent to engage
in a pattern of criminal profiteering activity, to-wit: three or more of the crimes charged in
Counts 3, 4 and 5 which are incorporated herein by reference

Contrary to RCW 9A.82.060(1)(a) and 9A.82.010(12), and against the peace and dignity
of the State of Washington.

1 **Count 2 Money Laundering**

2 That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
3 them in King County, Washington, on or about the period between January 1, 2021 and May 1,
4 2023 , did conduct a financial transaction involving the proceeds of specified unlawful activity,
5 to-wit: Promoting Prostitution in the Second Degree RCW 9A.88.080, knowing that the
6 transaction was designed in whole and in part to conceal and disguise the nature, location,
7 source, ownership, and control of the proceeds, and acted recklessly as to whether the property
8 was proceeds of specified unlawful activity;

9 Contrary to RCW 9A.83.020(1)(b), and against the peace and dignity of the State of
10 Washington.

11 **Count 3 Promoting Prostitution In The Second Degree**

12 That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
13 them in King County, Washington, on or about the period between January 1, 2021 and May 2,
14 2023 , did knowingly advance and profit from the prostitution of a female identified as "Alicia"
15 at Element Massage (another person);

16 Contrary to RCW 9A.88.080(1)(b), and against the peace and dignity of the State of
17 Washington.

18 **Count 4 Promoting Prostitution In The Second Degree**

19 That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
20 them in King County, Washington, on or about the period between January 1, 2021 and May 2,
21 2023 , did knowingly advance and profit from the prostitution of a female identified as "Mia" at
22 Garden Spa (another person);

23 Contrary to RCW 9A.88.080(1)(b), and against the peace and dignity of the State of
24 Washington.

Count 5 Promoting Prostitution In The Second Degree

That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
them in King County, Washington, on or about the period between January 1, 2021 and May 2,
2023 , did knowingly advance and profit from and a female identified as Jenny at the prostitution
of a female identified as "Jenny" at Luxe Massage (another person);

Contrary to RCW 9A.88.080(1)(b), and against the peace and dignity of the State of
Washington.

1 **Count 6 Promoting Prostitution In The Second Degree**

2 That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
3 them in King County, Washington, on or about the period between January 1, 2021 and May 2,
4 2023 , did knowingly advance and profit from the prostitution of a female identified as "Mia" at
5 Lily's Massage (another person);

6 Contrary to RCW 9A.88.080(1)(b), and against the peace and dignity of the State of
7 Washington.

8 **Count 7 Promoting Prostitution In The Second Degree**

9 That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
10 them in King County, Washington, on or about the period between January 1, 2021 and May 2,
11 2023 , did knowingly advance and profit from the prostitution of a female identified as "Lisa" at
12 the little Massage Spa (another person);

13 Contrary to RCW 9A.88.080(1)(b), and against the peace and dignity of the State of
14 Washington.

15 **Count 8 Promoting Prostitution In The Second Degree**

16 That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
17 them in King County, Washington, on or about the period between January 1, 2021 and May 2,
18 2023 , did knowingly advance and profit from the prostitution of a female identified as "Lucy" at
19 Apple Massage (another person);

20 Contrary to RCW 9A.88.080(1)(b), and against the peace and dignity of the State of
21 Washington.

22 **Count 9 Promoting Prostitution In The Second Degree**

23 That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
24 them in Snohomish County, Washington, on or about the period between January 1, 2021 and
May 2, 2023 , did knowingly advance and profit from the prostitution of a female identified as
"Eva" at L massage (another person);

 Contrary to RCW 9A.88.080(1)(b), and against the peace and dignity of the State of
Washington.

Count 10 Promoting Prostitution In The Second Degree

 That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
them in Snohomish County, Washington, on or about the period between January 1, 2021 and
May 2, 2023 , did knowingly advance and profit from the prostitution of a female identified as
"Yoyo" at Lemon Spa (another person);

2 Contrary to RCW 9A.88.080(1)(b), and against the peace and dignity of the State of
Washington.

3 **Count 11 Promoting Prostitution In The Second Degree**

4 That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
5 them Skagit County, Washington, on or about the period between January 1, 2021 and May 2,
6 2023 , did knowingly advance and profit from the prostitution of a female identified as "DeeDee"
at Sports Massage (another person);

7 Contrary to RCW 9A.88.080(1)(b), and against the peace and dignity of the State of
Washington.

8 **Count 12 Promoting Prostitution In The Second Degree**

9 That the defendants JING EMTAGE AND GERALD ALLAN EMTAGE and each of
10 them in Benton County, Washington, on or about the period between January 1, 2021 and May 2,
11 2023 , did knowingly advance and profit from the prostitution of a female identified as "Dee" at
Eastern Silk Massage (another person);

12 Contrary to RCW 9A.88.080(1)(b), and against the peace and dignity of the State of
Washington.

4 PROSECUTING ATTORNEY CASE SUMMARY AND REQUEST FOR BAIL AND/OR
5 CONDITIONS OF RELEASE

6 The State incorporates by reference the Certification for Determination of Probable
7 Cause prepared by Deputy Michael J Rexach of the King County Sheriff's Office for case
8 number C21008549.

9 The State respectfully requests that bail be set in the amount of \$1,000,000 for each
10 Defendant. This request is based upon CrR 3.2 that the defendants are not likely to appear for
11 future court appearances and that they may interfere with the administration of justice.

12 According to the Certification for Determination of Probable Cause and the investigation in this
13 case, over the course of two years Gerald and Jing Emtage owned and operated an extensive
14 criminal enterprise spanning four counties in Washington State and it appears that they may have
15 been planning to expand their business to other states. During that time made significant profits
16 from the commercial sexual exploitation of dozens of women.

17 As established through bank records, including foreign bank accounts and an account in
18 Hawaii, and the amount of United States currency recovered during the service of the search
19 warrants in this case it is clear that the defendants have the financial means to flee the
20 jurisdiction and the incentive to do so as they are charged with multiple felonies including a class
21 A felony.

22 It is clear from the investigation in this case that there is a substantial imbalance of power
23 between the defendants and the women that were trafficked and exploited through their
24 businesses. While the victims slept and ate in the same buildings where they were required to

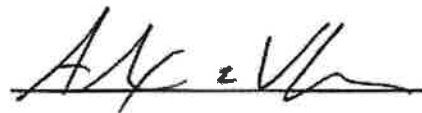

2 provide sexual services to strange men, the defendants were living in a home valued at over a
3 million dollars. While the Defendants funneled over a million dollars through their bank
4 accounts and hid hundreds of thousands of dollars in their home, there no State records of any
5 wages paid to their victims.

6 Gerald Emtage is currently on a deferred sentence for Patronizing a Prostitute out of King
7 County District Court. According to the docket he was sentenced in that matter on January 9,
8 2023.

9 Jing Emtage has no known criminal history.

10 The State further requests that the defendants be ordered to surrender their passports and
11 should they post bond that they be placed on electronic home detention with GPS monitoring.
12 Further, the State asks that the court order that they have no contact with each other and no
13 contact with any of the victims.

CERTIFICATION FOR DETERMINATION OF PROBABLE CAUSE

That Michael Rexach is a (n) Detective with the King County Sheriff's Office and has reviewed the investigation conducted in the King County Sheriff's case number (s) C21008549;

There is probable cause to believe that
Gerald Allan Emtage DOB: 08/02/1975

committed the crime(s) of:
Leading Organized Crime, RCW 9A.82.060; Money Laundering, RCW 9A.83.020; and
Promoting Prostitution in the Second Degree, RCW 9A.88.080

This belief is predicated on the following facts and circumstances:

There is probable cause to believe that Jing EMTAGE (03/11/1972) and Gerald EMTAGE (08/02/75) have committed the crimes of Leading Organized Crime RCW 9A.82.060, Money Laundering RCW 9A.83.020, and Promoting Prostitution in the Second Degree RCW 9A.88.080, for owning, operating, organizing, financing and managing multiple massage parlors as fronts for commercial sex acts and/or prostitution. This enterprise spans four counties in Washington State and there is evidence to suggest that they have and may be exploring business opportunities in Oregon and Hawaii.

This investigation began in January 2021, when the King County Sherriff's Office, (KCSO) received a citizen complaint about a massage storefront called ELEMENT MESSAGE. The verbal complaint was in regard to acts of prostitution occurring within the business, located at 9988 15th AVE SW Suite G Seattle, WA 98146, which is in the County of King, State of Washington. I began looking into the business through Washington State business records and learned that ELEMENT MESSAGE is owned by J&J RELAX SPA LLC.

J&J RELAX SPA LLC is owned and operated by Gerald "Jerry" Allan EMTAGE (08/02/1975) and Jing EMTAGE (03/11/1972). There have been a total of twelve known massage parlors that have been operated under J&J RELAX SPA LLC. Several of these massage parlors have been opened during the duration of this investigation and others have closed or changed ownership. The following list is the current known massage parlors open for business owned by Jing and Gerald Emtage: Eastern Silk Spa (AKA: Eastern Spa), 1207 George Washington Way, STE 21, Richland, WA, 99352; Element Massage, 9988 15th Ave SW, STE G, Seattle, WA, 98146; Garden Massage Spa, 15020 Ambaum Blvd SW, STE C, Burien, WA, 98146; Lily's Massage (AKA Lily's Spa), 17824 1st Ave S, STE 102, Burien, WA, 98148; Sports Massage, 1750 S Burlington Blvd, STE B, Burlington, WA, 98233; Luxe Massage, 15836 4th AVE SW Burien, WA 98166; Apple Massage, 28707 Pacific Hwy S, Federal Way, WA 98003; L Massage, 1326 5th St, Marysville, WA 98270; Lemon Spa, 4716 Evergreen Way, Everett, WA 98203. In addition to these currently operating store fronts the EMTAGE'S through their corporation also owned and operated Lucky Chen Massage in Tacoma, WA and Little Massage Spa in Seattle, WA which have either closed or changed ownership.

During the duration of this investigation encompassing the charging period for these offenses, detectives entered J&J RELAX SPA LLC operated

1 storefronts in an undercover capacity posing as customers. Once inside the
2 massage parlor the detective would pay the "house fee" for a massage, which
3 was typically \$50.00 for a half hour and \$70.00 for an hour. During these
4 undercover operations, and offer and agreement for a sexual act(s) was
5 verbally agreed upon for an additional fee or "tip" then declined by the
6 detectives. The sexual acts proposed, which ranged from manual stimulation to
7 sexual intercourse, priced from \$40.00 to \$200.00. Detectives completed a
8 total of 28 undercover operations at the above listed businesses between
9 January 2021 and April 2023. During each visit the detectives were offered
10 sex acts ranging from manual stimulation of their genitals, oral sex, and in
11 some instances sexual intercourse in exchange for a fee. These operations
12 included: a female identified as "Alicia" at Element Massage, a female
13 identified as "Mia" at Garden Spa, a female identified as "Jenny" at Luxe
14 Massage, a female identified as "Mia" at Lily's Massage, a female identified
15 as "Lisa" at the little Massage Spa, a female identified as "Lucy" at Apple
16 Massage, a female identified as "Eva" at L Massage, a female identified as
17 "Yoyo" at Lemon Spa, a female identified as "DeeDee" at Sports Massage, and a
18 female identified as "Dee" at Eastern Silk Massage.

19 The detectives' observations and experiences were corroborated by
20 several citizen complaints about the ongoing prostitution activities at some
21 of the locations. In September 2022, a citizen called the police to report
22 that he had gone into the GARDEN SPA and was offered the sex acts of a
23 "handjob" for the price of the massage and oral sex and sexual intercourse
24 for an additional \$200.00. In November 2022, The King County Sherriff's
25 Office took a report from the owner of one of building where the EMTAGES
26 lease space to run one of their businesses. The EMTAGES had called her to
27 complain that there may be rodents in the building. The owner reported that
28 she went to the business with an exterminator she discovered Jing and Gerald
29 had put up an unpermitted wall to separate the front and back of the Spa and
30 turned the back into an apartment with a kitchen, bathroom with a shower, and
31 a bedroom. When the property owner asked Jing how many people lived there,
32 Jing said "just one." The property owner explained to the deputy that they
33 wanted to make sure there was a record showing they were unaware of the
34 unpermitted alterations to the building or the possible nefarious activity
35 prior to that inspection so he wouldn't get in trouble for whatever Jing and
36 Gerald were doing.

37 During the undercover operations inside each of the businesses
38 detectives observed appeared to be 2-3 women working in each location at any
39 given time. In some instances, detectives were able to hear what sounded
40 like sexual services being performed in adjoining rooms. Detectives also
41 obtained evidence through this investigation indicating that the women that
42 work in these businesses also reside there. In some instances, they observed
43 what appeared to be residential accommodations. In one instance, on
44 04/14/2022 a burglary was reported at GARDEN SPA, located in Burien. The
45 KCSO that responded to take a report noted in his documentation that it
46 appeared that the women were living in the business. While conducting
47 surveillance of some of the business locations at closing time they did not
48 observe any of the female employees leaving the business after work.

49 Detectives also conducted extensive surveillance the listed business
50 locations as well as of both Jing and Jerry EMTAGE. They frequently saw the
51 EMTAGES delivering supplies to the businesses. They watched on several
52 occasions as Jing EMTAGE transported women from one business to another, on

each occasion the woman being transported had suitcases or bags with her and sat in the back seat of Jing's vehicle even when there was no front seat passenger. Detectives also observed Jing Emtage transport one woman from SeaTac International Airport to the SPORTS MASSAGE business in Burlington. Shortly after an Undercover detective went inside to conduct an undercover operation and recognized the woman assigned to provide his massage as the woman who had just come from the airport. She explained to the detective that she had just flown in from California. They also observed through various surveillance methods, Jing Emtage travel to several of the business locations followed immediately by her making banking transactions. Records from the EMTAGE'S Bank of America and Chase accounts were obtained and reviewed pursuant to search warrant. Those records were provided to an Intelligence Analyst (IA) who has works with law enforcement in an intelligence analysis role, with an emphasis on financial investigations, IA provided the following information:

Bank of America account xxxx is the primary business account for J&J Relax Spa. A merchant account is a type of commercial bank account that enables businesses to make, accept, and process credit and debit card payments. Once a customer makes a purchase, the funds are initially deposited in the merchant account before eventually being transferred to the business bank account. In this case, deposits range from daily to occasionally multiple times per day. The total merchant deposits from January 1, 2021 through December 31, 2022 was approximately \$1,139,421.63.

In addition to bank statements, Chase Bank provided documentation regarding cash exchanges that were conducted utilizing three different Chase account numbers. Chase Bank requires the customer to have an account at the institution in order to process a cash exchange. The accounts utilized were x1822, x8833 and x8660. A cash exchange can be completed in a number of different ways, however in this case, a cash exchange is a financial transaction that is conducted when a customer (EMTAGE) requests that small denomination U.S. currency be converted to large denomination U.S. currency. From April 17, 2020 through December 8, 2022, cash exchanges in the amount of \$539,965.00 were completed. Based upon the records provided, it is believed that this case was not deposited into any known financial institutions.

In November, 2022 Customs and Border Protection lawfully took custody of Jing's EMTAGES'S phone at a border crossing. The phone was later transferred into the King County Sheriff's Office custody and a search warrant was obtained and issued by a King County Superior Court for the search of this phone on 12/06/2022. I later reviewed the WhatsApp conversation between Gerald "Jerry" and Jing EMTAGE on Jing's phone. The name for Jing on this conversation is "Jing Jing" and the name for Gerald is "Artistic Upholstery & Restoration." Both confirmed their identity via photographs exchanged with one another and other basic conversations.

During the last year, Jing and Gerald had extensive conversations via text message about J&J RELAX SPA LLC owned storefronts. While Jing was out of the county in June and July of 2022, Gerald took over the daily responsibilities. According to the messages Gerald transported employees from storefront to storefront, picked up employees at the airport and collected money from the businesses. He also made deliveries of items such as condoms and KY lubricant. They had conversations about what needed to be accomplished for day as well as conversations about Jerry collecting money

1 from some of the storefront locations and transporting workers from the
2 airport to a storefront and between storefronts. These conversations were
3 consistent with surveillance observations of Jing's day-to-day business
4 routine. Gerald and Jing also discussed the purchasing of additional
5 storefronts, including one in Portland in August of 2022. Gerald told Jing no
6 to purchasing the storefront in Portland because it was 4.5 hours away. In
7 the same conversation Gerald suggested to Jing she open more around the
8 Everett area.

9 Also, on Jing EMTAGE'S phone, there were a number of text
10 communications in Mandarin on the WeChat App. The conversations were
11 provided to a Mandarin speaking analyst at the Washington State Patrol Fusion
12 Center. By way of example, in one conversation Jing EMTAGE convinced an
13 individual going by the name of "Sunny" to come to Washington State to work
14 in her businesses. She promised that the woman would make up to one thousand
15 dollars a day. From the conversation it appears that "Sunny" did in fact
16 come to work for the EMTAGES in the fall of 2022 and soon learned that the
17 promise of thousands of dollars was not accurate. She asked to be
18 transferred to another of the EMTAGE'S locations but it appears that the
19 promise of more money did not come to fruition and "Sunny" accused Jing
20 Emtage of being dishonest.

21 On 01/10/2023, the EMTAGES purchased a newly constructed single-family
22 residence in Burien for \$1,240,000.

23 On April 14, 2023, myself and Detective Grotzky learned that Jing and
24 Gerald EMTAGE were at SeaTac Airport preparing to board a flight to Honolulu,
25 Hawaii. Prior to leaving for Hawaii the EMTAGES visited two of their
storefront operations and made a trip to the bank. We were able to purchase
tickets for the flight and followed them to Hawaii. After we deplaned, we
observed the EMTAGES being picked up by an Asian female and were transported
directly to a storefront massage business. Detectives from the Honolulu
Police Department assisted with surveillance and observed them enter the
business.

Over the next two days myself and Detective Grotzky observed the
EMTAGE'S at the massage business for several hours each day. We observed
Gerald EMTAGE going in and out of the business as if inspecting the location.
I conducted an undercover operation at the massage business. When I entered
the business I was greeted by the woman who transported the EMTAGES from the
Airport and who they had met with there the previous day. We negotiated a
price for a massage as she escorted me to a room. A short time later the
first female brought in a second Asian female and informed me that the second
female would take good care of me. Toward the end of the massage session the
second female offered to allow me to digitally penetrate her, when I declined
she offered me manual stimulation of my genitals, which I also declined.
Throughout our contact this woman appeared to speak little English and
appeared to be very apprehensive. Jing and Gerald EMTAGE returned to Seattle
on April 18, 2023. Since that time detectives have continued surveillance
and they appear to be conducting business as usual.

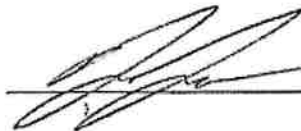
On May 2, 2023, Gerald and Jing Emtage were taken into custody and
search warrants were served on the above listed businesses as well as the
EMTAGES residence. Detectives recovered over \$600,000 in United States
currency at the businesses and residence. Much of the currency located at

1 the EMTAGE residence was found concealed in upholstered furniture. It should
2 be noted that Gerald EMTAGE owns and operates a custom upholstery business.
3 Detectives serving the warrant at the EMTAGE residence also located several
4 bank documents associated with overseas bank accounts. They also located a
5 check book for a bank in Hawaii with the account in the name of Gerald and
6 Jing EMTAGE. The address listed on the check comes back to a home in Hawaii,
7 which according to Zillow is worth over \$1.1 million.

8 The investigation in this case revealed that Gerald and Jing EMTAGE,
9 lead an organized business enterprise operating and facilitating and
10 profiting from an extensive illicit massage and prostitution business out of
11 the above listed storefront locations. As detailed above, Jing EMTAGE
12 recruited and retained women to work in their businesses. The EMTAGE'S
13 transported women from the airport to various store fronts as well as moving
14 women between their storefront locations. They have also been observed
15 delivering food and supplies to the businesses and text messages document
16 deliveries of items used in commercial sex work such as condoms and
17 lubricant. It appears that the women working in these businesses live on the
18 premises. Previously obtained bank and State records and the amount of
19 currency recovered during the service of the search warrants demonstrate that
20 the EMTAGE'S have moved substantial quantities of money through the bank
21 accounts associated with their business venture and in cash while not
22 disclosing income to the state or reporting any wages paid to their
23 employees.

24 Under penalty of perjury under the laws of the State of Washington, I certify
25 that the foregoing is true and correct.
