Councilmember Vaughan asked why the sales tax rate was 9.1% on this. Grant Weed thought that it might be a result of the City purchasing off the State's contract. Sandy Langdon concurred. She added that there is an administrative fee that is added by the State on top of the tax rate. Paul Roberts indicated he would look into this and get back to Council with the information.

15. Authorize Mayor to Sign Purchase Order No. F 4458 in the Amount of \$298,133.34 to Purchase a New Vactor Truck.

Public Works Director Paul Roberts explained that these trucks take a long time to deliver and are critical long lead items.

16. Authorize Mayor to Sign Local Agency Detour Agreement for WSDOT SR9 (108th Street N.E.) Improvement Project.

Director Roberts discussed the Detour Agreement and the ramifications of the closure of 108<sup>th</sup>. He noted that WSDOT's construction will coincide with some of the City's own construction projects in June through August of 2007. There will need to be some careful planning and coordination of detour routes.

Director Roberts explained that this is the next step in the AMR and involves installing 3000 meters. Staff is pleased that the bid came in under the budgeted amount.

Director Roberts explained that these agreements need to be signed in order to receive money for the TIB for these two projects.

19. Professional Service Agreement for Solid Waste Rate Study and Efficiency Review; Financial Consultant Solution Group (FCS).

Director Roberts reviewed this item. Councilmember Soriano wondered if the review would be more than just interviews. Director Roberts assured him that they will be looking at comparisons with other solid waste service providers and will examine details such as route pickups, time involved and how they are organized to address operations. Chief Administrative Officer Swenson explained that they began this process with some of those interviews Councilmember Soriano was referring to, but this will be the next phase.

Councilmember Seibert explained how Snohomish County benefited from a review of this type of information. He added that they need to be sure to look at efficiencies related to how the waste is dumped. Director Roberts concurred. He noted that increased traffic congestions and increased size of the City are also factors.

- Mayor Kendall asked Director Roberts if they were doing work at the reservoir at Highway 9 and 528 because it looks like there has been some construction activity there. Mr. Roberts did not recall any work scheduled there, but said he would check.
- Mayor Kendall commended Public Works for keeping the streets sanded during the icy weather.
- Chief Turner announced that the Marysville Dispatch has officially ended and did so without incident. SnoPac is now handling all the fire and police calls for the City.

Grand Weed said he had a few items to discuss in Executive Session.

- Mary Swenson was pleased to announce that the Palmer House sale is completed. The dispatchers had a difficult transition, but did it in a professional manner. All of the dispatchers will be staying with the City in other positions.
- Lakewood Crossing is really coming along. They are working with WSDOT on traffic issues up there.
- The Golf Manager position has been advertised and is now closed. They are hoping to do interviews as soon as possible.
- She had four personnel items and one real estate matter for Executive Session. She estimated that they would need 20 minutes for these items.

Councilmember Soriano commented that the recommendation is essentially guidelines and there is much room for variance. Councilmember Vaughan concurred. He commended the input that went into this and the consultant for doing a good job with conceptualization.

Councilmember Rasmussen stated that she really enjoyed seeing this vision. She felt it was very well done. She asked about the gateway at 88<sup>th</sup> Street and I-5. Since this is an important gateway she was wondering why it was smaller than the others. Community Development Director Gloria Hirashima commented that they had viewed some gateways as more urgent because of new development. Additionally, there was a concern that there wasn't very much right of way at 88<sup>th</sup> so they had chosen to look at something more vertical for that area. Councilmember Vaughan added that they also had to consider the sight distance as drivers come off the freeway.

Councilmember Rasmussen then referred to the proposal for the gateway at State Avenue and the bridge. She suggested designing something that actually attached to the bridge. Director Hirashima said that they had discussed that and it looked like they would be doing that.

Director Hirashima noted that Makers would be doing a presentation at the next meeting as well as any committee members who would like a chance to address the

Council. Their recommendation is to implement the gateways over time via developer incentives, regular maintenance/replacement of signs, and construction by the City's own sign shop. A total of ten gateways were suggested. Mayor Kendall had also recommended adding SR 92 and Highway 9.

Councilmember Seibert asked where the sign would be at 4<sup>th</sup> and State. Ms. Hirashima replied that it would be on the southeast corner. Councilmember Seibert recommended keeping the signs up high to avoid accidents and vandalism.

Councilmember Seibert asked if they would be using the City's existing logo. Director Hirashima explained that they had tried to capture essential elements from the logo and incorporate it into this. They tried to minimize what was on the signage to simplify it. Councilmember Seibert felt that that was fine on the larger signs, but thought that the logo should be on the smaller signs. Councilmember Vaughan explained that the existing logo is very difficult to see on a directional sign. That is why the developers had taken elements from it and used those. Gloria Hirashima added that the simplified elements allowed for better readability. Councilmember Seibert concurred. He expressed appreciation for the hard work that went into this.

Mayor Pro Tem Nehring commented that the likes the idea proposed for Comeford Park since this is such an important location for the residents of the City. He questioned the high price of the reader board. Ms. Hirashima informed him that it was accurate and that they are very expensive.

Councilmember Seibert suggested making the reader board large enough to be readable for cars or small enough not to be a distraction for cars since they would probably try to read it.

Councilmember Rasmussen suggested using Homeland Security money for a reader board since it could be useful in an emergency situation.

The Hearing Examiner (Examiner) made a site familiarization visit on June 3, 2005

The Department of Planning and Development Services (PDS) gave proper public notice of the open record hearing as required by the county code. (Exhibits 23, 24 and 25)

A SEPA determination was made on May 5, 2005. (Exhibit 22) No appeal was filed.

The Examiner held an open record hearing on June 8, 2005, the 157th day of the 120-day decision making period. Witnesses were sworn, testimony was presented, and exhibits were entered at the hearing.

#### **PUBLIC HEARING**

The public hearing commenced on June 8, 2005 at 1:06 p.m.

- 1. The Examiner announced that he had read the PDS staff report, reviewed the file and viewed the area and therefore was generally apprised of the particular request involved.
- 2. The applicant, L44-1 Baileys, LLC, was represented by Malcolm McNaughton. Snohomish County was represented by Bob Pemberton of the Department of Planning and Development Services and by Andy Smith of the Department of Public Works.
- 3. By document dated July 27, 2004, Philip Chris Gibson of Marysville expresses opposition to any further vehicular traffic in the subject vicinity, especially in view of the potential NASCAR track and expansion on Tulalip Tribal lands. In his opinion, "...Marysville is headed for local gridlock that will rival most anything in Puget Sound."
- 4. The hearing concluded at 1:16 p.m.

# FINDINGS, CONCLUSIONS AND DECISION

#### FINDINGS OF FACT

Based on all the evidence of record, the following findings of fact are entered.

- 1. The master list of exhibits and witnesses which is a part of this file and which exhibits were considered by the Examiner is hereby made a part of this file as if set forth in full herein.
- 2. The PDS staff report has correctly analyzed the nature of the application, the issues of concern, the application's consistency with adopted codes and policies and land use regulations, and the State Environmental Policy Act (SEPA). That staff report is hereby adopted (as amended by the Examiner) as if set forth in full herein.
- 3. The request is for a subdivision of approximately 65.21 acres into 182 single family lots using lot size averaging pursuant to SCC 30.23.210. The proposed subdivision is within the City of Marysville UGA but outside the corporate boundaries of the City of Marysville. Specifically, the subject site is on the east side of 83<sup>rd</sup> Avenue NE, opposite 77<sup>th</sup> Street NE, immediately east of the Marysville City limits.
- The project would comply with park mitigation requirements under Chapter 30.66A SCC (Title 26A SCC) by the payment of \$1,040.00 for each new single-family home. Other per lot fees are for (1) impacts on County roads, (2) transportation demand management, (3) impacts to City of Marysville Streets, (4) impacts to City of Arlington Streets, (5) impacts to State highways. The transportation-related fees alone total roughly three-quarters of a million dollars (\$706,000.).
- 5. The DPW reviewed the request with regard to traffic mitigation and road design standards. This review covered Title 13 SCC and Chapter 30.66B SCC (Title 26B SCC) as to road system capacity, concurrency, inadequate road conditions, frontage improvements, access and circulation, and dedication/deeding of right-of-way, state highway impacts, impacts on other streets and roads, and Transportation Demand Management. As a result of this review, the DPW has determined that the development is concurrent and has no objection to the requests subject to various conditions.
- 6. School mitigation requirements under Chapter 30.66C SCC (Title 26C SCC) have been reviewed and set forth in the conditions.
- 7. The subject site contains eight wetlands (two Category 4 and six Category 3) and two streams (both Type 5). A ditch and sidecasting along the south property boundary is in violation of Snohomish County grading regulations. The ditch crosses 650 feet of wetlands and wetland buffers. The ditch varies in width from 5 feet to 10 feet and in depth from 4 feet to 10 feet. To resolve the violation, the ditch must be filled to original grade using existing sidecast material as much as possible. The restored area and any disturbed areas are to be replanted with native trees and shrubs as specified in the mitigation plan. (See Exhibit 8.)

- 8. The PDS Engineering Division has reviewed the concept of the proposed grading and drainage and recommends approval of the project subject to conditions, which would be imposed during full detailed drainage plan review pursuant to Chapter 30.63A SCC (Title 24 SCC).
- 9. to infilte: Snohomish County Health District has no objection to this proposal provided that public water and a more several power owill be available for this development.
- 10. The property is designated Urban Low Density Residential (ULDR 4-6 du/ac) on the General Policy Plan (GPP) Future Land Use Map (FLUM) and is located within an Urban Growth Area (UGA. Land in this category may be developed at a density of 4-6 du/ac and one of the implementing zones is the R-9,600 zone which is the case here.
- 11. The proposed use (single-family detached development) is essentially compatible with existing single-family detached developments on larger lots. Because the property is within a UGA, policies were adopted to promote urban densities of development. A comparison with the present lower density character of much of the area is inappropriate since the present density of development in much of the surrounding area is inconsistent with both the adopted comprehensive plans and the present zoning.
- 12. Water and sewer utilities for the proposed plat have been conditionally approved by the City of Marysville. The conditions are: (1) the applicant must construct an off-site sewer system, including frontage along 83<sup>rd</sup> Avenue, (2) the applicant must submit a 60% annexation petition prior to utility connection, and (3) the applicant must submit a valid Annexation covenant and Power of Attorney prior to utility connection.
- 13. The request complies with the Snohomish County Subdivision Code, Chapter 30.41A SCC (Title 19 SCC) as well as the State Subdivision Code, RCW 58.17. The proposed plat complies with the established criteria therein and makes the appropriate provisions for public, health, safety and general welfare, for open spaces, drainage ways, streets or roads, alleys, other public ways, transit stops, potable water supplies, sanitary wastes, parks and recreation, playgrounds, schools and school grounds, and other planning features including safe walking conditions for students.
- 14. The proposal has been evaluated by PDS for compliance with the lot size averaging provisions of 30.41A.240 and SCC 30.23.210. This proposal is consistent with these provisions.
- 15. The request is consistent with Section 30.70.100 SCC (Section 32.50.100 SCC), which requires, pursuant to RCW 36.70B.040, that all project permit applications be consistent with the GMACP, and GMA-based county codes.
- 16. Any finding of fact in this decision which should be deemed a conclusion is hereby adopted as such.

#### **CONCLUSIONS OF LAW**

Based on the findings of fact entered above, the following conclusions of law are entered.

1. The Examiner having fully reviewed the PDS staff report, hereby adopts said staff report as properly setting forth the issues, the land use requests, consistency with the existing regulations, policies, principles, conditions and their effect upon the request. It is therefore hereby adopted by the Examiner (as amended by the Examiner) as a conclusion as if set forth in full herein, in order to avoid needless repetition.

- 2. The Department of Public Works recommends that the request be approved as to traffic use subject to conditions specified below herein.
- 3. The request is consistent with the GMACP, GMA-based County codes; and the type and character of .? land use permitted on the site and the permitted density with the applicable design and development standards.
- 4. The conclusions of law above herein are entered with awareness of the public concerns expressed in this record. However, the higher density infill in lieu of sprawl implements the applicable law and policies.
- 5. The request should be approved subject to compliance by the applicant with the following conditions:

#### **CONDITIONS**

- A. The preliminary plat received by the Department of Planning and Development Services on March 24, 2005 (Exhibit 17) shall be the approved plat configuration. Changes to the approved plat are governed by SCC 30.41A.330.
- B. Prior to initiation of any further site work; and/or prior to issuance of any development/construction permits by the County:
  - i. All site development work shall comply with the requirements of the plans and permits approved pursuant to Condition A, above.
  - The plattor shall mark with temporary markers in the field the boundary of all Native Growth Protection Areas (NGPA) required by Chapter 30.62 SCC, or the limits of the proposed site disturbance outside of the NGPA, using methods and materials acceptable to the County.
  - iii. A final mitigation plan based on the Conceptual Mitigation Report prepared by The Jay Group received July 2, 2004 (Exhibit 8) and Addendum to the Conceptual Mitigation Report prepared by the Jay Group dated December 30, 2004 (Exhibit 13) shall be submitted for review and approval during the construction review phase of this project.
- C. The following additional restrictions and/or items shall be indicated on the face of the final plat:
  - "The lots within this subdivision will be subject to school impact mitigation fees for Marysville School District No. 25 to be determined by the certified amount within the Base Fee Schedule in effect at the time of building permit application, and to be collected prior to building permit issuance, in accordance with the provisions of SCC 30.66C.010. Credit shall be given for four existing parcels."
  - ii. Chapter 30.66B SCC requires the new lot mitigation payments in the amounts shown below for each single-family residential building permit:
    - \$1,961.85 per lot for mitigation of impacts on county roads paid to the County, \$75.75 per lot for transportation demand management paid to the County,

\$1,245.94 per lot for mitigation of impacts on the City of Marysville streets paid to the City. Proof of payment shall be provided.

\$209.68 per lot for mitigation of impacts on the City of Arlington streets paid to the City. Proof notineed being payment is required to the City of Arlington streets paid to the City. Proof

\$2.51 per lot for mitigation of impacts on state highways paid to the County. (WSDOT ID#DOT-22 - SR9/SR 528 intersection signalization)

The developer of this subdivision has elected to defer these payment obligations to a time preceding building permit issuance. Notice of these mitigation payment obligations shall be contained in any deeds involving this subdivision or the lots therein. Once a building permit has been issued all mitigation payments for that lot shall be deemed paid.

iii. All Critical Areas shall be designated Native Growth Protection Areas (NGPA) (unless other agreements have been made) with the following language on the face of the plat;

"All NATIVE GROWTH PROTECTION AREAS shall be left permanently undisturbed in a substantially natural state. No clearing, grading, filling, building construction or placement, or road construction of any kind shall occur, except removal of hazardous trees. The activities as set forth in SCC 32.10.110(29)(a), (c), and (d) are allowed when approved by the County."

#### D. Prior to recording of the final plat:

- i. The developer shall pay the County \$1,040.00 per new dwelling unit as mitigation for parks and recreation impacts in accordance with Chapter 30.66A SCC; provided, however, the developer may elect to postpone payment of the mitigation requirement until issuance of a building permit for that lot. The election to postpone payment shall be noted by a covenant placed on the face of the recorded plat and included in the deed for each affected lot within the subdivision.
- ii. Frontage improvements shall have been constructed to the specifications of the City of Marysville. The final lift of paving for the frontage improvements may be bonded per the City of Marysville codes and policies.
- iii. Native Growth Protection Area boundaries (NGPA) shall have been permanently marked on the site prior to final inspection by the County, with both NGPA signs and adjacent markers which can be magnetically located (e.g.: rebar, pipe, 20 penny nails, etc.). The plattor may use other permanent methods and materials provided they are first approved by the County. Where an NGPA boundary crosses another boundary (e.g.: lot, tract, plat, road, etc.), a rebar marker with surveyors' cap and license number must be placed at the line crossing.

NGPA signs shall have been placed no greater than 100 feet apart around the perimeter of the NGPA. Minimum placement shall include one Type 1 sign per wetland, and at least one Type 1 sign shall be placed in any lot that borders the NGPA, unless otherwise approved by the County biologist. The design and proposed locations for the NGPA signs shall be submitted to the Land Use Division for review and approval prior to installation.

- iv. The final wetland mitigation plan shall be completely implemented.

- F. All development activity shall conform to the requirements of Chapter 30.63A SCC.

Nothing in this permit/approval excuses the applicant, owner, lessee, agent, successor or assigns from compliance with any other federal, state or local statutes, ordinances or regulations applicable to this project.

Preliminary plats which are approved by the county are valid for five (5) years from the date of approval and must be recorded within that time period unless an extension has been properly requested and granted pursuant to SCC 30.41A.300.

6. Any conclusion in this decision which should be deemed a finding of fact is hereby adopted as such.

#### DECISION

Based on the findings of fact and conclusions of law entered above, the decision of the Hearing Examiner on the application is as follows:

The request for a preliminary plat for a 182 lot subdivision utilizing lot size averaging provisions is hereby CONDITIONALLY APPROVED, subject to the conditions set forth in Conclusion No. 5 above.

## EXPLANATION OF RECONSIDERATION AND APPEAL PROCEDURES

The decision of the Hearing Examiner is final and conclusive with right of appeal to the County Council. However, reconsideration by the Examiner may also be sought by one or more parties of record. The following paragraphs summarize the reconsideration and appeal processes. For more information about reconsideration and appeal procedures, please see Chapter 30.72 SCC and the respective Examiner and Council Rules of Procedure.

#### Reconsideration

Any party of record may request reconsideration by the Examiner. A petition for reconsideration must be filed in a writing with the Office of the Hearing Examiner, 2nd Floor, County Administration East Building 3000 and Rockefeller Avenue, Everett, Washington, (Mailing Address: M/S #405; 3000 Rockefeller Avenue Exercit WA 2nd 98201) on or before JULY 5, 2005. There is no fee for filing a petition for reconsideration of the petitioner for reconsideration shall mail or otherwise provide a copy of the petition for reconsideration to all parties of record on the date of filing." [SCC 30.72.065]

A petition for reconsideration does not have to be in a special form but must: contain the name, mailing address and daytime telephone number of the petitioner, together with the signature of the petitioner or of the petitioner's attorney, if any; identify the specific findings, conclusions, actions and/or conditions for which reconsideration is requested; state the relief requested; and, where applicable, identify the specific nature of any newly discovered evidence and/or changes proposed by the applicant.

The grounds for seeking reconsideration are limited to the following:

- (a) The Hearing Examiner exceeded the Hearing Examiner's jurisdiction;
- (b) The Hearing Examiner failed to follow the applicable procedure in reaching the Hearing Examiner's decision;

- (f) The applicant proposed changes to the application in response to deficiencies identified in the decision.

#### Appeal

An appeal to the County Council may be filed by any aggrieved party of record. Where the reconsideration process of SCC 30.72.065 has been invoked, no appeal may be filed until the reconsideration petition has been disposed of by the hearing examiner. An aggrieved party need not file a petition for reconsideration but may file an appeal directly to the County Council. If a petition for reconsideration is filed, issues subsequently raised by that party on appeal to the County Council shall be limited to those issues raised in the petition for reconsideration. Appeals shall be addressed to the Snohomish County Council but shall be filed in writing with the Department of Planning and Development Services, 2<sup>nd</sup> Floor, County Administration-East Building, 3000 Rockefeller Avenue, Everett, Washington (Mailing address: M/S #604, 3000 Rockefeller Avenue, Everett, WA 98201) on or before JULY 7, 2005 and shall be accompanied by a filing fee in the amount of five hundred dollars (\$500.00); PROVIDED, that the filing fee shall not be charged to a department of the County or to other than the first appellant; and PROVIDED FURTHER, that the filing fee shall be refunded in any case where an appeal is dismissed without hearing because of untimely filing, lack of standing, lack of jurisdiction or other procedural defect. [SCC 30.72.070]

An appeal must contain the following items in order to be complete: a detailed statement of the grounds for appeal; a detailed statement of the facts upon which the appeal is based, including citations to specific Hearing Examiner findings, conclusions, exhibits or oral testimony; written arguments in support of the appeal; the name; a mailing address and daytime telephone number of each appellant; together with the signature of at least one of the appellant or of the appellant or of the appellant's agent or representative, if any; and the required filing fee:





#### **Summary:**

Funds have been dedicated within the 2007 budget for frontage and access improvements to Jennings Memorial Park. The Jay Group of Marysville, Washington has been selected to provide Landscape Design services for the project. # PROFESSIONAL SERVICES AGREEMENT BETWEEN CITY OF MARYSVILLE AND THE JAY GROUP FOR CONSULTING SERVICES FOR LANDSCAPE DESIGN Jennings Memorial Park

THIS AGREEMENT, made and entered into in Snohomish County, Washington, by and between CITY OF MARYSVILLE, hereinafter called the "City," and JAY GROUP, a Washington corporation, hereinafter called the "Consultant."

WHEREAS, the Consultant has represented, and by entering into this Agreement now represents, that the firm and all employees assigned to work on any City project are in full compliance with the statutes of the State of Washington governing activities to be performed and that all personnel to be assigned to the work required under this agreement are fully qualified and properly licensed to perform the work to which they will be assigned.

NOW, THEREFORE, in consideration of the terms, conditions, covenants and performances contained hereinbelow, the parties hereto agree as follows:

#### ARTICLE I. PURPOSE

The purpose of this agreement is to provide the City with Consulting services to provide Landscape Design Services for Jennings Memorial Park as described in Article II. The general terms and conditions of relationships between the City and the Consultant are specified in this agreement.

#### ARTICLE II. SCOPE OF WORK

The scope of work is set out in the attached Estimate of Professional Services for the General Sewer Plan Amendment, hereinafter referred to as the "scope of services," **Exhibit A**. All services and materials necessary to accomplish the tasks outlined in **Exhibit A** shall be provided by the Consultant unless noted otherwise in the scope of services or this agreement.

#### ARTICLE III. OBLIGATIONS OF THE CONSULTANT

III.1 MINOR CHANGES IN SCOPE. The Consultant shall accept minor changes, amendments, or revision in the detail of the work as may be required by the City when such

changes will not have any impact on the service costs or proposed delivery schedule. Extra work, if any, involving substantial changes and/or changes in cost or schedules will be addressed as follows:

**Extra Work**. The City may desire to have the Consultant perform work or render services in connection with each project in addition to or other than work provided for by the expressed intent of the scope of work in the scope of services. Such work will be considered as extra work and will be specified in a written supplement to the scope of services, to be signed by both parties, which will set forth the nature and the scope thereof. All proposals for extra work or services shall be prepared by the Consultant at no cost to the City. Work under a supplemental agreement shall not proceed until executed in writing by the parties.

III.2 **WORK PRODUCT AND DOCUMENTS**. The work product and all documents listed in the scope of services shall be furnished by the Consultant to the City, and upon completion of the work shall become the property of the City, except that the Consultant may retain one copy of the work product and documents for its records. The Consultant will be responsible for the accuracy of the work, even though the work has been accepted by the City.

In the event that the Consultant shall default on this agreement or in the event that this contract shall be terminated prior to its completion as herein provided, all work product of the Consultant, along with a summary of work done to date of default or termination, shall become the property of the City. Upon request, the Consultant shall tender the work product and summary to the City. Tender of said work product shall be a prerequisite to final payment under this contract. The summary of work done shall be prepared at no additional cost to the City.

Consultant will not be held liable for reuse of these documents or modifications thereof for any purpose other than those authorized under this Agreement without the written authorization of Consultant.

- III.3 **TIME OF PERFORMANCE**. The Consultant shall be authorized to begin work under the terms of this agreement upon signing of both the scope of services and this agreement and shall complete the work within 120 days, unless a mutual written agreement is signed to change the schedule. An extension of the time for completion may be given by the City due to conditions not expected or anticipated at the time of execution of this agreement.
- III.4 **NONASSIGNABLE**. The services to be provided by the Consultant shall not be assigned or subcontracted without the express written consent of the City.
- III.5 **EMPLOYMENT**. Any and all employees of the Consultant, while engaged in the performance of any work or services required by the Consultant under this agreement, shall be considered employees of the Consultant only and not of the City, and any and all claims that may or might arise under the Workman's Compensation Act on behalf of any said employees while so engaged, and any and all claims made by any third party as a consequence of any negligent act or omission on the part of the Consultant or its employees while so engaged in any

of the work or services provided herein shall be the sole obligation of the Consultant.

#### III.6 INDEMNITY.

- a. The Consultant will at all times indemnify and hold harmless and defend the City, its elected officials, officers, employees, agents and representatives, from and against any and all lawsuits, damages, costs, charges, expenses, judgments and liabilities, including attorney's fees (including attorney's fees in establishing indemnification), collectively referred to herein as "losses" resulting from, arising out of, or related to one or more claims arising out of negligent acts, errors, or omissions of the Consultant in performance of Consultant's professional services under this agreement. The term "claims" as used herein shall mean all claims, lawsuits, causes of action, and other legal actions and proceedings of whatsoever nature, involving bodily or personal injury or death of any person or damage to any property including, but not limited to, persons employed by the City, the Consultant or other person and all property owned or claimed by the City, the Consultant, or affiliate of the Consultant, or any other person.
- b. Should a court of competent jurisdiction determine that this agreement is subject to RCW 4.24.115, then, in the event of liability for damaging arising out of bodily injury to persons or damages to property caused by or resulting from the concurrent negligence of the Consultant and the City, its members, officers, employees and agents, the Consultant's liability to the City, by way of indemnification, shall be only to the extent of the Consultant's negligence.
- c. The provisions of this section shall survive the expiration or termination of this agreement.

#### III.7 INSURANCE.

- a. **Minimum Limits of Insurance**. The Consultant shall, before commencing work under this agreement, file with the City certificates of insurance coverage to be kept in force continuously during this agreement, and during all work performed pursuant to all short form agreements, in a form acceptable to the City. Said certificates shall name the City as an additional named insured with respect to all coverages except professional liability insurance. The minimum insurance requirements shall be as follows:
  - (1) <u>Comprehensive General Liability</u>. \$1,000,000 combined single limit per occurrence for bodily injury personal injury and property damage; damage, \$2,000,000 general aggregate;
  - (2) <u>Automobile Liability</u>. \$300,000 combined single limit per accident for bodily injury and property damage;

- (3) <u>Workers' Compensation</u>. Workers' compensation limits as required by the Workers' Compensation Act of Washington;
- (4) <u>Consultant's Errors and Omissions Liability</u>. \$1,000,000 per occurrence and as an annual aggregate.
- b. **Endorsement**. Each insurance policy shall be endorsed to state that coverage shall not be suspended, voiced, canceled, reduced in coverage or in limits except after thirty (30) days' prior written notice by certified mail, return receipt requested, has been given to the City.
- c. **Acceptability of Insurers**. Insurance to be provided by Consultant shall be with a Bests rating of no less than A:VII, or if not rated by Bests, with minimum surpluses the equivalent of Bests' VII rating.
- d. **Verification of Coverage**. In signing this agreement, the Consultant is acknowledging and representing that required insurance is active and current.
- OPPORTUNITY LEGISLATION. The Consultant agrees to comply with equal opportunity employment and not to discriminate against client, employee, or applicant for employment or for services because of race, creed, color, religion, national origin, marital status, sex, age or handicap except for a bona fide occupational qualification with regard, but not limited to, the following: employment upgrading; demotion or transfer; recruitment or any recruitment advertising; layoff or terminations; rates of pay or other forms of compensation; selection for training, rendition of services. The Consultant further agrees to maintain (as appropriate) notices, posted in conspicuous places, setting forth the provisions of this nondiscrimination clause. The Consultant understands and agrees that if it violates this nondiscrimination provision, this agreement may be terminated by the City, and further that the Consultant will be barred from performing any services for the City now or in the future, unless a showing is made satisfactory to the City that discriminatory practices have been terminated and that recurrence of such action is unlikely.
- III.9 **UNFAIR EMPLOYMENT PRACTICES**. During the performance of this agreement, the Consultant agrees to comply with RCW 49.60.180, prohibiting unfair employment practices.
- III.10 **AFFIRMATIVE ACTION**. Affirmative action shall be implemented by the Consultant to ensure that applicants for employment and all employees are treated without regard to race, creed, color, sex, age, marital status, national origin or the presence of any sensory, mental or physical handicap, unless based on a bona fide occupational qualification. The Consultant agrees to take affirmative action to ensure that all of its employees and agent adhere to this provision.

- III.11 **LEGAL RELATIONS**. The Consultant shall comply with all federal, state and local laws and ordinances applicable to work to be done under this agreement. This contract shall be interpreted and construed in accordance with the laws of Washington. Venue for any action commenced relating to the interpretation, breach or enforcement of this agreement shall be in Snohomish County Superior Court.
- III.12 **INDEPENDENT CONTRACTOR**. The Consultant's relation to the City shall at all times be as an independent contractor.
- III.13 **CONFLICTS OF INTEREST.** While this is a non-exclusive agreement the Consultant agrees to and will notify the City of any potential conflicts of interest in Consultant's client base and will seek and obtain written permission from the City prior to providing services to third parties where a conflict of interest is apparent. If a conflict is irreconcilable, the City reserves the right to terminate this agreement.
- III.14 **CITY CONFIDENCES.** The Consultant agrees to and will keep in strict confidence, and will not disclose, communicate or advertise to third parties without specific prior written consent from the City in each instance, the confidences of the City or any information regarding the City or services provided to the City.

#### ARTICLE IV. OBLIGATIONS OF THE CITY

- IV.1 **PAYMENTS**. The Consultant shall be paid by the City for completed work for services rendered under this agreement and as detailed in the scope of services as provided hereinafter. Such payment shall be full compensation for work performed or services rendered and for all labor, materials, supplies, equipment and incidentals necessary to complete the work. Payment shall be on a time and expense basis, provided, however, in no event shall total payment under this agreement exceed \$7,500.00. In the event the City elects to expand the scope of services from that set forth in **Exhibit A**, the City shall pay Consultant an additional amount based on a time and expense basis, based upon Consultant's current schedule of hourly rates of \$61.75 per hour.
  - a. Invoices shall be submitted by the Consultant to the City for payment pursuant to the terms of the scope of services. The invoice will state the time expended, the hourly rate, a detailed description of the work performed, and the expenses incurred during the preceding month. Invoices must be submitted by the 20th day of the month to be paid by the 15th day of the next calendar month.
  - b. The City will pay timely submitted and approved invoices received before the 20th of each month within thirty (30) days of receipt.
- IV.2 **CITY APPROVAL**. Notwithstanding the Consultant's status as an independent contractor, results of the work performed pursuant to this contract must meet the approval of the City, which shall not be unreasonably withheld if work has been completed in compliance with the scope of work and City requirements.

#### ARTICLE V. GENERAL

V.1 **NOTICES**. Notices to the City shall be sent to the following address:

V.2 **TERMINATION**. The right is reserved by the City to terminate this agreement in whole or in part at any time upon ten (10) days' written notice to the Consultant.

If this agreement is terminated in its entirety by the City for its convenience, a final payment shall be made to the Consultant which, when added to any payments previously made, shall total the actual costs plus the same percentage of the fixed fee as the work completed at the time of termination applied to the total work required for the project.

- V.3 **DISPUTES**. The parties agree that, following reasonable attempts at negotiation and compromise, any unresolved dispute arising under this contract may be resolved by a mutually agreed-upon alternative dispute resolution of arbitration or mediation.
- V.4 **NONWAIVER**. Waiver by the City of any provision of this agreement or any time limitation provided for in this agreement shall not constitute a waiver of any other provision.

# INTERLOCAL COOPERATIVE AGREEMENT NORTHWEST MINICHAIN WITH MARYSVILLE

THIS AGREEMENT is made and entered into by and between the City of Marysville, Washington ("Marysville") and Whatcom County, Washington ("County") pursuant to the authority granted by Chapter 39.34 RCW, INTERLOCAL COOPERATION ACT.

#### 1. PURPOSE

The purpose of this agreement is to provide for transportation services for prisoners for Marysville for a period beginning on the First day of January, 2007 and ending on the Thirty-first day of December 2007. Marysville and Whatcom County agree to the terms and conditions incorporated herein.

#### RESPONSIBILITIES:

Prior to signing this agreement, Marysville has determined that there exists a public need for the services to be provided hereunder, and that it is appropriate that public funds be expended to meet this need.

Marysville acknowledges Whatcom County's operational control of its jail facilities and agrees that prisoners transported on the Northwest Mini-Chain van by Whatcom County will be subject to Whatcom County Jail policies and procedures.

Whatcom County covenants to perform the following transportation services:

Provide inmate transportation services via the Northwest Mini-Chain for the City of Marysville with at least one (1) trip per weekday, the time of which shall be mutually agreeable to the County and the City of Marysville, as follows:

- a) To pick up inmates from any Northwest Mini Chain contracted city or county jail along the I-5 corridor, with King County Jail being the southernmost point.
- b) Provide driver and vehicle to accomplish above transportation services. Schedules will be set up in advance by telephone.

#### 3. TERM OF AGREEMENT:

The term of this Agreement shall be from January 1, 2007 through December 31, 2007, regardless of date of signature.

The terms of this agreement shall be subject to review and revision in September of 2007 for renewal in January 2008.

#### 4. MANNER OF FINANCING:

Funds for the payment of services to be rendered under this Agreement have been budgeted, allocated and are available for this purpose. This agreement shall not obligate Marysville in excess of the balance of funds available for this purpose, nor shall it obligate Whatcom County to perform services, which are not budgeted. The source of funds is the City of Marysville budget.

Whatcom County shall provide Marysville with an invoice for services rendered on a quarterly basis. The Contract Number, set forth above, shall be included on all billings or correspondence in connection therewith.

This compensation is calculated on the actual percentage of usage by Marysville of the total cost of the Northwest Minichain Transport System, and as such will not require a quarterly breakdown of actual transports.

The representatives shall be responsible for administration of this Agreement and for coordinating and monitoring performance under or greater than this Agreement. In the event such representatives are changed, the party making the change shall notify the other party.
  - 5.1 The County's representative shall be the Whatcom County Executive, and Sheriff Bill Elfo
  - 5.2 Marysville's representative shall be <u>Commander Ralph Krusey</u>.
- 6. TREATMENT OF ASSETS AND PROPERTY: No fixed assets or personal or real property will be jointly or cooperatively, acquired, held, used, or disposed of pursuant to this Agreement.
- 7. INDEMNIFICATION: Each party agrees to be responsible and assume liability for its own wrongful and/or negligent acts or omissions or those of their officials, officers, agents, or employees to the fullest extent required by law, and further agrees to save, indemnify, defend, and hold the other party harmless from any such liability. It is further provided that no liability shall attach to the County by reason of entering into this contract except as expressly provided herein.
- 8. TERMINATION: Any party hereto may terminate this Agreement upon thirty (30) days notice in writing either personally delivered or mailed postage-prepaid by certified mail, return receipt requested, to the party's last known address for the purposes of giving notice under this paragraph. If this Agreement is so terminated, the parties shall be liable only for performance rendered or costs incurred in accordance with the terms of this Agreement prior to the effective date of termination.
- 9. CHANGES, MODIFICATIONS, AMENDMENTS AND WAIVERS: The Agreement may be changed, modified, amended or waived only by written agreement executed by the parties hereto. Waiver or breach of any term or condition of this Agreement shall not be

considered a waiver of any prior or subsequent breach. The term of this Agreement may be extended by mutual agreement of the parties; provided, however, that the Agreement is in writing and signed by both parties.

- 10. SEVERABILITY: In the event any term or condition of this Agreement or application thereof to any person or circumstances is held invalid, such invalidity shall not affect other terms, conditions or applications of this Agreement which can be given effect without the invalid term, condition, or application. To this end the terms and conditions of this Agreement are declared severable.
- 11. ENTIRE AGREEMENT: This Agreement contains all the terms and conditions agreed upon by the parties. All items incorporated herein by reference are attached. No other understandings, oral or otherwise, regarding the subject matter of this Agreement shall be deemed to exist or to bind any of the parties hereto.

Gateways are an urban design feature used to identify a sense of place and provide a defining element to a community. The purpose of the Gateway Master Plan is to provide guidance for public right of way treatment at key intersections throughout the City, ranging from the Lakewood neighborhood on the north, to the Sunnyside/Whiskey Ridge neighborhood on the City's southeastern edge.

The Marysville gateways will serve five primary purposes – civic pride, welcome, wayfinding, informational, and event advertisement. The Gateway committee, consisting of representatives from citizens, business, City Council, Planning Commission and city department staff worked with the consultant team of Makers, Inc and Nakano Associates to develop recommendations for gateway treatment at key city intersections. The draft plan reflects proposed signage and landscape concepts for 10 key intersections. The document identifies the purpose of each gateway and recommended designs for meeting these goals.

The draft plan includes many design details for implementation of the gateway master plan. Details including font type, size and color were included to ensure consistency of construction of the gateways. It is anticipated that the gateways will be installed in the future by a variety of means – development installations, civic group projects, and city installations. So, while the plan in most cases reflects preliminary design concepts, there is enough detail to ensure consistency in final design and construction.

# Introduction

# Why Gateways?

Gateways are a somewhat unique urban design feature given their ability to fulfill a variety of roles and purposes. In their most basic capacity they signify one's arrival into Marysville by identifying a sense of place, thereby providing a defining element for the community and a welcoming first impression for visitors. Gateways of this type are often achieved with signage, banners, art, or a unique urban design element, making them effective directional and wayfinding tools as well.

Other roles are slightly more subtle but equally important. Given their locations at major entry and exit points, gateways will frequently signify a welcome or change or transition. Whether it's a change in land uses, neighborhoods, special districts, or traffic speeds, the gateway can be a useful way to trigger a traveler's awareness of the situation and the implications.

The Marysville gateways identified in this Master Plan will serve five primary purposes. These include:

- · Civic pride
- Welcome
- · Wayfinding
- Informational
- Event advertisement

# Purpose of the Master Plan

The City of Marysville initiated the Gateway Master Plan because it saw an opportunity to create a cohesive plan that coordinates gateway features with other streetscape elements. The Master Plan is a framework of guidelines to be referred to during the design and implementation of both City and private developer projects. Specifically, this plan:

Identifies the location and purpose for ten gateway locations



- Offers a hierarchy of gateway elements with a cohesive design theme
- Provides a recommended palette of materials for the gateways, adjacent landscaping, and the streetscape
- Outlines the policies necessary to encourage implementation in a manner consistent with the Master Plan and the goals of the City's Comp Plan

#### **Process**

Development of the Gateway Master Plan utilized an interactive process involving regular meetings and workshops between the consultant team and an advisory committee of approximately fifteen local stakeholders. These stakeholders, which included City staff, business owners, and residents, were selected to serve as an advisory committee because they represented a wide range of interests and objectives. They were particularly helpful with identifying what elements best reflected the character and values of Marysville, as well as the specific purpose for each of the ten proposed gateway locations.

The planning process was initiated in July 2006 with a workshop that included the consultant team and advisory committee. During the workshop a series of gateway images from other communities were reviewed and evaluated by the advisory committee for their appropriateness and appeal in Marysville. Using the input provided during this first workshop, the consultant team developed a conceptual plan for various gateway elements. A second workshop was scheduled to review these conceptual designs and collect additional input from the advisory committee. Following the second workshop the consultant team



continued to refine the gateway concepts into a series of preferred design schemes, which were presented to the committee at a third and final workshop in November 2006. Input from the third workshop led to the development of this Master Plan.


Figure 1. Concept Images Generated Early in the Process

# **Proposed Gateways**

## Location

Ten locations were identified by the advisory committee as appropriate sites for a gateway feature. These sites are listed, illustrated, and described below. In addition to the eleven gateways, Comeford Park in downtown Marysville was also identified for additional urban design enhancements that correspond to the gateway design concepts.

# 1. 172<sup>nd</sup> Street NE and 27<sup>th</sup> Avenue NE

This site is on SR 531 (172<sup>nd</sup> St) one block west of I-5 and signifies the entrance into Lakewood, a neighborhood in Marysville. It is a high visibility location supporting heavy traffic volumes of both local and regional visitors.

# 2. Smokey Point Blvd at North City Limit

This site is a major entrance to Marysville from the north. It is used regularly by local residents and provides good access to downtown.

## 3. 116th Street NE and I-5

This area is currently under development as a "gateway shopping center." It is located near a major interchange with I-5 and serves regional traffic as well as local residents. This area of  $116^{\rm th}$  Street NE was identified for a gateway by the 2005 Comprehensive Plan.

#### 4. 88th Street NE and I-5

This site is situated next to a major I-5 interchange. It was identified in the Comprehensive Plan as a gateway location that should have an attractive and consistent streetscape. The interchange is currently in need of beautification but is probably a lower priority than other gateway locations since there are no projects currently planned.

#### 5. 4th Street NE and I-5

This site is a major entrance into downtown Marysville off of I-5 into downtown. There is an existing gateway structure at this site that needs to be modified / updated to fit within the context of this Master Plan.

#### 6. 4th Street NE and State Avenue

This is a key intersection in downtown Marysville. There is a new Walgreen's being developed at this site which includes a small plaza/retail structure at the corner.

#### 7. State Avenue at Bridge

The bridge crossing Ebey Slough is a major entrance into Marysville from the south. Washington State Department of Transportation is replacing the old steel bridge with a new concrete structure, creating an opportunity to integrate a gateway feature with the new bridge design.

# 8. 84th Street NE and SR 9

This site is in a neighborhood-commercial area with redevelopment potential.  $84^{\rm th}$  Street NE is an important access point from the east.

## 9. 64th Street NE and SR 9

This site is on SR  $528 (64^{\text{th}} \text{ St})$ , which is a principle arterial providing access to Marysville from the east. There are major development plans for this intersection, including a Wal-Mart on the northwest corner.

#### 10. Soper Hill Road and SR 9

This site is currently outside the City limits, making it a lower priority compared to other gateway locations. However, City annexation of this area and future growth is expected to be significant, making it an important thoroughfare for vehicles traveling west to Marysville, I-5, and Everett.

#### 11. SR92 and SR 9

This site was recently annexed to the City. This gateway will be located at a planned extension of the SR92 intersection at Highway 9. The Whiskey Ridge subarea plan identifies this as a gateway into southeast Marysville.

# **Types**

The proposed gateway sites have been categorized as freeway/ highway commercial, downtown commercial, and community commercial based on the character of their surroundings.

#### Freeway / Highway Commercial

Gateways one through four are located on major freeway and highway corridors, making them important gateways for both local residents and visitors from elsewhere in the region.

#### **Downtown Commercial**

Gateways five through seven are located in and around downtown Marysville. They differ from the other gateways being proposed in that they are designed to function at the pedestrian scale and serve a key role as wayfinding tools.

## **Community Commercial**

Gateways eight through ten are located at small scale neighborhood-commercial developments. They are oriented primarily toward the residents who live in surrounding single-family neighborhoods.

# **Purposes**

Each of the proposed gateways serves a unique purpose based on its location and type. The purposes summarized below were developed during workshops with the Master Plan advisory committee.

# **Design Principles**

The following overarching principles should be applied to the design, installation/construction, and maintenance/upkeep of gateways.

Principle 1: Implement over time as opportunities arise

Gateways should be implemented as components of capital investments or private developments. A private developer should be encouraged to construct a gateway as a component of their plan. The City shall negotiate with the developer to either collect fees for municipal construction of a gateway or the developer should construct a gateway that complies with the City's Gateway Master Plan. Capital projects should reference this plan and where possible, incorporate the construction of gateway(s) into the project. Construction of capital projects should not preclude construction of future gateways.

Many locations within Washington Department of Transportation (DOT) ROW have been identified as appropriate locations for gateways. As projects are initiated within these ROWs the City should explore partnerships with DOT to enhance the interstate and the many highways that are adjacent to or in many cases run through Marysville.

The City currently has signage in place to designate Public facilities or to aid in the location of the facilities. As the signs become outdated they should be replaced with signage that is coordinated with the elements of this plan.

Principle 2: Consider the long-term maintenance and upkeep

The materials and components used for gateways should be durable and maintainable with the City resources. At a minimum, the lights, signage, and landscaping should be consistent with the City's existing palette to allow for efficient and economical maintenance and upkeep. In addition, all gateway elements should be vandal proof.

Principle 3: Gateway designs should be simple in character

The gateways should be free from excessive embellishments and limited to the recommended design palette. Where possible the following key elements should be used as common motifs:

- Metal Trellis
- · Masonry block base

- Landscaping
- · Logo and the red and blue colors

# Principle 4: Pedestrian amenities such as benches should be incorporated into gateways

Street furniture should be incorporated into gateway plans when they are located within areas of pedestrian activity and the available ROW can accommodate furniture.

# Principle 5: Landscaping should be an integral component of each gateway plan

Gateway elements should be set off by planters containing shrubs and trees that offer visual interest and relate/connect the gateway and the surrounding streetscape.

# Principle 6: Flowing water can be incorporated as a feature element

The watershed that flows through the downtown and Ebey Slough that boarders the southern portion of downtown is a strong Marysville image. The existing gateway at 4<sup>th</sup> Avenue and Interstate - 5 includes water as a feature element. Incorporating flowing water in a gateway can play tribute to its contribution to Marysville's image.

# Principle 7: Gateways should be sized and positioned appropriately for the location.

The size and scale of the gateway should not overpower adjacent landscaping, buildings or other site features or obstruct visibility of nearby businesses. Gateways should be located outside of vehicular lines of sight while being visible and legible from streets and paths.

# **Common Element Guidelines**


The use of common, repeated elements on each of the gateways will unite the individual gateways.


## Materials and Color Palette


All gateway materials and colors should be architecturally compatible with the guidelines set forth below. Gateway design should consider adjacent land uses and roadway function and configuration, site features, available site area, view corridors, and natural features.

- The gateway bases should be constructed of smooth face masonry units. Colored concrete block should be used with faces ground to expose the variegated stones. Color should be similar to what is illustrated in Figure 2 below, medium grey concrete with dark grays, greens, and reds for the exposed aggregate.
- The top of the block walls should have a solid precast concrete coping between 2" and 4 " thick of a dark gray to match the masonry blocks.
- Trellises should be constructed of welded steel tubes 2" to 3" wide with a baked enamel treatment in a flat black.
- All gateways should have an engineered concrete footing.
- Stainless steel should have a satin finish, semireflective with a hairline texture running through it. Refer to Figure 3 below.

# Logo

The logo was developed with input from the advisory committee. The design intent is to reflect Marysville's unique setting and values. Surrounding mountains and water are represented by the swooping "waves" at the top and bottom. The font style reflects a growing community built on small town values.

Individual components, the swoops or text, can be used separately or as a complete entity.




Figure 4. Recommended Logo

## Sian Text

The text messages conveyed to the public on the signs should be clear and concise.

- · All sign text should be similar to Optima in upper and lower case. See Figure 5 below.
- Monument sign lettering should be legible from the distance of the intended audience (i.e. motorist, pedestrian). The height of a typical letter should range from 6 to 12 inches. Exceptions may be considered for special site conditions that may warrant larger lettering for visibility. Lettering height should be determined based on site specific conditions to ensure legibility.
- All text should be in the identified red color.
- Lettering on large and medium sized signs should be dimensional with flat edges and a baked enamel finish.
- All dimensional lettering should be stud mounted over the top of the flat cut blue metal swooshes.
- Lettering on small signs should be painted onto the backing surface.

# Lighting

Sign illumination should complement the setting. Illumination shall be designed to avoid nuisances or hazards.

- All gateways should be externally illuminated from a ground source on a photocell or timer.
- · Light sources should be concealed from pedestrians' and motorists' "line of sight." Avoid light spill onto adjacent areas.

 External light sources should be constructed of durable materials to withstand the effects of weather and vandalism.

# Landscaping

Landscaping should be an integral component of each gateway. Gateway designers should follow the existing codes regarding screening, spacing, and density. This will ensure that plantings follow a similar pattern to what is currently allowed in the City. The planting should be designed for each type of gateway described below.

#### Freeway/Highway Commercial

Planting should provide seasonal color and an appealing visual impact throughout the year. Since these locations will be located near busy roads and viewed by fast moving traffic, we recommend that the shrub plantings create broad swaths and bold patterns. Groundcovers and large scale trees should be located in ways that emphasize the patterns created by the shrubs.

#### **Downtown Commercial**

Highlight the character of downtown and focus on the pedestrian experience by creating more intricate planting schemes using a variety of evergreen and deciduous plants. Plant a backbone of evergreens for year round interest and emphasize the seasons using deciduous plants with beautiful blooms and strong fall colors. Select street trees with bold fall colors and bright blooms.

## **Community Commercial**

Create a landscape planting that matches the scale of the surrounding neighborhoods and shopping centers. Use mass plantings where appropriate and highlight the gateway with splashes of seasonal color. Use both evergreen and deciduous trees in a way that highlights the gateway. For gateways located on the boarder between neighborhoods and more rural locations; use a blend of native plants to create a rural character.

Note: Gateway sites bordering streams and estuaries should include a combination of gateway and native

plants. Gateway plantings should be used along the road and around signage. Use native plants to blend back toward the stream or estuary. Select native plants that respond best to the environmental conditions on site.


# **Gateway Design Concepts**

The following concepts are provided as guidelines to be applied during the refinement of each particular gateway at a particular site. Design may warrant some deviation. However, the effort should be made to adhere to the overall design intent and remain consistent with the common elements — material, color, logo, sign text, lighting, and landscaping.

## Small Scale - Informational

A small scale sign for use within pedestrian orientated areas. A horizontal or vertical oval shaped stainless steel backer, solid or perforated, with painted swooping logo elements on the top and bottom. Painted message of matching font style located in middle. Sign can be surface or post mounted.

Cost Estimate: \$2,000 (assumes a volume discount through multiple sign orders)



# Medium Scale - Post Top Mounted

A medium scale, double sided metal panel with painted logo elements and message similar to small scale informational sign. Sign is ideally located within the streetscape where available ROW is limited and there is a mix of pedestrian and motorists pass by traffic.

Cost Estimate: \$4,000 (assumes a volume discount through multiple sign orders)



# Medium Scale - Cantilevered

The medium scale cantilevered sign is offered for situations where an over roadway gateway offers the most visibility since motorists are the predominate form of traffic. The post does however offer the opportunity to incorporate a pedestrian scale sign. Brackets can be added for banners.

Cost Estimate: \$53,000 (includes pole)




# Large Scale – Horizontal

A large scale horizontal sign is offered for locations where visibility from a distance is desired and/or where motorists are moving quickly past the gateway. Footprint requirements are a significant consideration for large scale horizontal gateways.

A stainless steel backing panel with swoosh elements on top and bottom and "Marysville" in all capitals in the middle. Could be constructed with or without a concrete masonry base. The illustration below shows the gateway without a concrete masonry base.

Cost Estimate: \$61,000 (includes base lights, trellis, landscaping, etc.)



The following directional signs are suggestions as City fabricated directional signs. The design intent is to frame the directional information with the logo.







# **Directional Kiosks**

A monument type of kiosk can be placed in public spaces where pedestrians look for directions to destinations throughout the city.

Cost Estimate: \$4,000 (assumes a volume discount through multiple sign orders)



# Informational Reader Board

As with the directional kiosk a monument type of kiosk with an electronic reader board could be placed in civic spaces or at locations where large amounts of community members pass by as pedestrians or motorists.

Cost Estimate: \$71,000 (includes electronic reader board on one side)



# Landscape Palette

Plant palettes have been generated to enhance the types of gateways indicated in Section II.B. of this report. As mentioned above the gateway types are Freeway/ Highway Commercial, Downtown Commercial, and Community Commercial. The plant palette is derived from the "Administrative Landscaping Guidelines" for the City of Marysville and augmented with additional plants. A three-letter code is placed in front of each plant name to indicate if the plant is best suited to one of the three gateway types listed above.

Three-letter prefixes are as follows:

FRE = Freeway/ Highway Commercial

DTC = Downtown Commercial

COM = Community Commercial

# CITY OF MARYSVILLE CONTRACT FOR RECOVERY OF UTILITY CONSTRUCTION COSTS CONTRACT NO.

THIS AGREEMENT, entered into by and between the CITY OF MARYSVILLE, a municipal corporation of the State of Washington, hereinafter referred to as "City," and

hereinafter referred to as "Developer."

#### WITNESSETH:

WHEREAS, the Developer has constructed and installed a <u>sewer</u> (water, sewer, or storm drainage) system, including a(n) 12 to 15-inch line and appurtenances situated as follows:

Approximately 309 LF of 12" and 1322 LF of 15" offsite sewer main located on  $79^{th}$  Avenue NE serving the Plat of Willow Park at  $32^{nd}$  Place NE.

WHEREAS, the Developer has conveyed said system by Bill of Sale to the City and the City has accepted ownership and maintenance of the same under its sole jurisdiction, subject to a <u>one</u>-year warranty by the Developer; and

WHEREAS, the parties desire to enter into a contract pursuant to Chapter 35.91 RCW providing for reimbursement to the Developer for its construction and installation costs by subsequent users of the system; NOW, THEREFORE.

IN CONSIDERATION of the covenants bargained for and given in exchange, the parties mutually agree as follows:

- 1. The Developer has furnished or shall furnish the City with an as-built drawing of the installation of the above-referenced system on mylar, 24" x 36" in size, together with receipted bills showing that all charges and expenses incurred in connection with the installation have been paid.
- 2. The Developer's costs for construction and installation of said utility lines and facilities, including engineering fees, were \$2277,873.23, which have been paid in full by the Developer.
- The real property described below (or described in the exhibit attached hereto) is benefited by the installation of said utility lines, and is subject to the lien created by this Contract:

Nine properties located in the SE Quarter of Section 02, Township 29 North, Range 5 East, W.M. Tax parcel #'s 005907-000-298-01, 005907-000-298-02, 005907-000-295-03, 005907-000-295-01, 005907-000-294-01, 005907-000-294-01, 005907-000-299-02, 005907-000-299-03, & 005907-000-314-01.

4. The proportionate share of the total cost of the utility lines which may be fairly attributed to serving and benefiting the above-described property, as a whole, rather than serving and benefiting the property of the Developer, is \$159,340.69.



- 5. For a period not to exceed fifteen (15) years from the date of this agreement, the City agrees to require the owners of the above-described real estate who hereafter connect to the above-described utility system to pay a fair pro rata share of the cost referred to in paragraph 4 above. This fair pro-rata share shall be determined from the length of the street frontage of the property to be served, which is known as the "front footage charge." This, however, does not include any other capital improvement charges levied by the City, whether it be by square footage of the area served, and/or a flat fee. No property extending beyond the terminus of the above-described system, as of the date said system has been accepted by the City, shall be served by said system unless there is an extension from said terminus which is constructed and financed in accordance with state and local laws and ordinances.
  - 6. The fair pro-rata share is hereby established to be \$86.27 per lineal foot of frontage.
- 7. No person, firm or corporation shall be granted a permit or be authorized by the City to connect to or use the above-described utility system during said fifteen-year period without first meeting the following conditions:
- If the property is not within the City limits, the owner thereof must sign an annexation covenant as required by City ordinance.
- Payment of all applicable connection charges, fees and assessments regularly imposed by City ordinance.
- c. Payment of the recovery charge referred to in this Contract.
- Compliance with all requirements for utility connections which are regularly imposed by City ordinance.
- 8. The City shall deduct a fee of \$50.00 for each utility connection, said fee to be kept by the City to cover the cost of administering this Contract. The City shall then disburse the remaining balance which is collected for each connection to the Developer within thirty (30) days of receipt thereof. If the Developer shall hereafter assign its rights herein, the City shall be provided with a signed copy of such assignment by the Developer. The Developer hereby waives any claim which it or its successors or assigns may have if the City negligently fails to collect a reimbursement charge from a property owner connecting to the utility system.
- 9. At the end of the fifteen-year period, which shall commence upon the recording of this agreement, this agreement shall terminate in and of itself, notwithstanding that the full amount provided for herein may not have been recovered. Connection charges subsequent to the termination of this agreement shall be governed by ordinance of the City of Marysville, and all such charges shall be paid to the City for its use and benefit.
- 10. The provisions of this Contract shall not be construed as establishing the City as a public utility in the areas not already connected to the utility system; nor shall this Contract be construed as establishing express or implied rights for any property owner to connect to the City's utility system without first qualifying for such connection by compliance with all applicable City codes and ordinances.
- 11. The Developer agrees to hold the City harmless from any and all liability resulting from errors in the legal descriptions contained herein, and the City is relieved of all responsibility under this agreement for collecting on parcels not properly included in the legal descriptions set forth in Section 3 of this contract.
- 12. This Contract shall be recorded in the records of the Snohomish County Auditor, and it shall be binding upon the parties, their heirs, successors and assigns. The Developer agrees to reimburse the City for the recording fee and for all legal fees and other costs associated with the execution and recordation of the agreement.



Section 2. Effective Date. This ordinance shall become effective five (5) days after publication.

## Reports:

- Librarian (Maggie Buckholz)
  - Maggie reported on several successful programs during the past month of Children's book week.
  - Christa will soon return to work.
  - The teen librarian has opened an account for the library on MySpace.com. The library has 28 friends already. She is using the internet as a resource to inspire the writing and art work of the Catharsis group.
  - The Library was closed for a couple of days during the recent snowfall. Sometimes the city is willing to clear the parking lot and sometimes it wants to limit liability by closing the library. Other factors in determining library closure are staffing problems related to bad roads.
  - Maggie reported that the Library was vandalized during the past month. A window was broken and an intitial attempt to steal computers was unsuccessful. A later attempt was successful and two computers and a flat panel monitor were stolen. It was also noted that several pieces of equipment had been unplugged,

- possibly in an attempt to facilitate theft. The city has stepped up patrols in the area.
- The pay phone has been vandalized has have handles on the bookdrop slots.
- The building roof had an ice dam build up on the roof during the snowy weather. The city cleaned up the water damage promptly and Marty made significant effort to clear the roof.
- Sno-Isle (Valerie Stevens)
  - Valerie reported on the recent elections. Lynnwood area voted to annex to the library system ending their contract status with the library.
  - The Arlington library issue did not pass. It failed to meet the 60% mark by 28 votes. Sno-Isle and Arlington together paid for a hand recount of the applicable voting districts. The original count was very accurate as the hand count only varied by a couple of votes. As a result of this vote, the Arlington library will be removing some of their non-fiction book collection to make room for improved staff work space.
  - The library system has been involved in a process called continuous improvement. Various staff members at various libraries have been assessing the process of handling holds. They are trying to find small ways to speed up the process without adding expenditures.
- City Council (Lee Phillips)
  - Lee was absent
- Friends of the Library (Dorothy Stanton)
  - Dorothy reported that the Friends will have a new president, Brett Ingram and his wife will be the secretary. Ethel Cage will continue as the treasurer for a few more months until a replacement can be found.

#### **Old Business**

- Gellerson Bequest Proposal Status Report
  - The teen shelving will be here soon.
  - The remainder of the computer chairs will come to about \$5000. The furniture committee will meet to evaluate what else can be done with the available budget.

- Art project Status Report
  - The RFP (Request for Proposals) and draft Contract have been approved by Sno-Isle Foundation. This process has been delayed by other demands on the Foundation staff. The Art Committee will begin meeting again and will present this to the board for approval.
- Parking Lot Lighting Update
  - The lighting improvement for the parking lot is underway. The trees have been removed. The lot will be partially closed the week of Dec 18<sup>th</sup> to enable the wiring to be laid in place. There is some delay in getting the light fixtures which causes a budget problem in getting this project done in this year's budget.

### **New Business**

Pay Phone Replacement Discussion

The city would like to not replace the pay phone that has been outside the library. They feel that they have to replace it frequently due to vandalism and its probable use for illegal activities. The board was concerned that not everyone has a cell phone. Maggie mentioned that patrons use library phones to call for rides now and that would continue. It was suggested that if the pay phone was removed there should be a sign indicating availability of a phone. We were concerned however about those who might need a phone during hours the library is not open.
