
Good morning Brian,

I have a quick question on you comment letter, item 28.a. (page 4 of 6 of the attached comment letter).

Was this comment simply a "boiler-plate comment" to be sure reference the previous plan review letter, dated 9/7/23 (also attached for ease of reference) was not overlooked? Per Comment 10 of this letter, fire sprinklers would be required only if fire flow does not meet fire code requirements, if any part of the homes are less than 200' from the public ROW. Based on this screenshot below we do not see any concern with distance from ROW for lots 20, 21, 26 & 27, but before we res-submit for second plan check, I wanted to confirm this to be MFD's finding as well. If you concur, I'll be happy to include this screenshot in the response for clear record keeping.
