NOTE:

THE DEPARTMENT OF ARCHAEOLOGY AND HISTORIC PRESERVATION'S (DAHP) INADVERTENT DISCOVERY PLAN SHALL BE FOLLOWED DURING SITE CONSTRUCTION. IF AT ANY TIME DURING THE CONSTRUCTION ARCHAEOLOGICAL RESOURCES ARE OBSERVED ON THE PROJECT SITE, WORK SHALL BE TEMPORARILY SUSPENDED AT THE LOCATION OF DISCOVERY. THE DAHP AND ALL CONCERNED TRIBES SHALL BE CONTACTED FOR ANY ISSUES INVOLVING NATIVE AMERICAN SITES. IF PROJECT ACTIVITIES EXPOSE HUMAN REMAINS, EITHER IN THE FORM OF BURIALS OR ISOLATED BONES OR TEETH, OR OTHER MORTUARY ITEMS, WORK IN THAT AREA SHALL BE STOPPED IMMEDIATELY. LOCAL LAW ENFORCEMENT, DAHP, AND AFFECTED TRIBES SHALL BE IMMEDIATELY CONTRACTED. NO ADDITIONAL EXCAVATION MAY BE UNDERTAKEN UNTIL A PROCESS HAS BEEN AGREED UPON BY THESE PARTIES, AND NO EXPOSED HUMAN REMAINS SHOULD BE LEFT UNATTENDED.
