	<b>Revised Scope of Work</b> : The Land Use Application, Project Narrative, Environmental Checklist, JARPA, Critical Areas Report and Site Plan have been amended (See Exhibits E015 – E020). Amendments to the initial scope of work includes partial fill of a Category III wetland (WL2) and placing a Type F stream (Stream 1) in an appropriately sized pipe.									
Project Description	To mitigate the impacts on 2,000 SF of Category III wetland, 16,400 SF of it associated buffer, and 6,800 SF of Type F stream, the applicant proposes purchasing mitigation bank credits from a State-certified mitigation bank.									
	The applicant is still seeking State Environmental Policy Act Review, Critical Areas Confirmation and Shoreline Substantial Development Permit Approval, in order to clear and fill the existing City of Marysville Public Works Operations site for a future mixed-use development, which would be approved under separate development permits. The immediate goal is to fill the site above the base flood elevation, environmental restoration and enhancement of the Ebey Slough shoreline.
