## **ELECTRICAL PERMIT – OWNER AFFIDAVIT**

I am applying for the property owner exemption under the following conditions:

STEP 1 - You must select the option that applies to your situation:

I swear under penalty of perjury that:	
OR	I am a registered general contractor who is installing a temporary electrical service owned by me on a project where I am the general contractor
I swear under penalty of perjury that I am:	
	The owner of real property; or
	The renter or lessee of real property. (You must provide a signed letter from the owner of the property granting permission for you as the tenant to perform electrical work on the property); or
	A nonprofit corporation that holds a current tax exempt status as provided under 26 U.S.C. Sec. 501(c)(3) or a nonprofit religious organization, and the total value of the electrical work does not exceed thirty thousand dollars (\$30,000.00).
STEP 2 - You must select the option that applies to your situation:	
	A New Single Family residence THAT IS NOT intended for rent, sale, or lease AND I will be personally doing the electrical work AND I will occupy the residence for at least 24 months after completion of the electrical work;
	A NEW 2, 3, or 4 unit residential property that IS intended for rent, sale, or lease AND myself and/or a regularly scheduled and paid employee(s) will be doing the electrical work AND I will occupy one of the units for at least 24 months after completion of the electrical work.
	An EXISTING 1, 2, 3, or 4 unit residential property that IS intended for rent, sale, or lease AND myself and/or a regularly scheduled and paid employee(s) will be doing the electrical work. The property will not be offered for sale within 12 months after obtaining the property;
	A farm AND I, personally, and/or a regularly scheduled and paid employee(s) will be doing the electrical work;
	An EXISTING place of business AND I, personally, and/or a regularly scheduled and paid employee(s) will be doing the electrical work;
	A NEW place of business that is NOT intended for rent, sale, or lease AND I, personally, and/or a regularly scheduled and paid employee(s) will be doing the electrical work; or
	Other property that is NOT intended for rent, sale, or lease AND I, personally, and/or a regularly scheduled and paid employee will be doing the electrical work.
	I am a nonprofit corporation that holds a current tax exempt status as provided under 26 U.S.C. Sec. 501(c)(3) or a nonprofit religious organization and the total market value of the electrical work does not exceed thirty thousand dollars (\$30,000.00), and the electrical work will be performed by appropriately certified electricians or certified and supervised trainees who are volunteering and not being compensated for electrical work per RCW 19.28.091(7).
