CALL TO ORDER / INVOCATION / PLEDGE OF ALLEGIANCE

Mayor Dennis Kendall called the October 9, 2006 meeting of the Marysville City Council to order at 7:00 p.m. Pastor Jack Richards of the Bethlehem Lutheran Church gave the invocation. Mayor Kendall led those present in the Pledge of Allegiance.

ROLL CALL

Chief Administrative Officer Mary Swenson gave the roll call. The following staff and councilmembers were in attendance.

COMMITTEE REPORTS

Councilmember Jeff Seibert reported on the **Public Works Committee Meeting**. Topics discussed included:

- Discussions regarding assisting Arlington with the wastewater treatment process.
- Staff is looking into a recycling grant for food and organic waste recycling.
- Transportation costs update.
- New meter reading service – 50 units currently being tested.
- County's voter ordinance.

AUDIENCE PARTICIPATION

Derek Walters, 4414 – 95th Street, Marysville, WA 98270, requested that the City Council consider amending MMC 11.81.70. Mr. Walters discussed his inability to park in front of his own house without receiving a citation and requested that the code be addressed to assist him. He also discussed problems he has had with his neighbors.

Chief Administrative Officer Mary Swenson indicated that staff is looking into the matter. Chief Turner added that he spoke with dispatch regarding holding a resolution meeting with Mr. Walters and his neighbors. He noted that officers have only responded when there has been a citizen complaint regarding parking matters.

Curry Smythe, Village Restaurant, 17121 28th Drive NE, Marysville, asked the City Council to give him a turn lane on Twin Lakes Road between the new Target and Costco. He explained that this area is very congested and difficult for customers to get into his restaurant. He felt that it was only fair to allow for a double-turn lane and no signs to enable better access to his restaurant.

Community Development Director Gloria Hirashima stated that they are monitoring and will continue to monitor the situation over the next few months. Staff's primary concern is safety. She noted that they may be making recommendations for changes, but they do not support the double-turn lanes in that area. She noted that they are working with the city engineer on this situation.

Councilmember Jeff Seibert suggested that that an expanded road in that area would encourage shoppers to use that as a shortcut. Ms. Hirashima concurred.

Councilmember Lee Phillips asked about the signs. Ms. Hirashima explained that they are "Private Drive Only" signs and they are part of the right-of-way permit that was needed to do the driveway cut.

Councilmember Carmen Rasmussen asked if u-turns were legal there. Ms. Hirashima responded that they are. Chief Administrative Officer Swenson added that there is a sign on the light that indicates that it is acceptable to do a u-turn there.

PUBLIC HEARING**14. Sunnyside Elementary School Annexation; PA 06015.**

Community Development Director Gloria Hirashima summarized the hearing. Mayor Kendall opened the hearing for public comments at 7:25 p.m. Seeing no public comments, the hearing was closed at 7:25 p.m. There were no Council comments or questions.

Motion made by Councilmember Nehring; seconded by Councilmember Seibert to approve pre-zoning the property consistent with the Comprehensive Plan and approving Ordinance 2660, annexing the property contained within the Sunnyside Elementary School Annexation, effective December 1, 2006. **Motion** passed unanimously (7-0).

15. Sunnyside Whiskey Ridge Expanded Annexation (includes Whiskey Ridge North Annexation); PA 06005 and PA 05058.

Ms. Hirashima summarized the hearing as explained on the agenda bill. Mayor Kendall opened the hearing for public testimony at approximately 7:28 p.m.

Public Testimony:

- Susan Whornham, 2829 – 82nd Avenue NE, Everett, WA 98205, asked if her property was included in the annexation. If so, would her address and school district change? Ms. Hirashima affirmed that she was part of the annexation and that her address would become Marysville. The school district would remain Lake Stevens. Ms. Whornham stated that she was very opposed to becoming a citizen of Marysville. She said she intentionally bought her property in Everett, as opposed to Marysville, and felt she had been ill-informed. City Attorney Grant Weed reviewed the due process that has occurred regarding this annexation.
- Bob Kozinsky, 3824 Sunnyside Blvd., had questions about the zoning of the area on the west side of the school. Ms. Hirashima explained that it would be 4.5 dwelling units per acre. He asked about having the sewer extended in that area. Ms. Hirashima replied that some developers are looking into the possibility of a public lift station. This is currently under review.
- Larry Novak, 3606 Densmore Road, Everett, also had questions about the zoning in his area. Mayor Kendall explained that the entire area is under study for a master plan right now. They hope to have a draft of that available in the next week. This will be open for public comment through the Planning Commission process. Gloria Hirashima concurred that the zoning has not been established yet, but they expect the master plan to be completed by the end of the year.
- Mark Meyer, 8512 East Sunnyside School Road, asked about the zoning for the area. Ms. Hirashima replied that this will also be included in the master plan.

- Dwayne Wiseman, 8805 East Sunnyside School Road, asked about the timing of the master plan process. Ms. Hirashima reviewed that. Mr. Wiseman discussed the pressure that is on many landowners right now by developers. Ms. Hirashima suggested waiting to make any decisions until the plan is developed. Mr. Wiseman asked about any plans to change East Sunnyside School Road. Ms. Hirashima responded that her understanding is that WSDOT has plans to close off access to Highway 9. City-initiated plans for other roads will be determined through the master plan process.
- Mark Prowthy, 5808 83rd Avenue NE, Everett, expressed concerns about 83rd being a speedway. He asked if there is anything that can be done to monitor or protect the area. He also expressed concerns about construction equipment traffic as development occurs. Gloria Hirashima encouraged him to participate in the planning process to find out what the City has planned. She also informed him that there will be more police in the area and they would have much more say in their local government once they are annexed.
- Gail Prowthy, 5808 83rd Avenue NE, Everett, also expressed concerns about the safety on their street. She asked if any sidewalks would be added. Ms. Hirashima explained that those would be done by developer frontage improvements. Staff will be putting an emphasis in the master plan to get those gaps filled in by providing incentives to developers.
- Terry Johnson, 4829 87th Avenue NE, commended the fine work of the City of Marysville staff and City Council. She stated that they are always looking forward and have been extremely responsive to the citizens. She thanked them for all they have done in this annexation.

Seeing no further public comments, Mayor Kendall closed the public hearing at 7:55 p.m.

Motion made by Councilmember Seibert; seconded by Councilmember Rasmussen to approve pre-zoning the properties consistent with the land uses outlined in the Comprehensive Plan and approving Ordinance 2661, annexing the properties contained within the Sunnyside-Whiskey Ridge "Expanded" Annexation, effective December 1, 2006. **Motion** passed (6-1) with Councilmember Phillips voting against.

CURRENT BUSINESS – None.

NEW BUSINESS

16. State Avenue (136th Street NE to 156th Street NE) Local Agency Agreement Supplement No. 1; Washington State Department of Transportation.

Councilmember Soriano asked Public Works Director Paul Roberts what the intent of the federal P.E. Funds was. Mr. Roberts explained that these are Planning and Engineering Funds and will help the planning and development of the project more rapidly.

Motion made by Councilmember Soriano; seconded by Councilmember Seibert to authorize the Mayor to sign the State Avenue Local Agency Agreement Supplemental No. 1 to allow additional federal funds to reimburse the City for remaining project design expenses. **Motion** passed unanimously (7-0).

17. Stillaguamish Water Filtration Plant Improvements – Professional Services Agreement Supplement; DMJM Harris, Inc.

Paul Roberts confirmed that the recovery of additional costs would be discussed in subsequent discussions with the primary contractor.

Motion made by Councilmember Wright; seconded by Councilmember Vaughan to authorize the Mayor to sign Supplement No. 2 to the Professional Services Agreement with DMJM Harris, Inc., in the amount of \$54,900.00. **Motion** passed unanimously (7-0).

18. PRD, Small Lot, BSP, and Permitted Uses Proposed Code Amendments; PA 06-033.

Steve Roberge noted that staff was recommending one additional change in 19.14.098 (8) regarding the 50% lot coverage. Staff is recommending striking this section and will instead depend on the existing zoning there.

Councilmember-Rasmussen asked about Pacific Ridge Homes' request to change the dimension of the porch requirement in their letter dated October 9, 2006. Community Development Director Hirashima stated that the Planning Commission did review this request and had many discussions about it. They felt very strongly about this requirement, but did include the opportunity for flexibility.

Councilmember Seibert thanked Ms. Hirashima for the color pictures, but noted that the photo of the auto court on page 4 does not appear to be to scale. He also thanked the Planning Commission for their work on this. He stated that he generally supports their recommendations, but in this instance he has several concerns, as follows:

- Lot coverage and its relationship to surface water rates
- Disagrees with 10% allowance of buffers to be used as a part of open space
- Parking enforcement issues
- Incentives are not appropriate for things that should be a standard
- Feels this is in the experimental stage with other communities and is not appropriate for Marysville yet.

Councilmember Vaughan asked about the next steps if this did not pass. City Attorney Grant Weed replied that once the moratorium is repealed the City will be back where it was prior to the time the moratorium was enacted. Gloria Hirashima clarified that just the air space condominiums were included in the moratorium. This code would provide tools for regulating those, as well as site plan standards. It does not necessarily change the densities allowed through the Comprehensive Plan zoning. This would be used primarily in Multi-Family zoning.

Councilmember Wright commented that both Planning Commission and staff have put a lot of time into this and she supported it in order to provide the design and the product that the City can be proud of.

Councilmember Phillips commented that he shared concerns regarding parking and incentives. Ms. Hirashima discussed options related to parking. Steve Roberge explained the current proposed parking regulations and then reviewed the discussions of the Planning Commission regarding parking ratios.

Councilmember Seibert asked about the effect of eliminating the landscaping strip. He was concerned that this might impact the desired outcome. Ms. Hirashima explained that, in general, they would try to maintain it, but there might be some instances where it doesn't make sense. She discussed the part of the code that requires developers to come up with alternative access points. Steve Roberge referred to page 20 of the ordinance, which outlines criteria if the landscaping is reduced or modified. Ms. Hirashima commented that this is a new area and will require monitoring to ensure that it is working as expected. They expect that adjustments will be necessary to make sure that it meets the City's goals.

Councilmember Seibert stated that he is mostly concerned about what will happen while the City is still figuring it out. He prefers being more comfortable with the code before approving it.

Gloria Hirashima emphasized that the goal of the code is to see higher quality development.

Motion made by Councilmember Wright; seconded by Councilmember Rasmussen to approve Ordinance No. 2662 regarding the PRD, BSP, Small Lot, and Permitted Uses amendments as recommended by the Planning Commission. **Motion** passed (5-2) with Councilmembers Nehring and Seibert voting against.

24. Small Works Contract for the Public Safety Building – Jail Door Controls Replacement Project Subject to City Attorney Approval.

This item was removed from the agenda.

25. **A Resolution of the City of Marysville Declaring Certain Items of Personal Property to be Surplus and Authorizing the Sale or Disposal Thereof.**

Motion made by Councilmember Rasmussen; seconded by Councilmember Soriano to adopt Resolution 2191, declaring certain items of personal property to be surplus and authorizing the sale or disposal thereof. **Motion** passed unanimously (7-0).

MAYOR'S BUSINESS

- Mayor Kendall noted the full parking lot upon the opening of Kohl's last week.
- Saturday morning was the official grand opening of the Harley Davidson store and it was very crowded.
- He referred to comments he has received from new stores who have been very pleased to do business with the City of Marysville. These are very welcome comments.
- He noted that they are still working on the traffic situation on all of the new businesses. Public Works Director Paul Roberts added that the traffic crews have been working with Community Development and the police and have been extremely responsive. WSDOT has also been very helpful.

STAFF BUSINESS

Gloria Hirashima thanked Steve Roberge and the Planning Commission for their work. She pledged to return with regular reports to the Council.

Grant Weed

- He attended the WSAMA conference in Spokane last week along with Ryan White and Craig Knutson. He noted that there was much discussion regarding I-933. Some cities are considering resolutions concerning their positions on the measure. He said this would need to happen soon if the City is interested. Also discussed at the conference was what cities can do by way of enacting pre-emptive ordinances. There was a range of possibilities.

- He stated that he would need a 10-minute executive session to discuss a real estate matter, with no action needed.

Mary Swenson:

- She was very pleased to finally get the Sunnyside Annexation complete. She stated that Gloria Hirashima has been working very diligently on the master plan. She appreciates what Gloria Hirashima, Steve Roberge and the Community Development department are doing with this. She noted that she has received kudos from new businesses and developers regarding these code changes.
- The Rotary Petting Pumpkin Patch is open. She encouraged Councilmembers to go.

Chief Turner:

- He commented that the 9-1-1 transition is going well although they are still working on some issues.
- They have placed a conditional offer on a lateral officer so hopefully he will be on board soon.
- The Graffiti Task Force will meet on Thursday the 19th. Staff has met with the tribal police. WSDOT has agreed to paint over the graffiti and to remove the walkway.

CALL ON COUNCILMEMBERS

Carmen Rasmussen:

- She said she has been amazed at the number of cars at Costco and Target, but noted that traffic has been moving well.
She will be going to NRPA conference this week.
- She gave an update on Healthy Communities – surveys going out and will be completed by the end of October.
- Discussed the community benefits of the trails in Princeton B.C. and encouraged the Council to keep access to the Centennial Trail on their minds.
- She thanked staff for the great job they did fielding all of the annexation questions.

Lee Phillips:

- He stated that he felt they should have waited until February to annex.
- He thanked Chief Turner for addressing the overpass issue.
- Noted that there will be a meeting held at the Globe by a group that wants to start an art center in Marysville.

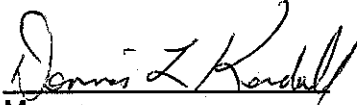

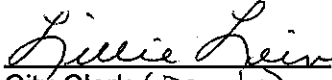
