## A. Mayor's Volunteer of the Month

Mayor Nehring presented the Volunteer of the Month Award to Jason Busch for his 10 years of volunteer service as a coach for the youth basketball league.

## **Public Comment**

Evan Reed, City of Everett, reintroduced himself as Executive Director of Bunker Arts Collective, an organization that mediates vandalism, graffiti, and litter with community-organized volunteer cleanups as well as a free mural program for City of Everett residents and businesses. He has expanded to Marysville now as the Marysville Boys and Girls Club as their Executive Director. He announced that they just received a \$10,000 grant for three murals along the side of the Boys and Girls Club building, a community garden, a community bulletin board, a little library, and a small 24/7 outdoor food pantry. He is very eager to get all that going. He is looking for local artists to do the mural. He also announced that his non-profit was able to do a cleanup at the intersection of 88th and I-5 and removed about 250 pounds of trash. Their next cleanup in Marysville will be March 23 from 1-3 p.m. at the same intersection. He has a van and all the equipment needed.

Mayor Nehring thanked him for the investment in the community.

Councilmember Richards asked if he has talked with the city volunteer coordinator. Mr. Reed said he had a great meeting with Parks over the week and was eager to make those connections.

Emergency Preparedness Manager Sarah LaVelle reviewed this item.

Councilmember Richards noted that the emergency center is at the far south end of town. He was concerned about potential difficulties to access to that area and

recommended looking into a site closer to the middle of town. Ms. LaVelle reviewed reasons for choosing that site but noted that could consider other areas for the future.

Councilmember King asked if the Food Bank building and parking lot is a community distribution site. Ms. LaVelle confirmed that there is an agreement in place should they need to use it.

Councilmember Norton asked if there was anything substantive changed from the prior report. Ms. LaVelle replied that it was mostly minor changes.

Councilmember James asked if one of the reasons it was up on the hill was because of communications ability. Ms. LaVelle confirmed this.
