NEW BUSINESS

13. Approval of Committee Recommendation for Gateway Master Plan.

<u>Stephanie Lakey of Makers Architecture and Urban Design</u> gave a presentation regarding the Committee Recommendation for Gateway Master Plan as contained in the Council packet. With the addition of a gateway at SR92 and Highway 9 as recommended by the Mayor and Councilmember Seibert there are a total of 11 intersections.

Mary Kirkland, 13004 Hilltop Road, Arlington, owner of Hilton Pharmacy at 4th and State and Committee Member.

Ms. Kirkland commented that it was very rewarding to work on the Gateway Committee. She commended the excellent work done by Makers and the good, creative input from community members. She felt that this is a good plan for a phase-in approach and is an important way to set design standards for upcoming developments.

Dorothy Stanton, 5900 - 64th Street NE #8, Marysville.

Mrs. Stanton thought that this sounded like a great plan, but she thinks that there should also be signs wishing folks, "Goodbye," and, "Thanks for coming," as they leave the City.

Marysville City Council January 22, 2007 Meeting Minutes Page 4 of 8 Community Development Director Gloria Hirashima concurred. She explained that some of the signs were designed to be double-sided so they could have messages on the back.

Tom King, 3113 Sunnyside Blvd, City of Marysville Employee

Mr. King commented that he likes all aspects of the plan, but is leery about hanging a banner over the bridge. He discussed the difficulties and liabilities associated with hanging banners over the roadway. He suggested a vertical banner instead.

Gloria Hirashima commented that City Engineer Kevin Nielsen had expressed similar concerns. She noted that the Committee had decided in their final discussions to have something fixed directly to the structure.

Mayor Kendall confirmed that there is room for modification in this plan. Gloria Hirashima affirmed that the plan could be modified or expanded as necessary.

Councilmember Vaughan commented that he was very happy with what the committee, staff and consultants produced. He felt that it is a great plan and will help to create consistency with the City's image.

Councilmember Soriano thanked all involved for their hard work and cooperation on this. He commented that the product is fantastic.

Motion made by Councilmember Vaughan, seconded by Councilmember Phillips, to approve the Gateway Plan with the understanding that there may be modifications as needed. **Motion** passed unanimously (6-0).

Mayor Kendall commended all those involved in this project.

Paul Roberts:

- Commented that they have been receiving a lot of calls regarding the surface water change in commercial fees. He encouraged Council to forward calls to Public Works.
- He discussed the damaged 10" forced main along the south side of Sunnyside. He said they have authorized an emergency contract to resolve the problem. The contractor should begin work in the next day or two. They are all moving as quickly as possible.
- He announced that the City received the Gold Award for Engineering Excellence from the American Consulting Engineers for the Lakewood Sewer Extension.

Mary Swenson commented that she had gone to Crystal Tree Village for a meeting regarding traffic congestion. They will continue to educate residents and keep them up to date with a newsletter. She stated that she had two personnel items for Executive Session.

Mayor Haakenson from the City of Edmonds spoke as a representative of the Association of Snohomish County Cities and Towns' newly formed Legislative Committee. He distributed and reviewed a fact sheet containing the committee's proposed legislative agenda items. He explained that they were asking for Council's input and support. He requested that the Council respond via email as soon as possible.

Councilmember Wright referred to the proposal to allow cities to use their REET tax for park maintenance. She noted that Representative Brian Sullivan has a bill that would use a portion of the REET tax for new roads as well as maintenance. She wondered if these two items would be in conflict. Mayor Haakenson did not think that they would.

Councilmember Lee Phillips requested a comparison of other cities' funding of their visitor centers. Mary Swenson indicated that staff would bring that back.

10. Authorize Mayor to Sign the Final Mylar for Subdivision Known as Rakestraw.

Senior Planner Chris Holland stated that in order to get the right-of-way dedicated to the City, the Mayor needs to sign the Final Mylar.

Councilmember Rasmussen referred to the provision for a left-turn lane into 39th. She asked if this took into account the plans for 40th in the Whiskey Ridge Master Plan. Mr. Holland indicated that the plans for 40th had been considered.

Chief Turner; Susan Bell, Principal at Cedarcrest Middle School; David Toyer, Barclays North, representing the Chamber; Bud Causer, Marysville Seniors against Crime (MSAC); Paul Rochon, Code Enforcement Officer

Chief Turner reviewed the proposed code revisions from the Graffiti Task Force. The main change is to amend the time requirement for the removal of graffiti to 48 hours. There has been overwhelming community support for this. He referred to the significant increase in graffiti in the last month or so and noted that it is very costly to both the City and the School District. He explained how groups/gangs use graffiti to communicate hate and discontent with other groups. He commented that this is a horrible offense on the community and it is the duty of the people to resolve it.

Mayor Pro Tem Nehring thanked the committee for their efforts and voiced his support of the proposal.

Councilmember Jeff Seibert asked how the appeal process would work. City Attorney Grant Weed reviewed the new code requirements and how the appeal process would function. The goal is to get voluntary compliance by property owners and that is generally how it works.

Councilmember Rasmussen asked David Toyer, who was representing the Chamber, why he thought that 50% of the survey takers did not support the ban on the sale of spray paint to minors. Mr. Toyer pointed to the issues related to administration and enforcement of this. He also noted that smaller businesses might have staffing issues associated with this requirement. The Chamber is recommending keeping this as a voluntary measure, but one that is encouraged.

Councilmember Rasmussen asked about the issue with the definition of responsible party. Mr. Toyer explained their concern is that the responsible party is notified, not just the one who is the lessee. There are many landlords who are not on site who are the ones with the authority and the motivation to effectuate change. Grant Weed commented that the practice of the City would be to locate the owner and to give notice to both the tenant and the landlord.

Councilmember Vaughan asked Code Enforcement Officer Paul Rochon how his efforts to get cooperation were going. Mr. Rochon said that most tenants are signing a release form, but others have issues related to out-of-town property management companies. He stated also that working with the utilities companies is an ongoing process.

In addition to this proposal, Councilmember Rasmussen suggested looking at the penalty phase of graffiti. She recommended additional civil penalties that the

Marysville City Council February 5, 2007 Work Session Minutes Page 4 of 9 damaged property owners can make a claim for in addition to the criminal prosecution. Grant Weed also discussed plans to work to convince legislators to change the state law.

Chief Turner commented that they are circulating a flier to businesses throughout the community informing merchants that they have the right to refuse service. He discussed the young age (as young as 7 and 10) and the apathy of kids that have recently been caught purchasing supplies.

Councilmember Philips asked why the Task Force was recommending 48 hours for cleanup instead of 24. Chief Turner said that this had been a topic of discussion, but the majority of the group felt that this was reasonable. Councilmembers Rasmussen and Seibert concurred, noting that 48 hours balanced the needs of the business owners and homeowners. Councilmember Vaughan pointed out that there is also a weather delay in the event of inclement weather.

Mayor Pro Tem Nehring encouraged the Chief to work with juvenile detention to require the kids to clean up graffiti. Bud Causer of Marysville Seniors against Crime (MSAC) discussed how some of this requires education of the businesses and residents because this whole issue is foreign to many of them. They do not fully understand the cost to the City.

Councilmember Wright asked what responsibility parents have in all this. Chief Turner thought that it used to be that under state law parents were responsible for vandalism damages up to \$3,000. He thought that this amount had been increased, but was not certain how much. He stated that they would be asking the juvenile court to take this matter more seriously in the future. City Attorney Grant Weed added that the state law also says that they need to be able to show that the parents had some knowledge about what the kids were doing. This is generally difficult to do.

Councilmember John Soriano asked about media effort related to this. Chief Turner said that both the *Globe* and the *Herald* are following the story. Chief Turner thanked the Chamber for the tremendous work that they have done.

Councilmember Soriano asked about a reference to checking off something on the business license to allow the City to go in and remove the graffiti if necessary. Paul Rochon explained that when they have a need for this they send a crew of MSAC volunteers out to take care of it. Mr. Causer added that the sooner the graffiti can be addressed, the easier it is to remove.

Councilmember Donna Wright thanked the MSAC volunteers for the work they have done. Bud Causer discussed his anger with all this, because of the impact it has on the City he loves, and the need to deal with it swiftly.

Councilmember Jeff Vaughan cautioned that although the Committee did discuss a proposal to give the City the right to clean up graffiti, he thinks property owners need to take responsibility for their own property. This tool would work best for absentee landlords or utilities, but he does not think that the City should be in the business of repainting the city.

Erik Wagner, Wagner Insurance, 1375 State, Marysville.

Mr. Wagner said his business has been hit by graffiti vandals numerous times. He cautioned against making the victim of the crime into the criminal. He feared this might happen if the owner was not able to remove the graffiti in the required timeframe because of extenuating circumstances. He recommended that it should be against the law for a youth to carry a concealed paint can on their person. City Attorney Grant Weed said that this is the law in California, but not here. Mr. Wagner also supported requiring offenders to clean up graffiti.

Craig Shankle, Resident, Marysville.

Mr. Shankle supported Mr. Wagner's position. He does not think that property owners should be held responsible. He was shocked at the young age of the offenders. In addition to other criminal penalties, Mr. Shankle suggested requiring enrollment of the youth in some sort of an after school art school as a creative outlet. He also suggested the creation of a Marysville Citizens Academy for juniors.

City Attorney Weed clarified that the violation for the property owner would not be a criminal penalty; it would be a civil infraction with a fine up to \$25. He further commented that the City court does not have jurisdiction to handle cases of kids under 18. Staff is working to get the court to understand the impact of this kind of activity.

Chief Turner agreed that they have no intent to criminalize the victims. The intent is to obtain compliance from businesses in removing the graffiti as quickly as possible.

Paul Roberts reviewed the PSA and explained that it would provide stormwater design services.

Jeff Vaughan recognized Mike Robinson for his assistance in apprehending a vandal.

Jeff Seibert thanked the graffiti removal volunteers.

He noted that there appears to be an abandoned vehicle on 80th Street. He noted that 80th Street is becoming a truck parking lot at night.

The CITY OF MARYSVILLE, a first-class municipal corporation of the State of Washington (hereinafter the "City"), with offices located at City Hall, 1049 State Avenue, Marysville, Washington, 98270, and THE GREATER MARYSVILLE TULALIP CHAMBER OF COMMERCE, 8825 34th Avenue NE, Suite C, Marysville, Washington, 98271 (hereinafter the "Contractor"), in consideration of the mutual covenants herein, do hereby agree as follows:

- I. PURPOSE: This Agreement covers the partial funding of a Visitor & Community Information Center which is a joint economic development project of The Greater Marysville Tulalip Chamber of Commerce, the City of Marysville and the Tulalip Tribes.
- II. TERM OF AGREEMENT: Notwithstanding the date of execution hereof, this Agreement shall be in effect from January 1, 2007 to December 31, 2007, both dates inclusive.
- III. LIAISON: The City's officer responsible for this Agreement is Mary Swenson, the Chief Administrative Officer. The Contractor's responsible person is Caldie Rogers, the President/CEO.
- IV. SCOPE OF WORK: See Exhibit "A" attached and incorporated herein by this reference.
- V. PAYMENT: Contractor shall be paid \$31,000.00 per year payable in the first quarter of 2006.
- VI. EXTRA WORK AND CHANGE ORDERS: Work in addition to, or different from, that provided for in the Scope of Work section, shall only be allowed by prior authorization in writing, as a modification to this Agreement. Such modifications shall be attached hereto and made a part hereof, and shall be approved in the same manner as this Agreement.
- VII. LIABILITY AND INSURANCE: The Contractor agrees to defend the City, hold it harmless, and indemnify it as to all claims, suits, costs, fees and liability arising out of the acts or work of the Contractor, its employees, subcontractors, or agents (including field work) pursuant to this Agreement, where such liability is incurred as a result of the actions or omissions of such parties. Contractor will obtain and maintain in force at least the following minimum insurance coverage covering all activity under this Agreement, and as to which the City shall be named as additional insured:
 - A. Workers Compensation
 - B. Broad Form comprehensive General Liability

Statutory Amount \$1,000,000

C. Automobile Liability \$ 500,000

Contractor specifically and expressly waives any immunity that may be granted it under the Washington State Industrial Insurance Act, Title 51 RCW. Further, the indemnification obligation under this contract shall not be limited in any way by any limitation on benefits payable to or for any third party under the workers' compensation acts.

An insurance certificate showing the coverage required under this paragraph VII will be submitted to the City annually. The City, its officers, agents and employees shall be named as additional insured's as it respects the obligations under this agreement.

VIII. COMPLIANCE WITH LOCAL LAWS: The Contractor shall comply with all applicable laws, ordinances, and codes and statutes of the State and local governments.

IX. DEFAULT AND REMEDIES:

- A. Should either party hereto believe that the other has failed to substantially perform all or a material part of its obligations under the Agreement, it shall deliver written notice to that effect to the other, specifying the alleged default and giving the other party fifteen (15) days to cure such default. Thereafter, should the default not be remedied to the satisfaction of the non-defaulting party, this Agreement may be terminated by the non-defaulting party upon seven (7) days written notice (delivered by certified mail).
- B. In the event of default by either party, the non-defaulting party may, at its option, bring suit to either recover damages resulting from the default or, alternatively, seek specific performance of this Agreement.
- C. Should a party file suit to enforce the provisions of this Agreement, including without limitation a suit seeking damages for default, the substantially prevailing party shall be entitled to recoup its legal expenses, including reasonable attorney's fees incurred, in connection with such effort.
- D. If either party defaults without legal excuse in timely fulfilling any monetary obligation owed to the other party hereunder, the obligation shall bear 12% simple interest from the date of default until paid in full.
- X. ASSIGNMENT: Neither party shall assign or delegate any or all interests in this Agreement without first obtaining the written consent of the other party.
- XI. VENUE STIPULATION: This Agreement has been and shall be considered as having been made and delivered within the State of Washington, and shall be governed by the laws of the State of Washington both as to interpretation and performance. Any action in law or equity, or judicial proceeding for the enforcement of this Agreement or any of the

provisions contained therein, shall be instituted and maintained only in Snohomish County Superior Court, Everett, Washington.

XII. STATUS OF CONTRACTOR: Neither the Contractor nor personnel employed by the Contractor shall acquire any rights or status in the City's employment, nor shall they be deemed employees or agents of the City for any purpose other than as specified herein. Contractor shall be deemed an independent contractor and shall be responsible in full for payment of its employees, including workers' compensation, insurance, payroll deductions, and all related costs. Further, Contractor represents that it is customarily in the business of providing the services described in this Agreement, has its own place of business, is eligible for and does file with the Internal Revenue Service a schedule of business expenses, has established an account with the State Department of Revenue and has received a unified business identifier number, and maintains a separate set of books and records for such business.

VISITOR & COMMUNITY INFORMATION CENTER

SCOPE OF WORK

The goal of the Visitor & Community Information Center (VCIC) is to strengthen area economy by promoting the greater Marysville Tulalip area as a desirable place to visit whether for leisure, business, or culture with a focus on enhancing the visibility and growth of businesses within the visitor market; and 2) promoting the greater Marysville Tulalip area as a desirable place to invest and live in.

Free travel and recreation counseling services will be provided to visitors and residents 9:00 a.m. to 5:00 p.m., seven days a week from Memorial Day through Labor Day and Mondays through Fridays from Labor Day to Memorial Day. Free community and business information will be provided to residents, current and potential investors and businesses year-round Mondays through Fridays from 9:00 a.m. to 5:00 p.m.

A summary of contacts and services rendered will be tracked and reported monthly in writing to the City's project manager.

The Chamber's scope of work regarding the Visitor & Community Information Center will include:

- Organize and coordinate an ongoing Volunteer Travel Counselor Development Program to include recruitment, placement, training, supervising, recognition and evaluation of volunteers;
- Plan and direct the activities of the Visitor & Community Information Center including: developing a comprehensive information network, monitoring and updating changes in information, collecting and distributing literature and materials, providing promotional display areas in the Visitor & Community Information Center, and providing Voter's Registration services;
- Develop cooperative relations with local and statewide chambers of commerce, information centers, visitor and convention bureaus, local community service organizations, other tourist attractions and the State of Washington's Division of Tourism, providing an environment required to adequately respond to requests from visitors, locals and businesses for information and referrals;
- Coordinate approved public use of chamber facilities including scheduling use, supervising and monitoring use, assisting users as required, and identifying and reporting safety and maintenance concerns;

- Maintain and distribute literature and materials reasonably required for the proper and efficient operation of the Visitor & Community Information Center;
- Collect and display tourism and recreation promotional videos;
- Maintain a record keeping system, resource library and community information data bases;
- Manage the administrative functions of the Visitor & Community Information Program including: recruiting, hiring, training, supervising and evaluating the Visitor Services staff, includes full-time, part-time, temporary, interns and students.
- Serve as a distribution point for materials generated and provided by the City's economic development committees.
- Assist the City's economic development efforts by providing available information to committees as requested.
- Direct businesses seeking relocation to the City's Community Development Director or appropriate City staff.
- Provide a monthly report documenting businesses seeking location and/or relocation to the region.
- Work collaboratively with City staff to ensure that efforts are not duplicated and enhanced services are provided to both parties.

In an effort to keep all parties informed with the progress and successes of this agreement the parties agree to the following:

- The Chamber President will meet on a monthly basis with the City's Chief Administrative Officer to ensure adequate lines of communication exist between both parties.
- The Chamber President/CEO and four Chamber Board members will meet with the Mayor, Chief Administrative Officer and three Council members, on an as needed basis to review the status of the contract.

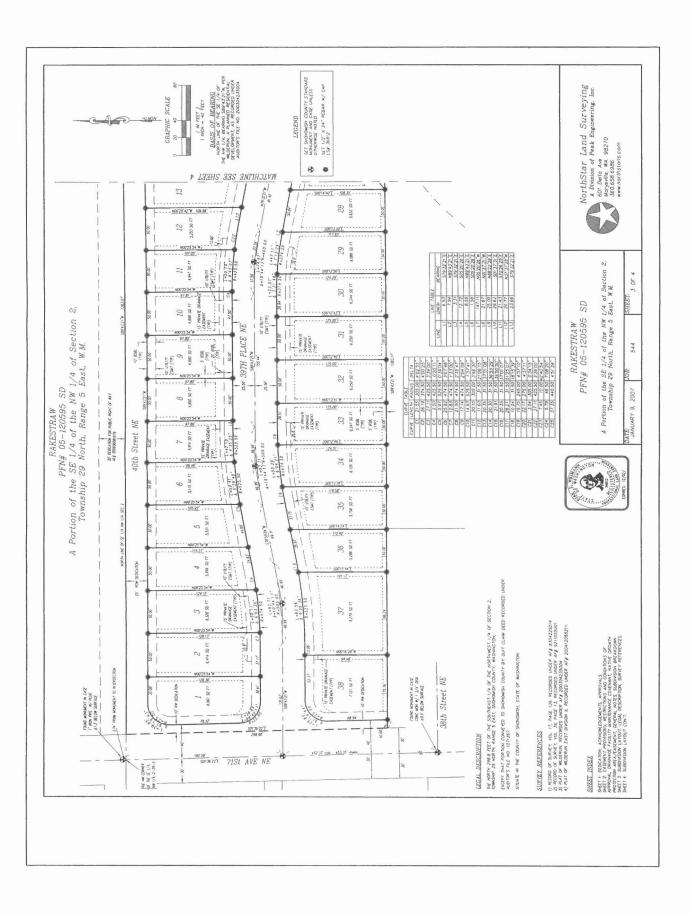

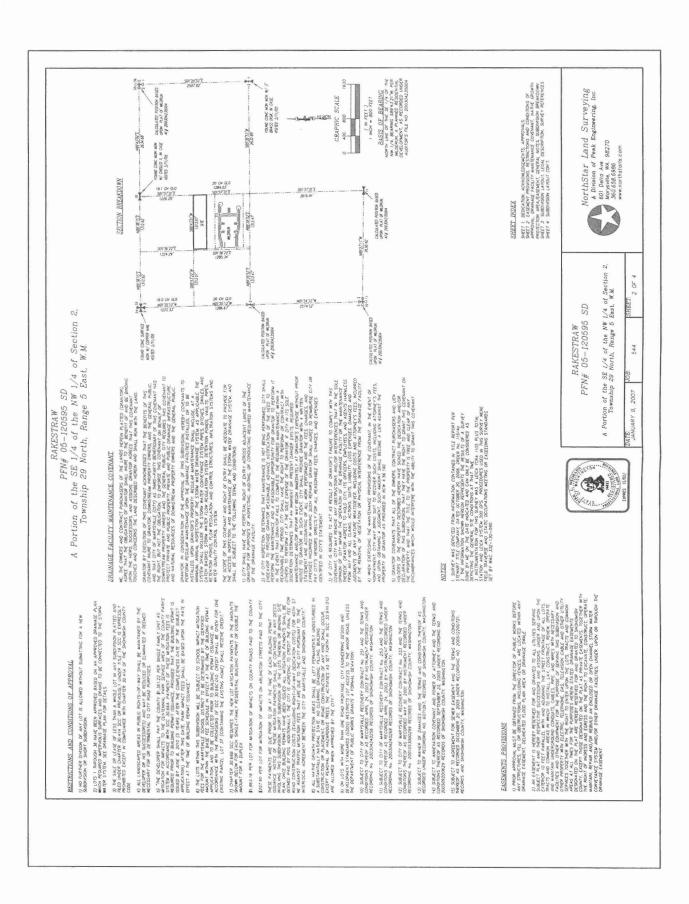

Summary Statement:

The Community Development Department is requesting approval of a contractual agreement for Professional Plans Examiner Services associated with Community Development Department. The Building Division is requesting this contract for Pac Rim Code Services to provide Plans Examiner services to the City of Marysville. City staff will continue to conduct the majority of building plan reviews. Pac Rim provides support during periods of high permit volume in order to meet permit review timelines. This service was anticipated in the 2007 approved budget.

AGREEMENT FOR PERSONAL SERVICES

THIS AGREEMENT is entered into between the CITY OF MARYSVILLE, a municipal Corporation, hereinafter referred to as the "CITY" and Pac Rim Code Service, Tim Nordtvedt, hereinafter referred to as "Consultant".

1. **PURPOSE.** The purpose of this Agreement is to provide for professional Plan Examiner service associated with Community Development Department for the City of Marysville, Washington.

2. **TERM OF AGREEMENT.** This Agreement will commence in January 2007 and terminate on December 31, 2007.

3. **SCOPE OF SERVICES TO BE PROVIDED.** The Consultant will review plans for Conformance with the current International Building Code Requirements, as adopted by the City. The Consultant will provide written documentation and communicate with the City staff regarding Review of residential and commercial plans. The Consultant will meet with city staff as necessary and as agreed to by the parties to discuss review procedures and comments. The Consultant may be required to perform other related work upon request.

Consultant agrees to allow the City and other persons authorized by the City to periodically review the progress of work and work product at any reasonable time.

4. **COMPENSATION.** The City will pay the Consultant at the rates described herein:

5. **INDEPENDENT CONTRACTOR.** Both the City and the Consultant agree that the Consultant will act as an independent contractor in the performance of his duties under this Agreement. Accordingly, the Consultant shall be responsible for the payment of all benefits and taxes including, but not limited to, unemployment, federal withholding for incoming tax, FICA, industrial insurance, business license fee, and any other fees, taxes or other obligations imposed by law as required.

6. **WORK PRODUCT.** The consultant agrees that all work product generated by his or her efforts will be the sole property of the City.

7. **EMPLOYMENT OF OTHERS.** The Consultant agrees to perform all work under this Agreement and will not subcontract or assign the work required under this Agreement to any other person without the express consent of the City.

8. **ENTIRE AGREEMENT.** This agreement constitutes the entire agreement between the parties. No other agreement, either written or oral, shall be binding on the parties.

Whereas graffiti has continued to be an escalating problem in the City, the City Council has directed the creation of a Graffiti Task Force that has been meeting since September 2006. That Task Force now recommends approval of changes to the existing ordinance on Graffiti Nuisance. As part of the Task Force, the Marysville Chamber has conducted a survey supporting this ordinance and is attached for Council review. Changes to the ordinance include shortening the time period for abatement from 30 days to 48 hours and seeks voluntary cooperation of retail merchants who sell paint and markers to limit access to these implements to minors. The ordinance holds both the owners and tenants responsible for the removal of graffiti within 48 hours.

RECOMMENDED ACTION:

Staff recommends that Maryville City Council approve changes to Municipal Code 6.25 entitled, Graffiti Nuisance Ordinance and authorize the Mayor to sign the ordinance.

ORDINANCE NO.

AN ORDINANCE OF THE CITY OF MARYSVILLE, WASHINGTON AMENDING CHAPTER 6.25 OF THE MARYSVILLE MUNICIPAL CODE RELATING TO ABATEMENT AND REMOVAL OF GRAFFITI.

WHEREAS, in 1999 the Marysville City Council adopted Ordinance 2295 (codified as Chapter 6.25 of the Marysville Municipal Code) to address the abatement and removal of graffiti; and

WHEREAS, the Marysville City Council finds that there has been a significant increase in the number of incidents involving graffiti and the associated defacing and vandalism to public and private property; and

WHEREAS, certain types of graffiti which have been identified in and around Marysville and Snohomish County is associated with the presence of gang activity; and

WHEREAS, the Mayor and City Council have formed a committee consisting of elected officials, City staff, school district representatives, business community representatives and citizens to study and make recommendations to address graffiti and gang related activity in and around the City; and

WHEREAS, the City Council wishes to request the Marysville business community, on a voluntary basis, to restrict access to aerosol paint and indelible markers to minors under the age of 18 years; and

WHEREAS, one measure recommended by the Graffiti Committee was to prepare amendments to MMC Chapter 6.25, to address the time period for removal of graffiti and to encourage restrictions to accessibility of the tools of graffiti, namely aerosol paint and indelible markers;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MARYSVILLE, WASHINGTON DO ORDAIN AS FOLLOWS:

Ordinance 2295 as codified in Chapter 6.25 of the Marysville Municipal Code is hereby amended to read as follows:

GRAFFITI NUISANCE

Sections:

6.25.010 Graffiti deemed nuisance.
6.25.020 Definitions.
6.25.030 Continued presence of graffiti an infraction.

6.25.050 Appeal.
6.25.060 Removal by city.
6.25.070 City cost recoverable – Debt – Lien.
6.25.075 Sale or gift of aerosol paint and indelible markers.
6.25.080 Severability.

6.25.010 Graffiti deemed nuisance.

Graffiti and other defacement of public and private property, including walls, rocks, bridges, fences, gates and other structures, trees, and other real and personal property within the city, constitutes a nuisance.

Although it is appropriate, where possible, to request that the courts require people who are convicted of acts of malicious mischief and vandalism involving the application of graffiti to public or private property to restore the property so defaced, damaged or destroyed, oftentimes it is difficult to identify, or to identify and convict, the wrongdoer.

The continued presence of graffiti is a blight on the community. While voluntary graffiti removal should be encouraged, where graffiti has not been promptly removed, graffiti should be removed in accordance with the provisions of this chapter.

6.25.020 Definitions.

For the purposes of this chapter, the following words shall have the following meanings:

(1) "Abate" means the removal, painting over, or other obscuring of graffiti from view as directed by the notice provided for in MMC 6.25.040.

(2) "Graffiti" means the defacing, damaging or destroying by spraying of paint or marking of ink, chalk, dye or other similar substances on public or private buildings, structures, facilities, natural features, and places.

(3) "Graffiti nuisance property" means property upon which graffiti exists and where, after notice as provided by this chapter, the graffiti has not been abated by the deadline set in a notice as established by this chapter.

(4) "Indelible marker" shall mean any marker, pen or similar implement containing anything other than a solution which can be removed

ORDINANCE - 2 W/mv/ord.am6.25abate.graffiti.RED with water after it dries and having a flat, pointed or angled writing surface of a width of 4 mm or greater.

(5) "Owner" means any entity or entities having a legal or equitable interest in real or personal property including but not limited to the interest of a tenant or lessee.

(6) "Pressurized container" shall mean any can, bottle, spray device or other mechanism designed to propel liquid which contains ink, paint, dye or other similar substance which is expelled under pressure either through the use of aerosol devices, pumps or similar propulsion devices.

(7) "Responsible party" means an owner, and also an entity or person acting as an agent for an owner, or an entity or a person who has dominion and control over a property. There may be more than one responsible party for a particular property.

6.25.030 Continued presence of graffiti an infraction.

It shall be a civil infraction for a responsible party to allow a graffiti nuisance property to exist. Each day a graffiti nuisance property shall exist shall be a separate infraction. A civil infraction under this chapter shall be punishable by a penalty of \$25.00 for each violation.

6.25.040 Graffiti- Notice of removal.

(1) Whenever graffiti exists and is visible to any person of normal eyesight utilizing any public road, parkway, alley, sidewalk or other facility open to the general public, the responsible person shall abate such graffiti nuisance within 48 hours of the placement of such graffiti.

(2) Whenever the responsible party fails to abate and remove graffiti as set forth in (1) above, and whenever the Mayor or his/her designated representative determines that graffiti exists a notice shall be issued to the responsible person to abate the nuisance by a stated deadline, which shall be no more than 48 hours after the date of the notice unless weather or seasonal conditions require a longer deadline.

(3) The giving of notice as required by this section shall be accomplished by providing the notice to the responsible party in any one of the following ways:

(a) By personal service on the responsible party;

(b) By registered or certified mail, postage prepaid, properly addressed and mailed to the last known address of the responsible party and to the address of the party.

(4) The notice shall be as established by the Chief of Police. The notice shall include a list of community resources and references where the property owner may seek assistance in the eradication of graffiti.

Deleted: (1) Whenever the mayor, or his/her designated representative, determines that graffiti exists and the same is visible to any person of normal eyesight utilizing any public road, parkway, alley, sidewalk, or other facility open to the general public, a notice shall be issued to the responsible person to abate the nuisance by a stated deadline, which shall be no more than 30 days after the date of the notice unless weather or seasonal conditions require a longer deadline.

6.25.050 Appeal.

The hearing examiner for the city of Marysville hereby is given jurisdiction to hear appeals of a "Notice of Graffiti, of Graffiti Nuisance Property and Removal."

An appeal shall be commenced by filing a notice of appeal with the city clerk within 10 days after the service of the "Notice of Graffiti, of Graffiti Nuisance Property and Removal" on the party or parties to whom the notice is directed. If no appeal is filed within said 10 days, the "Notice of Graffiti, of Graffiti Nuisance Property and Removal" shall become final and conclusive, and not subject to appeal or review in any forum.

In any appeal, the city shall have the burden to prove by a preponderance of the evidence that the property contains graffiti, the named party is a responsible party, the deadline for abatement is reasonable and should not be adjusted for weather or seasonal conditions, and the manner of abatement is reasonable.

If the hearing examiner finds that the property contains graffiti and that the named party is a responsible party, but that either the manner of abatement is not reasonable, or the deadline should be extended for seasonal or weather conditions, then the hearing examiner shall modify the manner of abatement to make the same reasonable or extend the deadline a reasonable period to account for seasonal or weather conditions, as the case may be.

The hearing examiner shall issue a written decision containing the following information: (1) findings of fact (which shall include the common address and legal description for the property) and conclusions of law; (2) the manner of any required abatement action and the deadline by which abatement must be completed; (3) a description of the civil penalty for an infraction which may accrue if the responsible party fails to abate the graffiti by the deadline established in the decision and order; (4) a statement that the decision of the hearing examiner becomes final 21 days after the date of the decision unless the decision of the hearing examiner is appealed to the Snohomish County Superior Court; and (5) a statement that if the graffiti is not abated by the deadline established in the decision and order that the city or its contractor may abate the graffiti and the cost of abatement will be a personal obligation of the responsible party and a lien against the graffiti nuisance property.

(1) The hearing examiner shall mail his/her decision to the named party by regular and certified mail, and a copy of the decision also shall be posted on the property in a conspicuous location.

(2) Any review of the decision of the hearing examiner must be by land use petition filed within 21 days of issuance of the decision and order in the Snohomish County Superior Court in accordance with the Land Use Petition Act.

ORDINANCE - 4 W/mv/ord.am6.25abate.graffiti.RED

6.25.060 Removal by city.

When the deadline established under this chapter has passed, and the property is deemed graffiti nuisance property, the city may abate the graffiti nuisance property. Either city resources or contractors may be used in abating the graffiti nuisance property.

Using any lawful means, the city and its representatives may enter upon the graffiti nuisance property and abate the graffiti. The city may seek such judicial process or writ as is deemed necessary to carry out the abatement.

6.25.070 City cost recoverable- Debt - Lien.

If the city is required to remove graffiti and abate a graffiti nuisance property, the city shall bill the cost of removal and abatement to the responsible party. The costs billed shall be due and payable to the city within 10 calendar days of billing. The costs billed shall include the value of the use of city staff and resources <u>at the current established hourly rate</u> and all payments made to third parties.

If the costs billed are not paid when due, they shall be a personal debt of the responsible party and automatically the costs shall be a lien upon the graffiti nuisance property. The city may take all lawful action to collect the debt of the responsible party or to foreclose its lien upon the graffiti nuisance property.

6.25.075 Sale or gift of aerosol paint and indelible markers.

On a voluntary basis, the Marysville City Council requests and encourages all businesses within the City and all citizens to refrain from selling, offering to sell, cause to be sold, giving or lending any aerosol paint or pressurized container of paint or any indelible marker to any minor under the age of 18 years. Businesses are encouraged to require picture identification for all persons who may be under the age of 18 years. All businesses who offer for sale aerosol paint or indelible markers are requested to voluntarily restrict access to those items from the public by either placing them behind a locked counter, cabinet or other storage facility so that access to them cannot be gained without their being unlocked by an authorized employee or other authorized representative of such business or by placing them in a location where they can be in constant, uninterrupted view of an authorized employee or other authorized representative of such business. Within one year of the effective date of this ordinance the City Council shall review the effectiveness of this section and shall consider whether such provisions shall be made mandatory rather than voluntary.

6.25.077 Rewards.

ORDINANCE - 5 W/mv/ord.am6.25abate.graffiti.RED **Deleted:** (which is hereby established as \$22.50 per hour)

The City may offer a reward not to exceed \$300.00 for information leading to the identification and apprehension of any person who willfully damages or destroys any public or private property by the use of graffiti. The actual amount awarded (not to exceed \$300.00) shall be determined in the discretion of the Chief of Police. In the event of damage to public property, the offender or the parents or legal guardian of any unemancipated minor must reimburse the City for any reward paid. In the event of multiple contributors of information, the reward amount shall be divided by the City in the manner it shall deem appropriate. Claims for rewards under this section shall be filed with the Chief of Police or his designee in the manner specified by the Marysville Police Department. No claim for a reward shall be allowed unless the City investigates and verifies the accuracy of the claim and determines that the requirements of this section have been satisfied.

6.25.080 Severability.

The provisions of this chapter are declared to be separate and severable. If any clause, sentence, paragraph, subdivision, section, subsection or portion of this chapter, or the application thereof to any person or circumstance, is held to be invalid, it shall not affect the validity of the remainder of this chapter, or the validity of its application to other persons or circumstances.

RE: Proposed Amendments to Graffiti Ordinance

Dear Council Members,

One behalf of the members of The Greater Marysville Tulalip Chamber of Commerce, I want to thank you for asking us to sit on the City's Graffiti Taskforce. Our involvement has been clear from the beginning – to represent the business community, especially small businesses, to insure our city has the highest quality of life while minimizing the impacts new requirements may have on business. In that regard, our Chamber mass mailed information on this ordinance to both its membership and the remaining licensed business community as well as concurrently conducted a survey to analyze our members' support, as well as their concerns, towards each element of the proposed amendments. Attached is a copy of the results of our survey, as well as a summary of many of the comments we received.

Our Chamber Government Affairs Committee and Board of Directors have reviewed the results of our survey along with the comments from our members and have developed recommendations that we believe strongly must be considered in approving a final version of ordinance.

Our Chamber supports a new graffiti ordinance that incorporates the following:

- Removal of graffiti by the business or individual within 48 hours.
- A provision that clarifies the definition of "responsible party" in MMC CH. 6.25.040 and clarifies how the city will attempt to contact property owners/landlords in the case where the premises are occupied by tenant businesses that may or may not have the authority within their leases to perform the required abatement. Further, given that MMC Ch. 6.25.070 allows the city to abate the graffiti and recover the cost through a lien, the Chamber is concerned with insuring that a tenant's lack of responsibility in notifying their landlord of a nuisance notice will not have the potential to negatively impact the business affairs of the property owner/landlord.

- The Chamber believes strongly that the City should evaluate and consider a mechanism, such as a check-off at the time of the issuance of a business license, that will allow the City, should it have an abatement program in place (e.g. the abatement being provided by the Marysville Seniors Against Crime), to access that private property for the purposes of abatement. We recognize that this issue must also be coordinated in a manner that recognizes, as discussed above, that business are sometimes only tenants of property and not the owners that can legally give the permission required by the City in order to allow for abatement.
- In regards to the proposed new section, MMC Ch. 6.25.075, the Chamber strongly supports a **voluntary** program at this time that encourages local business to refrain from selling graffiti related products to minors less than 18 year of age, restricting the access to such products and/or placing such products in areas where they are more easily monitored. The Chamber believes that mandating these restrictions at this time will be burdensome and costly and that further consideration should be given to their effectiveness, especially if similar restrictions are not adopted in neighboring communities. Further, the Chamber supports review of these restrictions, as well as the effectiveness of the other amendments within this revised code, within one year of the ordinance's effectiveness. And, the Chamber strongly encourages the City to work with the Chamber prior to the initiation of this review to get notice to those businesses selling the products in question so that they can participate in any discussions regarding mandatory restrictions.
- The Chamber encourages the City, and offers its support, to work with neighboring jurisdictions to facilitate their consideration and adoption of similar codes to maximize the effectiveness of discouraging graffiti within our city and the communities that surround us.

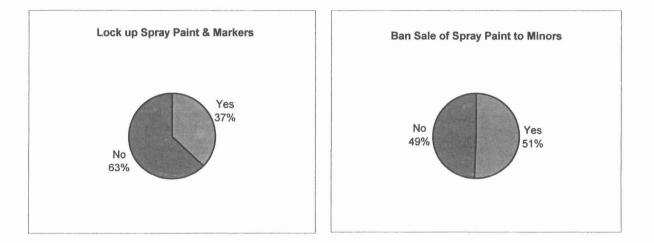

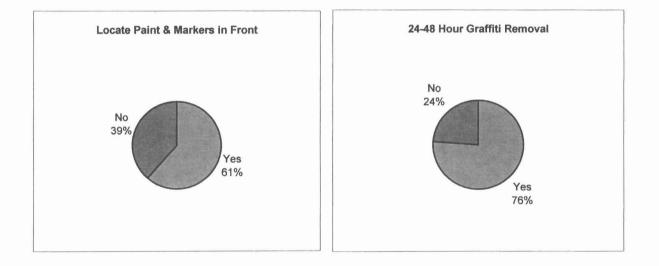

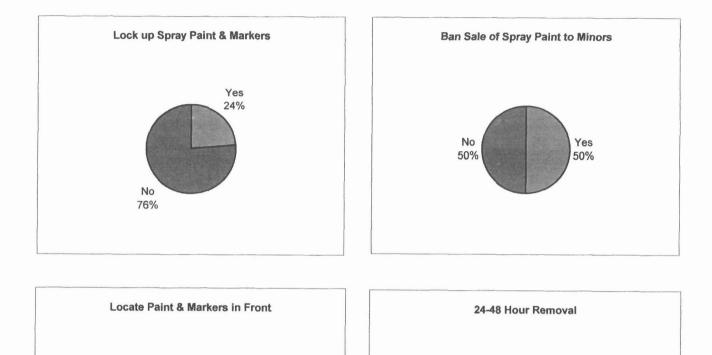

As a retailer it would be an undue hardship to expect a retailer to either lock up or specifically relocate a spray paint and/or a marker display. This would only thwart the shoplifter if you ban the sale of paint and markers to minors. Requiring the removal of graffiti is a good measure. Can you list the "Seniors Against Crime" to police this rather than Marysville Police? Might be a good idea. – Steve Ahmann

It's a shame that at a time in our community when there is traffic gridlock at exit 200 & 202, that instead of developing solutions to these problems our City Council wants to ban the sale of spray paint and markers to minors. Marysville City Council formally authorized the initiation of final design for the State Avenue 116th Street NE to 152nd Street NE Corridor Improvement Project in the spring of 2006. The design team has since undertaken and advanced the project's final design package, or "PS&E," up to 60% completion. In conjunction with this progress, significant strides have also been made with regard to permitting, NEPA environmental review, and Right of Way acquisition. Consequently, the project remains on track for construction later this year.

The authorization being requested through the current Council Action would facilitate additional engineering design services in the form of storm drainage analysis and design for approximately 3,700 feet of storm sewer — to be installed on State Avenue north of 152nd Street NE — as well as engineering design services necessary to incorporate the same into the larger project's PS&E package. Additionally, the work involves the incorporation of storm drainage design elements, already complete, from the "152nd Street NE Trunk Storm Sewer" plan set into the larger project's PS&E package. Ancillary work elements include necessary topographic surveying services and potholing of potential utility conflict locations.

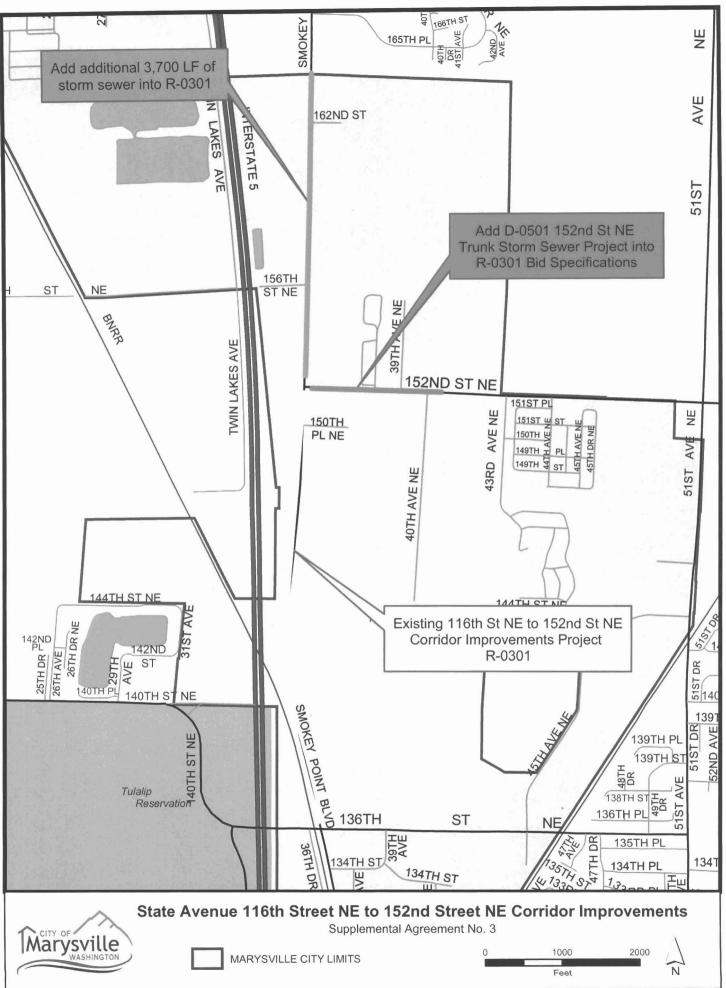

This Scope of Work is to detail the services required to integrate into the current State Avenue Roadway Improvements Project two additional storm drainage elements – comprised of 1) a stormwater conveyance system in Smokey Point Boulevard between 152nd Street NE and the Marysville/Arlington city limits, and 2) a stormwater conveyance system on 152nd Street NE, between State Avenue and the City's regional detention facility to the east. The second of these elements has already been advanced to 90% completion as the "152nd Street NE Trunk Storm Sewer" contract package. This effort will involve integration of that previously-completed design into the State Avenue contract plans and specifications. The first element involves design that has not yet been undertaken and, consequently, a larger portion of the work outlined herein. By combining these designs into the larger State Avenue contract package, the City believes that consequential *efficiencies of scale* will serve to drive down the total, aggregate construction cost well below what it would have been had these been let as three separate construction projects.

The CONSULTANT shall provide all labor and services necessary to complete the work of this AGREEMENT, including all supplies, equipment, software, incidentals, and materials except as designated elsewhere in this AGREEMENT. The CONSULTANT shall submit all work to the CITY in CITY format as it is detailed in the work elements.

The final contract plans shall be stamped with the seal of the consulting engineer.

30.0 PROJECT MANAGEMENT AND QUALITY CONTROL

- A. Project Management This Scope includes the project management and quality control and public involvement for the PS&E package for the project currently titled "State Avenue Roadway Improvements".
 - 1. Direction of the CONSULTANT staff and review of their work over the course of the PROJECT shall be provided. This work element includes preparing the monthly progress reports, monitoring the status of individual work elements, attending meetings, communicating outstanding information, and coordinating work items planned for the following month.
 - 2. Periodic monitoring of the PROJECT budget will occur over the course of the PROJECT. Current budget status shall be developed by the CONSULTANT. This work element is intended to help monitor costs and budgets and to propose corrective actions. These actions could include formal requests for budget increases or scope modifications or reduction. In the event that such requests are deemed necessary, they shall be forwarded to the City prior to commencement of associated work, and with sufficient detail so as to allow the City adequate opportunity to understand and respond to them on their merits.

This information will be filed to facilitate ready and selective retrieval. The status of requested information will be monitored.

B. SUBCONSULTANT Liaison

- 1. Direction of the SUBCONSULTANTS and review of their work over the course of the PROJECT shall be provided by the CONSULTANT. This work element includes reviewing the status of individual work element and monthly progress reports, attending meetings, and planning work items for the following month.
- 2. Monthly monitoring of the SUBCONSULTANTS budget shall occur over the course of the PROJECT. Current status will be developed. This work element is intended to help monitor costs and budgets and to propose corrective actions. These actions could include formal requests for scope/budget modifications. In the event that such requests are deemed necessary, they shall be forwarded to the City prior to commencement of associated work, and with sufficient detail so as to allow the City adequate opportunity to understand and respond to them on their merits.
- C. Create and Maintain the Schedule
 - 1. The CONSULTANT shall submit a comprehensive project schedule to the City no later than 5 working days after the date the AGREEMENT is executed. This schedule, as well as all supplemental schedules, shall be developed by a critical path method using Microsoft Project and shall show the following:
 - a. Completion of all work within the specified contract time.
 - b. The proposed order of work.
 - c. Projected starting and completion dates for major phases of the work (milestones) for the total project, as well as key subordinate tasks.
 - 2. The CONSULTANT shall submit supplemental project schedules at the bi-weekly status meetings or whenever there has been a change in the schedule affecting the critical path, and when requested by the City. Supplemental schedules shall reflect all changes in the proposed order of work and all affects to the progress of the work.
 - 3. Work shall consistently progress with the following major milestones:
 - a. Environmental documentation.
 - b. Permitting.
 - c. PS&E Completion / Advertisement / Award.
 - d. Right-of-way acquisition.

- D. Monthly Progress Reports and Invoices
 - 1. Monthly progress reports shall be prepared by the CONSULTANT in a format agreed to with the City's Project Design Engineer, and shall include a written report of the work performed by the CONSULTANT and SUBCONSULTANTS during the billing period.
 - Monthly invoices shall be prepared by the CONSULTANT for work activities for the prior month. These shall include SUBCONSULTANT'S work. Both the progress report and invoice shall be submitted at the same time.

Deliverables: Monthly Progress Reports and Invoices

- E. Coordination Meetings and Field Visits
 - 1. The CONSULTANT shall prepare for, attend, and document up to six additional coordination meetings with the City, and/or other affected agencies and SUBCONSULTANTS. Comprehensive minutes shall be prepared for each meeting by the CONSULTANT, and distributed to all participants no later than two days thereafter. The meetings will be held in the City.
- F. Quality Control/Assurance (QC/QA) Review.
 - 1. This task is for QC/QA review of CONSULTANT deliverables. The review will cover plans, cost estimates, and pertinent information on an ongoing basis. The work entails the periodic review of design criteria, assumptions, concepts, and presentation of product format, and assurances that the overall PROJECT objectives are being fulfilled.
 - 2. Additional quality review shall be provided by the City's liaison by reviewing work in progress. Also, individual disciplines and support groups within the City will be relied upon to review and provide direction of pertinent work items, and will coordinate with the CONSULTANT'S project manager and pertinent staff members.

While the City may fulfill some quality review function, as noted, the responsibility for quality control and assurance falls primarily to the CONSULTANT. Consequently, QA/QC review shall be performed by the CONSULTANT in a manner and to an extent that ensures only minimal need for subsequent QA/QC review and correction by the City.

31.0 ENVIRONMENTAL DOCUMENTATION

Land Use: The original scope of work assumed the City would provide land use data for the forecast year. The CONSULTANT was required to compile this data after discussions with the City.

152nd Intersection: After completing the Traffic Technical Report the City informed the CONSULTANT that a driveway permit had been issued to convert the 152nd intersection from a 3 –legged approach to a 4-legged approach. This resulted in additional work, consisting of revisions to the LOS analysis and report.

Design speed: After completing the Noise Discipline Report the State Avenue design speed was revised necessitating rerunning the noise model and revising the report.

WSDOT revisions: WSDOT required a different approach for the noise analysis and the report was revised to reflect the changes.

Cultural Resources: An off-site detention basin was added to the project scope. This required a field investigation and preparation of a cultural resources memorandum report.

Project Management: Additional project management was required for these services.

STORM DRAINAGE DESIGN

Storm Drainage Design Understanding and Scope of Work: Detention and stormwater treatment will be provided for the State Avenue Roadway Improvements Project in Marysville, Washington, based on the 2001 *Washington State Department of Ecology Storm Water Management Manual for Western Washington.* In order to fulfill regulatory compliance for storm drainage, the State Avenue Roadway Improvements project will be incorporated into a regional drainage system. This Scope of Services includes hydrologic and hydraulic modeling for the regional drainage system and plans, specifications, and estimates of the regional facilities.

1. The regional drainage system will provide detention and stormwater treatment for the following areas:

State Avenue Roadway Improvements from 136th Street NE to 152nd Street NE, widening from two to five lanes (approximately 10 acres).

State Avenue Roadway Improvements from 128th Street NE to 136th Street NE, widening from three to five lanes (approximately 5 acres).

Omni Development—located on east side of State Avenue, approximately 1,000 feet north of 128th Street NE (approximately 6 acres).

37 acres located on west side of Smokey Point Boulevard, approximately 1,000 feet north of 156th Street NE.

2. The regional facilities include elements from the original Agreement Scope of Work, as well as certain new elements (aforementioned):

Stormwater conveyance and collection for State Avenue Roadway Improvements from 136th Street NE to 152nd Street NE.

128th Street Pond improvements, approximately 40-foot expansion and pump station expansion.

Stormwater conveyance along Smokey Point Boulevard from 152nd Street NE to Marysville/Arlington city limits.

152nd Street NE trunk storm sewer.

Pond 1 outlet structure modifications.

Hayho Creek floodplain storage: Analyze effect of storage in hydraulic analysis.

32.0 DESIGN DEVELOPMENT

- A. Downstream Analysis:
 - 1. Provide downstream analysis for each of the three point of compliances (POCs) including:
 - a. POC#1 located at 156th Street NE and Interstate 5.

- b. POC#2 located at 128th Street and State Avenue.
- c. POC#3 located on Hayho Creek approximately 500 feet downstream of 136th Street at the BNSF railroad culvert.
- 2. At each POC, we will provide a detailed field reconnaissance for at least 1/4-mile downstream.
- B. Update Sub-basin Routing
 - 1. Update sub-basin routing that reflects the following:
 - a. Minimize the 128th Pond size to an expansion of approximately 40 feet to the west, which will provide stormwater treatment for the State Avenue road reconstruction and Omni Development. The 128th Pond will also provide partial detention on top of the treatment area.
 - b. A portion of the stormwater from Smokey Point Boulevard north of 152nd Street NE will be diverted to Pond 1 for additional detention in order to meet 85release rates at 128th Street NE and State Avenue. (POC#2)
 - c. Additionally, the Smokey Point Boulevard diversion will be modified to make use of flow attenuation available in the existing 152nd Street NE/Smokey Point Boulevard pond, so that a larger volume of runoff will be diverted to Pond 1 for stormwater treatment and detention.
 - d. Over-detention storage in the floodplain along Hayho Creek will be modeled to mitigate for the diverted flow into the Hayho sub-basin.
- C. Revise sub-basin delineation and impervious area calculations based on latest State Avenue Roadway Improvements from 128th Street NE to 152nd Street NE alignment provided by KPFF, Omni Development, and approximately 37 acres of development west of Smokey Point Boulevard to be connected to Pond 1.
- D. Update Ftables for 128th Pond, Pond 1, proposed conveyance systems along State Avenue and Smokey Point Boulevard, and flood plain storage along Hayho Creek.
- E. Run HSPF for predevelopment (re-run to account for pre-developed forest for adjustment in State Avenue alignment), post-developed, and interim (same as post-developed except only Reardon and Harley portion of 37 acres completed) conditions based on updated Ftables and sub-basins.
 - 1. Optimize 128th Pond and Pond 1 geometry and orifice pond configuration.
 - 2. Optimize flow splitter structures at 152nd Street NE and Smokey Point Boulevard and 128th Street NE and State Avenue.
 - 3. Size Hayho Creek floodplain storage.
 - 4. Provide City with available detention volume and stormwater treatment area in Pond 1 upon project completion.
- F. Size Conveyance Pipes with XPSWMM: Size conveyance pipes along State Avenue from 136th Street NE to 152nd Street NE and Smokey Point Boulevard from 152nd Street NE to the Marysville-Arlington boundary using XPSWMM.

- G. Update 152nd Street NE Trunk Storm Sewer Hydraulics: Update hydraulic analysis of conveyance system from the intersection of Smokey Point Boulevard and 152nd Street NE to Pond 1 with flow attenuation in the 152nd Street NE/Smokey Point Boulevard pond.
- H. Finalize 128th Street NE Pump Station Hydraulics: 128th Street NE Pump Station hydraulic analysis using XPSWMM including wet-well sizing, on-off levels, and intake and discharge pipe sizing.

Deliverables: Electronic copy of completed model.

33.0 HYDRAULIC REPORT

- A. Update and expand report to include discussions regarding:
 - 1. The revised tributary areas north of 152nd Street NE and west of Smokey Point Boulevard,
 - 2. Interim and final conditions for the flow control at Pond 1, where interim conditions includes only the existing developments north of 152nd Street NE,
 - 3. Hayho Creek floodplain storage requirements for final conditions,
 - 4. Hydraulics of the conveyance system north of 152nd Street NE, and
 - 5. The 128th Street NE pump station design.

Deliverables: Draft Stormwater Design Report.

Final Stormwater Design Report.

34.0 SURVEYING

A. Field Survey: CONSULTANT shall provide Marysville with field survey of existing surface features of the site to a level adequate for the preparation of a base map for final design of the stormwater conveyance along Smokey Point Boulevard. The survey will include topography breaks, pavement and other hardscape, significant trees (over 8 inches in diameter), utilities, striping, and appurtenant drainage structures necessary for final construction documents. A utility locate service will be retained in order to locate and mark underground utilities otherwise not marked for design from a "utility one-call" report. A "reflectorless" total station instrument will be used to collect much of the data in the traveled lanes. The use of this technology should prevent the need for extensive traffic lane closures to collect much of this data. A minimum amount of traffic control will be required for opening sanitary and storm sewer structures in order to measure invert elevations and identify structure and pipe size, type, and condition.

Existing street rights-of-way and other boundary monuments will be surveyed and used to establish the existing right-of-way alignment. Adjoining property lines of record will be shown.

The area that will be surveyed and mapped will include: Smokey Point Boulevard from the street centerline to the right-of-way margin (half street) from 152nd Street NE to 300 feet south of the Marysville/Arlington city limits. The total length is approximately 3,700 linear feet. CONSULTANT shall also locate the opposite flow line of the street for graphic purposes.

This proposal assumes that the CITY will obtain property access and right-of-entry, if needed, in order that CONSULTANT field surveyors can locate utilities or other features on private property.

- B. Prepare Project Base Map: A project base map will be prepared in AutoCAD. Project base maps will be prepared at a scale of 1 inch = 20 feet with 1-foot topographic contour intervals. Existing planimetric features, utilities, significant trees, and vegetation within the project area will be located and shown in the base maps. Base maps will include Washington State Plane NAD '83 horizontal and NAVD '88 vertical datum control information (or a designated project datum) for the project area. Note: only the project sites will be surveyed in detail.
 - **Deliverables:** Electronic AutoCAD (v.2004) files of all survey base map information will be provided to the City upon completion of work.

Survey products include a survey base map of the associated conveyance system, parcels, easements, and topography features.

Assumptions: We assume that no boundary surveys will be needed to establish the record boundaries of the adjoining fee simple properties. The adjoining parcel lines will be shown based on record information only and will not constitute a full boundary survey.

The right-of-way alignment will be surveyed and fully resolved. The right-of-way margins adjoining the Storm Conveyance design will be resolved based on available record information only.

We assume that no property support such as legal descriptions for easements or property acquisition will be required for this task. Should additional work be requested pertaining to a fee simple property then the CITY will provide title reports for any properties requiring easements or property acquisition.

The CITY will obtain necessary rights-of-entry permission for private properties prior to performing field survey work.

The CITY will provide any available information as to the location of underground utilities within the surveyed area, both public and private. CONSULTANT will coordinate with utility location services to conduct potholing, if needed.

35.0 PLANS, SPECIFICATIONS AND ESTIMATE

- A. Design the 128th Street NE stormwater treatment and detention pond to accommodate a new pump station utilizing existing pumps currently owned by the City, and reconfigure grading to accommodate new pump station location.
- B. Prepare 60 percent, 90 percent and Final construction plan and profile drawings and detail drawings for the stormwater collection and conveyance system in Smokey Point Boulevard between 152nd Street NE and the Marysville/Arlington city limits.

- C. Integrate the 152nd Trunk Storm Sewer plans into the existing State Avenue plan set format. This includes updating plan sheet drafting standards, standard notes, alignment references, details and sheet match-lines.
- D. Prepare additional special provisions for new pump station and new flow splitter designed by CONSULTANT. Special provisions will be prepared in CITY standard format for unit price contracts.
- E. Prepare opinions of probable construction cost for elements above. Coordinate identification of bid items and creation of bid proposal for elements previously designed under a separate contract that are to be integrated into the State Avenue plans.
 - **Deliverables:** 60 percent, 90 percent and Final Plans for 128th Street Pond modifications and pump station modifications.

Plans for Smokey Point Boulevard from 152nd Street to Marysville/Arlington City limits.

90 percent and 100 percent Plans for 152nd Trunk Storm Sewer.

60 percent, 90 percent, and Final Cost Opinion.

60 percent, 90 percent, and Final Special Provisions.

Assumptions: Design will be accomplished within a four-month timeframe.

As-built survey of the 128th Street NE pond to be provided by City.

Modifications to pumping station will include a total of (2) 5 horsepower pumps and (2) 15 horsepower pumps where one of the 15 horsepower pumps will act as a redundant pump.

Geotechnical/groundwater information required for storm drainage design and the 128th pond design will be provided by CONSULTANT.

No effort is included for participation in any permitting, public involvement, or Council Briefings for the two additional storm drainage elements that are being incorporated into the State Avenue plans.

All review and edit comments from the CITY shall be consolidated into one set of consistent (i.e., non-conflicting) written comments prior to transmittal to CONSULTANT for revisions.

If the CITY requests the WSDOT Northwest Region Stormwater Report Checklist and Template (June 2003), this will be undertaken as new additional work, and additional budget will need to be negotiated.

CONSULTANT shall provide services during project bidding. CONSULTANT will not provide support services during project award, construction, or closeout.

All project environmental documentation which may be necessary due to this Supplement will be provided by others. The electrical design for the pump station will be provided by design vendor to SUBCONSULTANT, and paid for as a direct expense to SUBCONSULTANT.

Utility Potholing (Contingency): CONSULTANT will hire a SUBCONSULTANT for the purpose of potholing the project site in order to accurately locate any utilities that need to be accounted and/or moved during the design and construction process. \$10,000 has been allocated for this service. This work will only be executed with specific written authorization to proceed.

END OF STORM DRAINAGE DESIGN

36.0 COST ESTIMATE AND SPECIFICATIONS

- A. The CONSULTANT shall review and prepare a 60 percent, 90 percent, and final construction cost estimate for all construction elements. Unit prices shall be reviewed and agreed upon for consistency between prime consultant and SUBCONSULTANTS.
- B. The CONSULTANT shall prepare contract specifications per the City's requirements. The draft specifications will be submitted with 90 percent Plans and Cost Estimate.
 - 1. Subconsultant plans and cost estimates shall be reviewed for consistency with previous plans format and presentation relative to clarity of bid items and work included within each bid item.
 - 2. Draft specifications from SUBCONSULTANTS will be reviewed and revised as necessary to provide consistency throughout the Bid Documents regarding work included within each unit bid item within the Bid Proposal.
 - 3. Format of quantity calculations for each bid item will be agreed upon, and revised as needed to provide consistent deliverable for all work within the Bid Documents.

Deliverables: Preliminary and final Specifications, Cost Estimate, and Documentation.

The City IS department was having difficulty filling a temporary position through it's normal agency, Robert Half. The candidates that Robert half provided did not meet the minimum knowledge or experience requirements of the position. We put out a request to all City and County IT Directors for recommendations to replace Robert Half. North Resource was recommended to us by the City of Everett. North Resource is a technology consulting firm that specializes in placing advanced technology consultants with businesses.

The position that Exhibit A outlines is to replace an employee who left the City in late December. This temporary position's primary duties will be to help implement the City's new Exchange Server and several other smaller projects. This position's permanent job description is currently being reviewed by HR and we intend to post for a permanent replacement as soon as the review is complete and Council approves the new job description.

RECOMMENDED ACTION:

City staff recommends that the City Council authorizes the Mayor to sign the attached Service Agreement and Exhibit A from North Resource Inc..

COUNCIL ACTION:

North Resource, Inc. SERVICE AGREEMENT

This agreement is entered into this 5th day of February 2007 ('Effective Date") by and between City of Marysville (herein after referred to as the "Client") with offices located at 1049 State Avenue, Marysville WA 98270 and North Resource, Inc. (hereinafter referred to as "NORTH RESOURCE, INC. ", a Corporation with its office located at 17035 166th Place SE, Renton W A 98058.)

1. North Resource, Inc. Services

North Resource, Inc. is to furnish qualified personnel to provide technical services to Client in the areas of consulting, systems analysis and design and/or programming services, as well as any other related duties that might be applicable to Client's data processing requirements. Particulars of the services to be provided by North Resource, Inc. to Client are set forth on Exhibit A attached hereto, together with any amendments to Exhibits A which may be agreed to by the parties during the term of North Resource, Inc. engagement hereunder.

2. Payment for Services

NORTH RESOURCE, INC. shall invoice Client on a semi-monthly basis for all services being performed pursuant to the provisions of Exhibit A, and any applicable local, state or federal sales, use or excise tax shall be added to the prices herein stated. Charges are payable to NORTH RESOURCE, INC fifteen (15) days of receipt of invoice. Client also agrees, if this Agreement is referred to an attorney for collection, to pay court costs plus reasonable attorney fees.

It is expressly understood and agreed to that the personnel furnished by the Contractor hereunder to perform the services provided for in Exhibit A hereof shall be and always will remain the contractors employee(s) or agent(s), and under no circumstances are such personnel to be considered the Client's employee(s) or agent(s), and, shall be ill an independent contractors, relationship to the Client at all times.

4. Non-Solicitation of Employees

During the term of this Agreement and for six (6) months thereafter, Client agrees not to solicit for employment nor employ, directly or indirectly (either as an employee, contractor, independent agent, or representative of another vendor), any employee of Contractor who is providing services to Client hereunder without prior written consent of Contractor and Contractor agrees that it will not solicit for employment, nor employ, directly or indirectly, any of Client's employees connected with the subject matter of this Agreement without the prior written consent of Client.

5. Facilities

To the extent the services to be provided for hereunder are to be performed upon Client's premises, Client agrees to supply North Resource, Inc. personnel with suitable work stations similar to those provided to Client's own employees of a similar position and Client further agrees to provide such personnel with all supplies and equipment needed by them to perform services for which they have been assigned.

Client reserves the right to terminate this Agreement in the event that Client notifies North Resource, Inc. in writing within the first ninety (90) days of this Agreement that it is not satisfied with the performance of North Resource, Inc. services under this Agreement. In such event, Client agrees that North Resource, Inc. shall have thirty (30) days after receipt of written notice in which to either provide Client with another employee, to

perform services for Client or modify the performance of its original employee, to the Clients satisfaction.

North Resource, Inc. reserves the right to terminate this Agreement in the event that Client shall be in default of a material provision of this Agreement and such default is not cured by Client within ten (10) days after written notice of default to Client. All notices from North Resource, Inc. to Client shall specify the nature of the default and the corrective action, if any, which may be taken by Client to cure the default.

9.2 **Termination without Cause**. Client reserves the right to terminate this Agreement in whole or in part upon thirty (30) days prior written notice to North Resource, Inc. The City of Marysville and its agents will soon begin the property acquisition phase for the State Avenue 116th Street NE to 152nd Street NE Corridor Improvement Project — for the purposes of widening the roadway from its existing configuration to a 5-lane section with curb, gutter, and sidewalks.

Fair market value compensation will be offered to the property owners in accordance with recently-completed appraisals. If the City and the property owners cannot reach a mutually agreeable settlement, the enclosed ordinance will allow the City to exercise eminent domain for the acquisition of property through condemnation proceedings. As noted, this Ordinance amends a previously adopted Ordinance – accounting for additional properties that will be subject to Right of Way acquisition due to the project. These properties lie generally to the south of 136th Street NE, and eastward of State Avenue.

A key reason for approving the attached ordinance at this time is for the benefit of the property owners so that the compensation they receive for the transfer of a portion of their property to the City will not be subject to real estate excise tax. As the attached **WAC 458-61A-206** states:

"Transfers of real property to a governmental entity under an imminent threat of the exercise of eminent domain, a court judgment or settlement with a government entity based upon a claim of inverse condemnation, or as a result of the actual exercise of eminent domain, are not subject to the real estate excise tax."

RECOMMENDED ACTION:

Staff recommends that the Council approve the Ordinance authorizing the condemnation, appropriation, taking, and damaging of land and other property for the improvement of State Avenue from 116th Street NE to 152nd Street NE.

AN ORDINANCE OF THE CITY OF MARYSVILLE, WASHINGTON, AMENDING ORDINANCE NO. 2655 TO INCREASE THE PORTION OF STATE AVENUE TO BE IMPROVED TO ENCOMPASS THE AREA FROM APPROXIMATELY 116TH STREET NE TO APPROXIMATELY 152nd STREET NE, AND ADDING LAND AND PROPERTY AUTHORIZED TO BE CONDEMNED, APPROPRIATED, TAKEN AND DAMAGED

WHEREAS, the City Council of the City of Marysville (hereinafter the "City") finds as follows:

1. Public safety, convenience, use and necessity demand the widening of State Avenue to five lanes from approximately 116th Street NE to approximately 136th Street NE, together with construction of curbs, gutters and sidewalks and expansion of detention pond capacity, to meet the requirements of increased traffic.

2. By Ordinance No. 2655 passed by the City Council on July 24, 2006, the City Council approved the condemnation, appropriation, taking and damaging of lands, rights, privileges and other property for the purpose of widening State Avenue from two to five lanes and constructing curbs, gutters and sidewalks, from approximately 136th Street NE to approximately 152nd Street NE.

3. The improvement of State Avenue from 116th Street NE to 136th Street NE can most efficiently and cost-effectively be accomplished by constructing said improvements with the 136th Street NE to 152nd Street NE improvements as a single project.

4. The City has conducted engineering studies and has determined that increasing the scope of the project will require acquiring property for the street widening as more specifically described in **EXHIBIT B** attached hereto and incorporated herein by this reference.

5. The City has conducted engineering studies and has determined that the widening of State Avenue will increase storm water, requiring increased detention pond capacity that can best be met by expanding the City's detention pond located on 128th Street NE west of the Burlington Northern Santa Fe Railroad spur, which expansion will require acquisition of a portion of Snohomish County tax parcel 300504-003-002-00 described in **EXHIBIT C** attached hereto and incorporated herein by this reference.

6. The entire cost of the acquisitions provided by this ordinance shall be paid by the following funds of the City:

Fund No. 305 (GMA-Street)

or such other funds as may be provided by law.

7. The City may be unable to agree with certain property owners upon the compensation to be paid for said properties.

8. The City has authority pursuant to RCW Chapter 8.12 to acquire, if necessary, title to real property for public purposes. The widening and improvement of State Avenue is a public purpose.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MARYSVILLE, WASHINGTON, DO ORDAIN AS FOLLOWS:

1. **EXHIBIT A** of Ordinance No. 2655 is hereby amended to add the properties described in **EXHIBIT B** and **EXHIBIT C** attached hereto and incorporated herein by this reference to the real property that the City is authorized to condemn, appropriate, take and damage in conjunction with the widening of State Avenue.

2. The use of the property described in **EXHIBIT B** is for widening State Avenue to five lanes and constructing curbs, gutters and sidewalks, from approximately 116^{th} Street NE to approximately 152^{nd} Street NE, which is a permanent public use and is reasonably necessary for the purposes for which it is sought.

3. The use of the property described in **EXHIBIT C** is for increasing detention pond capacity to accommodate increased storm water generated by the widening of State Avenue, which is a permanent public use and is reasonably necessary for the purposes for which it is sought.

4 All lands, rights, privileges and other property lying within the limits of the land described in **EXHIBITS B** and **C** are authorized to be condemned, appropriated, taken and damaged for the purpose of widening State Avenue to five lanes, and constructing curbs, gutters and sidewalks, from approximately 116th Street NE to approximately 152nd Street NE, and enlarging the City's existing storm water detention facility. All lands, rights, privileges and other properties are to be taken, damaged and appropriated only after just compensation has been made, or paid into the court for the owners thereof in the manner provided by law.

5. The cost of the acquisition provided for by this ordinance shall be paid by the following funds of the City:

Fund No. 305 (GMA-Street)

or such other funds as may be provided by law.

6. The City's attorneys should be and hereby are authorized and directed to begin and prosecute the actions and proceedings in a manner provided by law to carry out the provisions of this ordinance, and to enter into settlements to mitigate damages.

ORDINANCE NO.

AN ORDINANCE OF THE CITY OF MARYSVILLE, WASHINGTON AMENDING CHAPTER 6.25 OF THE MARYSVILLE MUNICIPAL CODE RELATING TO ABATEMENT AND REMOVAL OF GRAFFITI.

WHEREAS, in 1999 the Marysville City Council adopted Ordinance 2295 (codified as Chapter 6.25 of the Marysville Municipal Code) to address the abatement and removal of graffiti; and

WHEREAS, the Marysville City Council finds that there has been a significant increase in the number of incidents involving graffiti and the associated defacing and vandalism to public and private property; and

WHEREAS, certain types of graffiti which have been identified in and around Marysville and Snohomish County is associated with the presence of gang activity; and

WHEREAS, the Mayor and City Council have formed a committee consisting of elected officials, City staff, school district representatives, business community representatives and citizens to study and make recommendations to address graffiti and gang related activity in and around the City; and

WHEREAS, the City Council wishes to request the Marysville business community, on a voluntary basis, to restrict access to aerosol paint and indelible markers to minors under the age of 18 years; and

WHEREAS, one measure recommended by the Graffiti Committee was to prepare amendments to MMC Chapter 6.25, to address the time period for removal of graffiti and to encourage restrictions to accessibility of the tools of graffiti, namely aerosol paint and indelible markers;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MARYSVILLE, WASHINGTON DO ORDAIN AS FOLLOWS:

Ordinance 2295 as codified in Chapter 6.25 of the Marysville Municipal Code is hereby amended to read as follows:

6.25.010 Graffiti deemed nuisance.

Graffiti and other defacement of public and private property, including walls, rocks, bridges, fences, gates and other structures, trees, and other real and personal property within the city, constitutes a nuisance.

Although it is appropriate, where possible, to request that the courts require people who are convicted of acts of malicious mischief and vandalism involving the application of graffiti to public or private property to restore the property so defaced, damaged or destroyed, oftentimes it is difficult to identify, or to identify and convict, the wrongdoer.

The continued presence of graffiti is a blight on the community. While voluntary graffiti removal should be encouraged, where graffiti has not been promptly removed, graffiti should be removed in accordance with the provisions of this chapter.

6.25.020 Definitions.

For the purposes of this chapter, the following words shall have the following meanings:

(1) "Abate" means the removal, painting over, or other obscuring of graffiti from view as directed by the notice provided for in MMC 6.25.040.

(2) "Graffiti" means the defacing, damaging or destroying by spraying of paint or marking of ink, chalk, dye or other similar substances on public or private buildings, structures, facilities, natural features, and places.

(3) "Graffiti nuisance property" means property upon which graffiti exists and where, after notice as provided by this chapter, the graffiti has not been abated by the deadline set in a notice as established by this chapter.

(4) "Indelible marker" shall mean any marker, pen or similar implement containing anything other than a solution which can be removed

ORDINANCE - 2 W/mv/ord.am6.25abate.graffiti.RED with water after it dries and having a flat, pointed or angled writing surface of a width of 4 mm or greater.

(5) "Owner" means any entity or entities having a legal or equitable interest in real or personal property including but not limited to the interest of a tenant or lessee.

(6) "Pressurized container" shall mean any can, bottle, spray device or other mechanism designed to propel liquid which contains ink, paint, dye or other similar substance which is expelled under pressure either through the use of aerosol devices, pumps or similar propulsion devices.

(7) "Responsible party" means an owner, and also an entity or person acting as an agent for an owner, or an entity or a person who has dominion and control over a property. There may be more than one responsible party for a particular property.

6.25.030 Continued presence of graffiti an infraction.

It shall be a civil infraction for a responsible party to allow a graffiti nuisance property to exist. Each day a graffiti nuisance property shall exist shall be a separate infraction. A civil infraction under this chapter shall be punishable by a penalty of \$25.00 for each violation.

6.25.040 Graffiti- Notice of removal.

(1) Whenever graffiti exists and is visible to any person of normal eyesight utilizing any public road, parkway, alley, sidewalk or other facility open to the general public, the responsible person shall abate such graffiti nuisance within 48 hours of the placement of such graffiti.

(2) Whenever the responsible party fails to abate and remove graffiti as set forth in (1) above, and whenever the Mayor or his/her designated representative determines that graffiti exists a notice shall be issued to the responsible person to abate the nuisance by a stated deadline, which shall be no more than 48 hours after the date of the notice unless weather or seasonal conditions require a longer deadline.

(3) The giving of notice as required by this section shall be accomplished by providing the notice to the responsible party in any one of the following ways:

(a) By personal service on the responsible party;

(b) By registered or certified mail, postage prepaid, properly addressed and mailed to the last known address of the responsible party and to the address of the party.

(4) The notice shall be as established by the <u>Chief of Police</u>. The notice shall include a list of community resources and references where the property owner may seek assistance in the eradication of graffiti.

6.25.050 Appeal.

The hearing examiner for the city of Marysville hereby is given jurisdiction to hear appeals of a "Notice of Graffiti, of Graffiti Nuisance Property and Removal."

An appeal shall be commenced by filing a notice of appeal with the city clerk within 10 days after the service of the "Notice of Graffiti, of Graffiti Nuisance Property and Removal" on the party or parties to whom the notice is directed. If no appeal is filed within said 10 days, the "Notice of Graffiti, of Graffiti Nuisance Property and Removal" shall become final and conclusive, and not subject to appeal or review in any forum.

In any appeal, the city shall have the burden to prove by a preponderance of the evidence that the property contains graffiti, the named party is a responsible party, the deadline for abatement is reasonable and should not be adjusted for weather or seasonal conditions, and the manner of abatement is reasonable.

If the hearing examiner finds that the property contains graffiti and that the named party is a responsible party, but that either the manner of abatement is not reasonable, or the deadline should be extended for seasonal or weather conditions, then the hearing examiner shall modify the manner of abatement to make the same reasonable or extend the deadline a reasonable period to account for seasonal or weather conditions, as the case may be.

The hearing examiner shall issue a written decision containing the following information: (1) findings of fact (which shall include the common address and legal description for the property) and conclusions of law; (2) the manner of any required abatement action and the deadline by which abatement must be completed; (3) a description of the civil penalty for an infraction which may accrue if the responsible party fails to abate the graffiti by the deadline established in the decision and order; (4) a statement that the decision of the hearing examiner becomes final 21 days after the date of the decision unless the decision of the hearing examiner is appealed to the Snohomish County Superior Court; and (5) a statement that if the graffiti is not abated by the deadline established in the decision and order that the city or its contractor may abate the graffiti and the cost of abatement will be a personal obligation of the responsible party and a lien against the graffiti nuisance property.

(1) The hearing examiner shall mail his/her decision to the named party by regular and certified mail, and a copy of the decision also shall be posted on the property in a conspicuous location.

(2) Any review of the decision of the hearing examiner must be by land use petition filed within 21 days of issuance of the decision and order in the Snohomish County Superior Court in accordance with the Land Use Petition Act.

ORDINANCE - 4 W/mv/ord.am6.25abate.graffiti.RED

6.25.060 Removal by city.

When the deadline established under this chapter has passed, and the property is deemed graffiti nuisance property, the city may abate the graffiti nuisance property. Either city resources or contractors may be used in abating the graffiti nuisance property.

Using any lawful means, the city and its representatives may enter upon the graffiti nuisance property and abate the graffiti. The city may seek such judicial process or writ as is deemed necessary to carry out the abatement.

6.25.070 City cost recoverable- Debt - Lien.

If the city is required to remove graffiti and abate a graffiti nuisance property, the city shall bill the cost of removal and abatement to the responsible party. The costs billed shall be due and payable to the city within 10 calendar days of billing. The costs billed shall include the value of the use of city staff and resources <u>at the current established hourly rate</u> and all payments made to third parties.

If the costs billed are not paid when due, they shall be a personal debt of the responsible party and automatically the costs shall be a lien upon the graffiti nuisance property. The city may take all lawful action to collect the debt of the responsible party or to foreclose its lien upon the graffiti nuisance property.

6.25.075 Sale or gift of aerosol paint and indelible markers.

On a voluntary basis, the Marysville City Council requests and encourages all businesses within the City and all citizens to refrain from selling, offering to sell, cause to be sold, giving or lending any aerosol paint or pressurized container of paint or any indelible marker to any minor under the age of 18 years. All businesses who offer for sale aerosol paint or indelible markers are requested to voluntarily restrict access to those items from the public by either placing them behind a locked counter, cabinet or other storage facility so that access to them cannot be gained without their being unlocked by an authorized employee or other authorized representative of such business or by placing them in a location where they can be in constant, uninterrupted view of an authorized employee or other authorized representative of such business. Within one year of the effective date of this ordinance the City Council shall review the effectiveness of this section and shall consider whether such provisions shall be made mandatory rather than voluntary. **Deleted:** (which is hereby established as \$22.50 per hour)

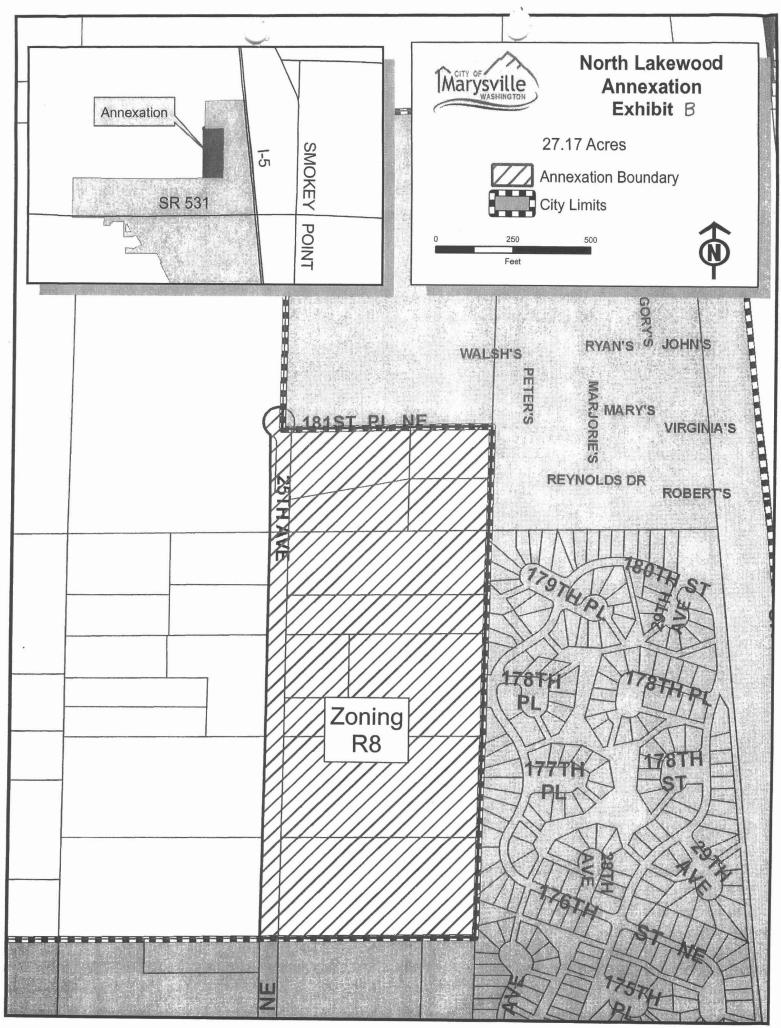

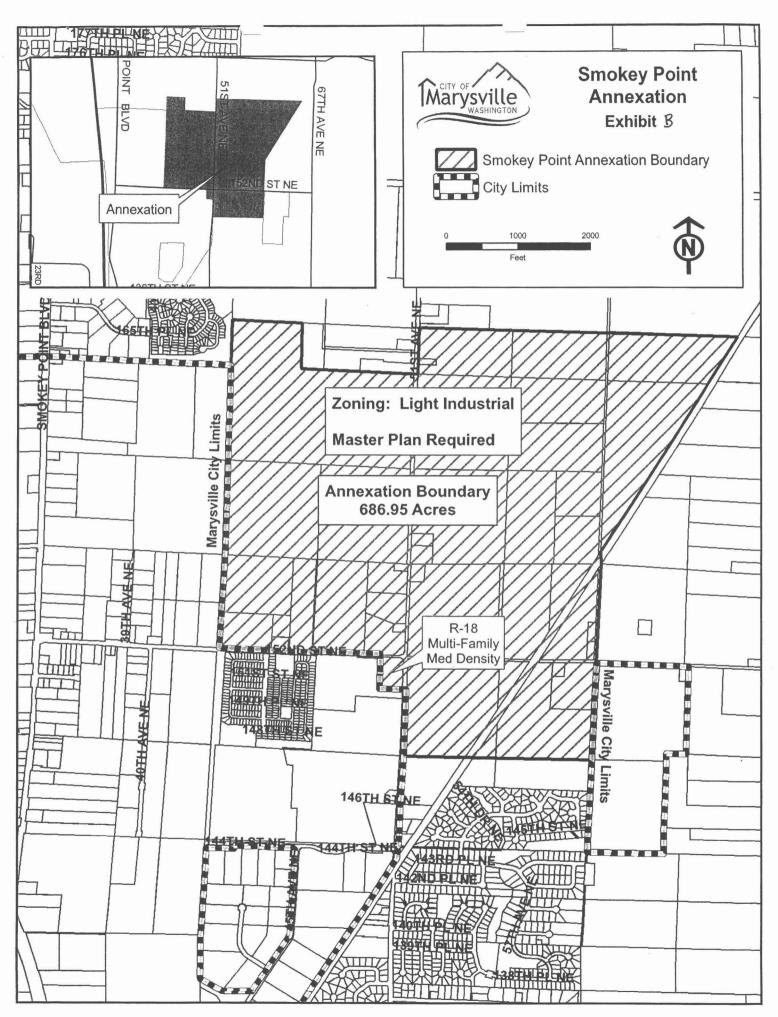

RESOLUTION NO.

A RESOLUTION OF THE CITY OF MARYVILLE GRANTING A UTILITY VARIANCE FOR TULALIP TRIBES OF WASHINGTON FOR PROPERTY LOCATED AT 6410 "A" and "B" 23RD AVENUE NE, MARYSVILLE, WASHINGTON AND AMENDING RESOLUTION NO. 1763.

WHEREAS, on November 13, 1995 the Marysville City Council adopted Resolution No. 1763 granting a utility variance for the Tulalip Tribes of Washington for a sewer connection without water for property associated with the construction of a cultural museum; and

WHEREAS, the Tulalip Tribes requested a revision to the previously granted utility variance to include two water and two sewer connections to provide utility service to a proposed museum and office building located at 6410 23rd Avenue NE; and

WHEREAS, on March 27, 2006 the Marysville City Council held a public meeting concerning the tribes' request and made the following findings:

- 1. The subject property is located outside the city limits, the utility service area boundary and urban growth boundary.
- 2. Without provision of city water there will be inadequate fire flow to the tribes' buildings. Sewer service is necessary and required to avoid environmental impacts to sensitive areas and to accommodate use of said structures by employees and members of the public. Under such circumstances provision of sanitary sewer and municipal water services are necessary to address public health and safety issues.
- 3. The Tulalip Tribes are a sovereign nation. As such the requirement of MMC 14.32.040(2) relating to annexation or execution of annexation covenant should not be required in this case due to the fact that many of the reasons for which annexation is generally required do not apply to the tribes. Jurisdictional and legal issues relating to the tribes that do not apply to non-tribal land justifying the variance from the annexation or annexation covenant requirement.
- 4. In light of the above-referenced findings the authorization of the variance will not be materially detrimental to the public interest, welfare or the environment.

RESOLUTION - 1 /W/mv/Res.Tulalip.Utilities.F

- 5. The above-referenced findings reflect exceptional or extraordinary circumstances or conditions applying to the subject property that do not apply generally to other properties in the same vicinity.
- 6. The variance is necessary for the preservation and enjoyment of a substantial property right of the applicant possessed by owners of other properties in the same vicinity.
- 7. The granting of a variance in this case will not be inconsistent with the long-range plans of the city utility system or jeopardize utility availability for properties within the city limits, so long as the utility connections are limited to the two buildings for which service has been applied for.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARYSVILLE, WASHINGTON AS FOLLOWS:

Resolution Number 1763 is hereby amended as follows:

1. The variance for the applicant's request for two water and two sewer connections is hereby approved subject to the following conditions:

- a. Except as otherwise stated herein, the sewer and water connections shall be subject to the provisions of Marysville Municipal Code, Chapters 14.01, 14.03, 14.05, 14.07, 14.08, 14.09, 14.10 and 14.20.
- b. This variance is approved subject to the condition that the sewer and water connections shall be strictly limited to the museum and office building located at 6410 "A" and "B" 23rd Avenue, N.E., and shall be strictly limited to the uses presently proposed for said buildings. Use of the sewer or water connections for any other purposes than the tribal museum and office building shall be grounds for termination of sewer service and disconnection from the city's utility system.
- c. The city and Tulalip Tribes agree to commence negotiations for the potential sale and/or transfer of the sewer and water utility infrastructure to the Tulalip Tribes in the general area west I-5 known as Marysville West. The exact boundaries and utilities to be transferred shall be determined through mutual discussions and cooperation between the parties. As a material condition of this Resolution the tribes shall provide the city with a letter stating its intention to enter into negotiations with the city for the purchase and/or transfer of the utilities in this area. In the event the parties are successful in reaching agreement for the purchase and sale of said utilities this Resolution shall be unnecessary and shall be repealed.
- 2. Dispute Resolution.

The parties desire to avoid and settle without litigation future disputes which may arise between them relative to this agreement. Accordingly, the parties agree to engage in good faith negotiations to resolve any such dispute.

RESOLUTION - 2 /W/mv/Res.Tulalip.Utilities.F In the event they are unable to resolve any such dispute by negotiation, then such dispute concerning any claim arising out of or relating to this agreement or the performance or interpretation thereof shall be submitted to arbitration in accordance with the arbitration rules of the American Arbitration Association (hereinafter "Rules") then in effect, and the award rendered by the arbitrator shall be binding as between the parties.

The written demand for arbitration shall contain a statement of the question to be arbitrated and the name of the independent arbitrator appointed by that party. The other party to this agreement shall, within ten (10) days of the receipt of the written demand, appoint an independent arbitrator and give notice in writing thereof to the party who commenced arbitration. A third independent arbitrator shall be appointed by requesting a list of five (5) arbitrators from the American Arbitration Association. The selection of the third independent arbitrator shall be made by each party to this agreement taking turns striking names from said list until one such name shall remain. A coin shall be tossed to determine which party strikes the first name. The arbitrator selected from the list, hereafter "independent arbitrator" shall select a time, date, and place for the hearing, and shall give each party not less than thirty (30) days notice in writing thereof.

The parties agree that after any such demand for arbitration has been made, they shall, before the hearing thereof, make discovery and disclosure of all matters relevant to such dispute, to the extent and in the manner provided by the Federal Rules of Civil Procedure. All questions that may arise with respect to the obligation of discovery and disclosure and the protection of the disclosed and discovered materials shall be referred to the independent arbitrator. A stenographic record shall be made of any arbitration hearing.

The parties shall share the cost of arbitration.

This agreement shall be construed, and the legal relations between the parties herein, shall be determined in accordance with the substantive law of the State of Washington. Any action to enforce the terms of this section or the award of the arbitrator shall be filed in Snohomish County Superior Court.

The substantially prevailing party in any arbitration action or action to compel arbitration or to enforce judgment or any appeal thereof shall be entitled to all costs and its reasonable attorney fees.

3. The Tulalip Tribes' board of directors shall authorize its chairman to sign this Resolution as its approval and consent to the conditions set forth herein. This Resolution shall become effective immediately following consent and approval by the City and Tulalip Tribes.
