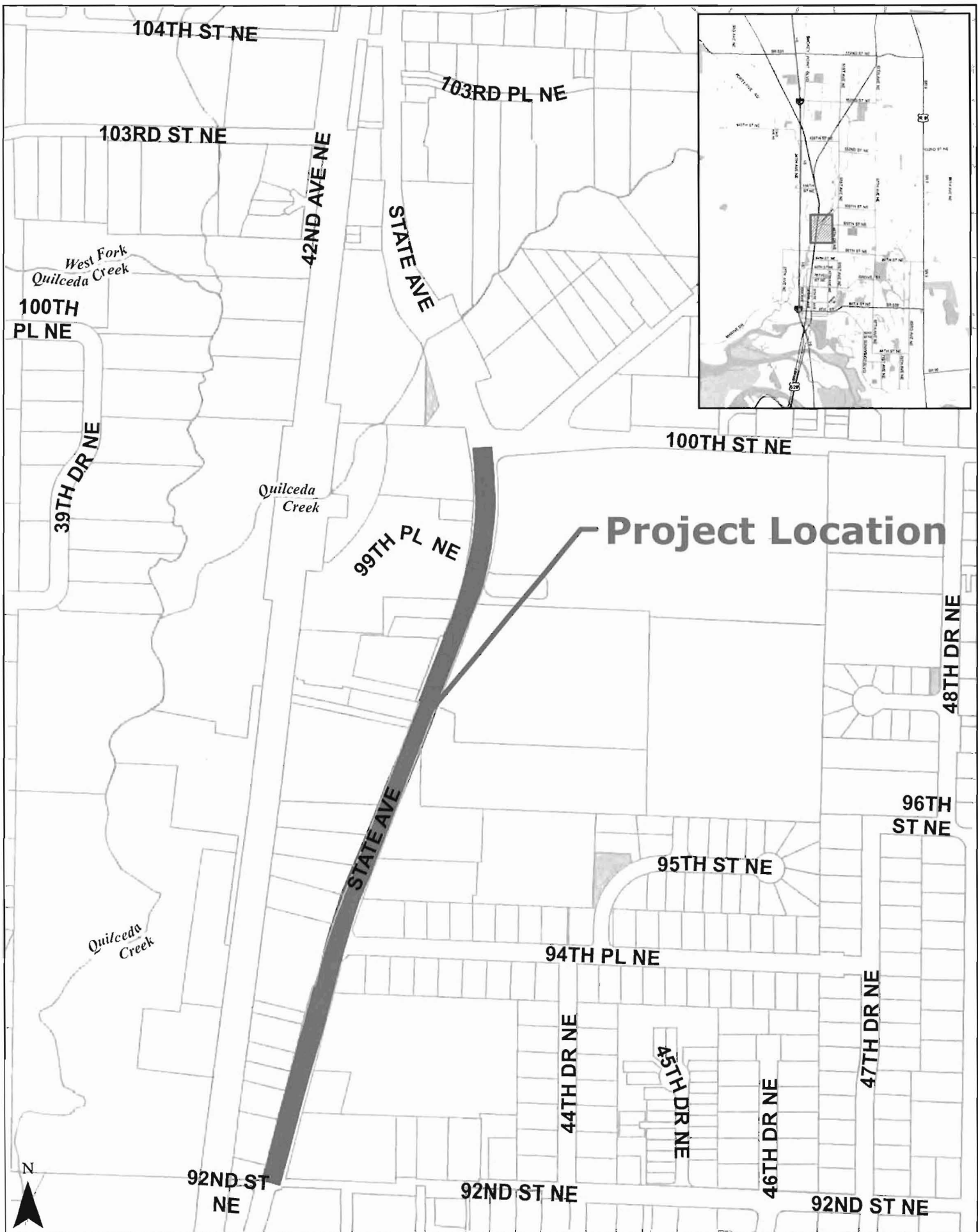
**SUMMARY:**

The City was awarded \$450,000 in federal funding for the State Ave Overlay project from 92<sup>nd</sup> St NE to 100<sup>th</sup> St NE, of which \$432,500 is for construction and the remaining \$17,500 is for staff time. The project includes replacing sidewalk ramps to meet ADA, a full width grind and 2-inch overlay, installation of vehicle video detection and loop replacement, and replacing pavement markings.

The project was advertised for a June 27, 2013 bid opening. The City received X bids as shown on the attached bid tabulation. The low bidder was X. at \$X. The engineer's estimate is \$500,000. References have been checked and found to be satisfactory.
