DESCRIPTION:

This Supplemental Agreement is for a cost increase and time extension for the Professional Services Agreement (PSA) with Macaulay & Associates, Ltd. for the 156th Street Local Improvement District. This contract will provide funds and time for additional services related to the LID hearings, potential appeals, and public comments.
