A correction of easement is necessary and required by the Snohomish Health District to construct and maintain a septic system at $6302152^{\text {nd }}$ ST NE, Marysville (more commonly known as the Strawberry Fields Caretaker's residence). The septic system is owned and maintained by the City of Marysville, has been constructed, and is currently in use. The Snohomish Health District will not issue a final permit for said septic system until a drain field easement is recorded.

## RECOMMENDED ACTION:

Staff recommends that the Council authorize the Mayor to sign the correction of easement for purposes of utilizing a City owned septic system.
