SUMMARY:						

The City has 43 servers that have been virtualized and placed on four fault tolerant Dell host servers and four fault tolerant HP SANs (disk storage). The advantages of virtualization are many including reduced overall cost, flexibility, speed of development, and disaster recovery. The City's current hosts and SANs are over six years old and no longer under service warranty. We have also outgrown our current hosts.

During the replacement search, we looked at both traditional host/SAN configurations and newer hyper-converged configurations. Hyper-converged may be a bit of a marketing term, but it does offer additional cost savings and reduced complexity while still maintaining all the advantages. We made the determination to proceed with a hyper-converged solution.

We compared the three primary hyper-converged vendors that have State contracts: Dell, HP, and Nutanix. One big advantage that Nutanix offers is an integrated host software solution called Acropolis. This provides additional savings by allowing us to delay and reduce the need for purchasing Microsoft server software.

Comparing the three quoted offerings, Nutanix offered a significant money savings even prior to factoring in the software savings. We then compared purchasing Nutanix through several different contract vehicles and Transource Services had the best pricing using the State's NASPO contract # MNWNC-130.

RECOMMENDED ACTION:

Staff recommends that Council authorize the Information Services department to purchase a Nutanix hyper-converged system through Transource Services Corporation using quote #278027.
